FlexNet Agent 5.7 retrieves and communicates data for Flexera’s usage-reporting web application: FlexNet Manager for Engineering Applications.

### Using with FlexNet Manager for Engineering Applications

FlexNet Agent 5.7 supports the administrative capabilities of FlexNet Manager for Engineering Applications to manage a FlexNet Publisher licensing environment. FlexNet Agent 5.7 supports both single-server configurations and triad configurations for serving licenses.
