Using with FlexNet Manager for Engineering Applications

FlexNet Agent 5.8 supports the administrative capabilities of FlexNet Manager for Engineering Applications to manage a FlexNet Publisher licensing environment. FlexNet Agent 5.8 supports both single-server configurations and triad configurations for serving licenses.
