Dashboard

The **Dashboard** is the initial interface to FlexNet Manager for Engineering Applications, enabling you to quickly view summary information about your vendor daemons and license servers, FlexNet Agents, most-active features, and alert messages.

Click the **Dashboard** tab to display the **Dashboard** page.



Tip • To configure the number of rows displayed in the status tables, use the Manager System Configuration page. Specify a number in the **Summary Table Size** box.

Vendor Daemon Status

The **Vendor Daemon Status** table shows the status of the vendor daemons in your environment—whether they are up (running), down (not running), or whether the status is unknown. The table also provides the name of the license server on which the vendor daemon resides.

- Click the name of a vendor daemon to configure or manage the vendor daemon.
- Click the name of a license server to configure or manage the license server.

Agent Status

The **Agent Status** table shows the current status of FlexNet Agents registered with FlexNet Manager for Engineering Applications— whether they are up (running), down (not running), or whether the status is unknown. The table also provides the name of the FlexNet Agent host.

Click the name of a FlexNet Agent to go to the Edit Agent page, where you can modify settings for the agent.

Alerts

The **Alerts** table displays current alert messages, including the date and time the alert was triggered. Alerts are categorized and color-coded according to severity.

- Error (red)
- Warning (yellow)

Information (blue)

To dismiss an alert from the Alerts table, click its **Dismiss** button. You can dismiss all alerts using the Alerts Summary page.

If the number of current alerts exceeds the number of rows in the Alerts table, click the **more** link to go to the Alerts Summary page, where you can view all of the current alerts.

Most Active Features

The **Most Active Features** table lists the 10 features with the highest usage percentage. To determine the usage percentage (% **Licenses in Use** column), the number of licenses currently in use is divided by the total number of licenses available for a particular feature.

This table contains the following information:

- Feature name—Name of the active feature. Click the feature name to view feature usage by license pool. This enables you to view more specific information about the feature's usage, including the feature version and license server name. You can also view a list of users who have used the feature.
- Vendor daemon—Name of the vendor daemon that serves the feature.
- Licenses in use—Number of licenses in use for that feature, along with the total number of licenses available.
 For example, if the Licenses in Use value is 75/100, it means that 75 licenses are in use out of a total of 100 available licenses.
- % licenses in use—Percentage of licenses in use for the feature. This is the number of licenses in use, divided by the total number of available licenses for the feature.

Click the **more** link under the list of feature names to see a summary of usage by feature.

Freeing Licenses

Sometimes, an application stops responding (or *hangs*) and consumes a license that you want to free for use by someone else in your enterprise. If you need to free a license so it can be used by another user (if the license server was configured to allow licenses to be freed), click the feature name for which you want to free licenses. For more information, see Freeing Licenses by User.

Functionality available from the **Servers** tab enables you to configure, manage, update, and view summary information about the FlexNet license servers, vendor daemons, and FlexNet Agents deployed in your environment. In addition, you can use the Not Recognizable License Servers page to view a list of license servers and vendor daemons that are no longer recognized by FlexNet Manager for Engineering Applications.

The following functionality is available from the **Servers** tab.

- License Managers—Configure and manage FlexNet license servers, viewing license server status, and view debug logs for license servers and FlexNet Agents.
- Vendor Daemons—Configure and manage vendor daemons, view vendor daemon status, add and edit options
 files, and rotate report logs.
- Agents—View the status of deployed FlexNet Agents, add and manage FlexNet Agents, and view FlexNet Agent logs.
- Third-Party License Servers and Third-Party Licensing Templates—Create templates for third-party (non-FlexNet and non-LUM) license servers, add and manage third-party license servers, and view status for thirdparty license servers.
 - If you have enabled the display of IBM LUM license-server data, you can access the LUM Server page from this section.
- **Not Recognizable**—View lists of FlexNet license servers and vendor daemons that are no longer recognized by FlexNet Manager for Engineering Applications.

Working with FlexNet License Server Managers

The **License Manager Summary** page displays a list of the FlexNet license servers in your environment that are managed by FlexNet Manager for Engineering Applications.

Available from the **Servers** tab (under the **License Managers** section), this page provides the following information:

• **License Server**—Display name of each license server. If the license server is a triad configuration (three license servers configured to accommodate failover), a triad icon is displayed to the right of the license server name.



Click the license server name to go to the **Configure and Manage License Server** page, where you can manage the license server manager or configure the license server manager settings.

- Port@Host—Port and host setting for each license server manager. If the license server is a triad, this column
 lists the port and host settings for all three servers.
- **License Manager Status**—Status of each license server manager. Click the **Update Status** button to immediately refresh the status display for the license server.
 - Up—License server is currently running.
 - Down—License server is currently not running.
 - Unknown—License server status is not known.
 - Lost quorum—For license-server triads, this means that the quorum has been lost. A *quorum* requires that at least two of the three license servers are running and communicating with each other.
- Vendor Daemon Status—Status of the vendor daemons in each license server—whether the vendor daemons
 are up (running) or down (not running), or the status is unknown.
- Last Update—Time and date of the last license server manager status update. Click the Update Status button
 to immediately update the status for the license server manager.
- Update Status button—Click this button to immediately update the license server's status and the information displayed on this page.

You can sort the table by license server name and by license manager status.

Configuring and Managing License Servers

You can configure and manage your individual license servers using the **Configure and Manage License Server** page. This page contains two sections—License Server Status and License Manager Configuration. You can also schedule license-server updates from this page.

License Server Status

The **License Server Status** section displays information about the license server, and provides links to view debug logs and FlexNet Agent logs. For triad license-server configurations, this section provides information about all three license servers in the triad.

In this section, you can do the following:

- · View the status of the license server manager (Imadmin or Imgrd), vendor daemons, and FlexNet Agent.
- View the version of the FlexNet Agent and the FlexNet Publisher version and location of the license server manager.
- Click a vendor daemon name to configure and manage the vendor daemon.
- Click the **View Debug Log** link to view the debug log for the license server manager.
- Click the View Agent Log link to view the FlexNet Agent log file.
- Click the License Server Scheduling link to enable and schedule automatic status updates and license file rereads.

Any FlexNet Manager for Engineering Applications user can view license server status and settings. However, to manage and configure a license server, a user must be assigned a role with the "Manage License Servers" permission.



Task To manage the license server:

- From the Servers tab, under the License Managers section, click License Manager Summary to display the License Manager Summary page.
- Click the display name of the license server you want to configure or manage to display the Configure and Manage License Server page.
 - To start the license server manager, click the **Start** button.

License Manager Configuration

The License Manager Configuration section shows the configured settings of the license server and its running settings. When the license server manager is restarted, the values specified in the **Configured Value** side become the running values for the license server, and are displayed in the **Running Value** side.

You can change the default schedule for status updates and for license-file rereads.

You can also update license-server status manually.



Task To change the default settings for a license server:

This link is displayed only for users assigned a role with the Manage License Servers permission.

- 2. To disable automatic status updates, clear its **Enable** check box.

Removing License Servers from FlexNet Manager for Engineering Applications Management

If you no longer want to use FlexNet Manager for Engineering Applications to manage a particular license server, you can remove that license server from management using the FlexNet Manager for Engineering Applications interface. Removing a license server from FlexNet Manager for Engineering Applications management does not delete the license server; it removes configuration information about the license server from the FlexNet Manager for Engineering Applications database and from the license server's FlexNet Agent.



Task To remove a license server from FlexNet Manager for Engineering Applications management:

- From the Servers tab, under License Managers, click License Manager Summary to display the License Manager Summary page.
- 2. In the **License Server** column, click the name of the license server that you want to remove from FlexNet Manager for Engineering Applications management. This opens the **Configure and Manage License Server** page for the license server.

6. Click **Save** to save any configuration changes.

Options Files: Passing Instructions to Vendor Daemons

You can pass instructions to a vendor daemon using an options file. The options file is where you specify the path to a report log file. To enable reporting for a vendor daemon, you must include the keyword REPORTLOG in the vendor daemon's options file, and specify the path to the report log file. See Enabling Report Logging for more information.

You can add a new options file, and you can edit an existing options file within FlexNet Manager for Engineering Applications using a text editor–style interface. (You can also import an options file at the command line.) FlexNet Manager for Engineering Applications automatically notes the newly configured options file during a reread of the vendor daemon's license files, or when the license server or vendor daemon is restarted.

The options file location must be either of the following:

- Specified on the VENDOR line of the license file that contains the vendor daemon's feature lines.
- In the same directory as the vendor daemon's license file with a file name that matches the vendor daemon
 name with an .opt extension (for example for a vendor daemon named mycompany, the options file must be
 named mycompany.opt).

To work with an options file within FlexNet Manager for Engineering Applications, a user must be assigned a role with the Manage Options for Vendor Daemons permission.

Common Vendor Daemon Mapping

FlexNet Publisher provides a *common vendor daemon* option to software publishers who want to deploy a single vendor daemon that serves features previously served by other vendor daemons. This scenario typically applies to software publishers who have acquired or merged with other companies, where the individual companies have previously sold FlexEnabled applications with their own vendor daemons.

For example, *ABCware* merges with *DEFware*, and begins to deploy the new vendor daemon *abcdef*. When the *abcdef* vendor daemon registers with FlexNet Manager for Engineering Applications, it receives usage information only about features served by the *abcdef* vendor daemon. Data received about features served by previously deployed *abcware* and *defware* vendor daemons is disregarded. To ensure that FlexNet Manager for Engineering Applications receives all relevant data for the merged publisher's features, you must map the secondary vendor daemon names (*abcware* and *defware*) to the primary vendor daemon name (*abcdef*).

Use of a common vendor daemon enables the publisher to use one vendor daemon to serve features with different vendor names. A common vendor daemon configuration contains:

- One primary vendor daemon—This is the vendor daemon for the acquiring company.
- One or more secondary vendor daemons—These are the vendor daemons that were deployed prior to the merger or acquisition.



Task To configure common vendor daemon mapping:

- 1. Stop the Admin server if it is running.
- 2. Open a Command Prompt window and change to the following directory—

<fnmea admin install dir>/release/manager/webapps/flexnet/WEB-INF/classes

- 3. Open the file secondaryVendors.properties. (This is an empty file.)
- 4. Add the common vendor daemon mappings to the .properties file in the following manner:

secondaryVendorName1=primaryVendorName secondaryVendorName2=primaryVendorName

In the case of the previous example, the .properties file would contain the following:

abcware=abcdef defware=abcdef

5. At the command prompt, change to the *<fnmea_admin_install_dir>* directory, then type the following command:

flexnet site make

6. Restart the Admin server.

LUM License Servers

FlexNet Manager for Engineering Applications provides support for integrating data from IBM's Licensing Use Management (LUM) tool, which is used to monitor and track license usage. This enables your enterprise to use FlexNet Manager for Engineering Applications to view LUM concurrent usage activity and to run reports based on LUM data. (The LUM data includes license checkins and checkouts, and the total number of available licenses.)

Refer to the *FlexNet Manager for Engineering Applications 2018 R1 Reporting Guide* for information on configuring FlexNet Manager for Engineering Applications for use with LUM.

The LUM Servers page lists the LUM servers in your environment from which FlexNet Manager for Engineering Applications is capable of extracting LUM report logs. Each LUM server entry is distinct and corresponds to a specific vendor hosted on a LUM server machine. Using this page, you can add, edit, and remove LUM servers, as well as schedule report log rotation and server updates.



Task

To view LUM servers that have been added to FlexNet Manager for Engineering Applications:

From the **Servers** tab, under the **Third-Party License Servers** section, click **LUM Servers** to display the **LUM Servers** page.

Multiple Vendors Within a LUM Server

If you have multiple vendors that run within a LUM server and your enterprise wants to obtain report logs from each of them, you must define each of these vendors in FlexNet Manager for Engineering Applications as a separate LUM server entry. Multiple LUM server entries may map to the same LUM server machine, but each of these entries must specify a different vendor.

Adding LUM License Servers

Note the following about time zone information and number formats: Some LUM server usage, license, and report log data (i4blt output) may have numbers with different number formats and the date/time strings that use different time zones. If you have LUM data containing time zone information and number formats that differ from the default settings (see the descriptions for the Time Zone, Number - Decimal Separator, and Number - Thousand Separator settings), and you want to bulk-import LUM report logs or import LUM report logs using the FlexNet Manager for Engineering Applications user interface, you must add (or edit) the LUM servers using the LUM Servers pages.

On the New LUM Server or Edit LUM Server page, you can specify the appropriate number formats and time zone for the LUM data. This enables FlexNet Manager for Engineering Applications to process the data correctly.



Task To add a LUM license server to FlexNet Manager for Engineering Applications:

- From the Servers tab, under the Third-Party License Servers section, click LUM Servers.
- 2. Click New LUM Server to display the New LUM Server dialog.
- **3.** In the **LUM Server** section, provide the required information (indicated by red asterisks) and any optional settings

Note that you can change the status-update schedule later, and you can refresh a LUM server's status at any time by clicking the **Refresh** link for the LUM server.

Not Recognizable License Servers and Vendor Daemons

Licenses

From the **Licenses** tab, you can view deployed licenses by type (concurrent or activatable, or by license rights representation), fulfillment records in trusted storage, or license files. Using pages under this tab, you can also add licenses, and delete inactive licenses.

You can do the following, using the pages available from the **Licenses** tab:

- View concurrent licenses
- View activatable licenses
- View detachable licenses
- View licenses in license files
- View license certificates
- View fulfillment records
- Add license certificates
- Delete inactive licenses

Viewing Concurrent Licenses

The **Licenses** tab enables you to view deployed licenses by type—concurrent or activatable, or by license rights representation—fulfillment records in trusted storage or license files. You can also add licenses, and delete inactive licenses.

Concurrent licenses are listed by feature. The following information is displayed for each feature:

- Name of the vendor daemon serving the feature
- Feature name
- Feature version
- Total Count: The total number of active licenses available for the feature.

- Concurrent: The number of concurrent licenses available for the feature
- Overdraft: The number of overdraft licenses available for the feature
- A link to access server information



Note • The count of licenses reflects what is in the license file, but may not accurately reflect the total number that is available. FlexNet Manager for Engineering Applications sums all FEATURE lines. If a license file's FEATURE line uses the SUPERSEDE keyword, the total count may be inaccurate. To see the total count from the perspective of the license server, refer to the license-activity pages, available under the Activity tab.

The list of concurrent licenses can be sorted by feature name, feature version, and vendor daemon name.



Task To view concurrent licenses managed by FlexNet Manager for Engineering Applications, including detachable licenses:

- From the Licenses tab, under Concurrent Licenses, click All Concurrent Licenses to open the Concurrent Licenses page. (To view only detachable licenses, click Detachable Licenses Only.)
- 2. Click the **Servers** link for the feature of interest to display the **Concurrent Licenses License Servers** page. This page displays the feature by a list of the license servers that serve it. The license server list can be sorted alphabetically.

For each license server, the following information is displayed:

- Display name of the license server
- Type of license line for the feature (for example: FEATURE, INCREMENT)
- License expiration date, or permanent, if the license never expires
- Total number of licenses for the feature on a given license server
- Number of concurrent licenses for the feature on a given license server
- Number of overdraft licenses available for the feature on a given license server
- 3. To view detailed license certificate information, click the Detail link for a feature on a license server.

Viewing Detachable Licenses Only

Viewing Detachable Licenses Only

Pages beneath the **Licenses** tab enable you to view deployed licenses by type—concurrent or activatable. From within concurrent licenses, you can view detachable licenses on the **Concurrent Licenses (Detachable Licenses Only)** page.

On this page, detachable licenses are listed by product. The following information is provided for each product:

- Vendor daemon name
- Product name

- Product version
- Total number of licenses available for the product
- Number of detachable licenses available for the product
- Number of overdraft licenses available for the product
- A link to access server information

You can sort the list of detachable licenses by product name, product version, or vendor daemon name.



Task To view detachable licenses managed by FlexNet Manager for Engineering Applications:

- 1. From the Licenses tab, under Concurrent Licenses, click Detachable Licenses Only to display the Concurrent Licenses (Detachable Licenses Only) page.
- 2. Click the **Servers** link for a product to display its **Detachable Licenses License Servers** page, which displays the product by a list of license servers that serve licenses for it. The list can be sorted alphabetically.

For each license server, the following information is displayed:

- Display name of the license server
- Fulfillment record ID for the given product
- License expiration date
- Total number of licenses for the product on a given license server
- Number of detachable licenses for the product on a given license server
- Number of overdraft licenses available for the product on a given license server
- **3.** To view detailed fulfillment record information, click the **Detail** link for a product on a license server. This displays the **Fulfillment Record Details for Detachable** page, which provides the following information:
 - Product name and version
 - Suite ID, if any
 - Fulfillment record ID
 - Entitlement ID
 - Vendor daemon name
 - License server display name
 - Expiry of the license
 - A link to view the entire fulfillment record
 - Detachable and overdraft license count

This page also contains links to other parts of the FlexNet Manager for Engineering Applications interface:

- Click the vendor daemon name to open the Configure and Manage Vendor Daemon page.
- Click the fulfillment record ID to view all the license lines in the fulfillment record.

Viewing Concurrent Licenses

Viewing Activatable Licenses

Pages beneath the Licenses tab enable you to see deployed licenses by type—concurrent or activatable, or by license rights representation—fulfillment records in trusted storage or license files. You can also add licenses, and delete inactive licenses.

Activatable licenses are listed by product in the **Activatable Licenses** page. The following information is provided for each product:

- Name of the vendor daemon serving the product
- Product name
- Product version
- Total number of licenses available for the product
- Number of activatable licenses available for the product
- Number of overdraft licenses available for the product
- A link to access server information



Task To see activatable licenses managed by FlexNet Manager for Engineering Applications:

- From the Licenses tab, under Activatable, click Activatable Licenses to open the Activatable Licenses page.
 You can sort the list of activatable licenses by product name, product version, or vendor daemon name.
- 2. Click the **Servers** link for a product to display its **Activatable Licenses License Servers** page. This page displays the product by a list of license servers that serve it. The server list can be sorted alphabetically.

For each server, the following information is displayed:

- Display name of the license server
- Fulfillment record ID for the given product
- License expiration date
- Total number of licenses for the product on a given server
- Number of activatable licenses for the product on a given server
- Number of overdraft licenses available for the product on a given server
- 3. To view detailed fulfillment record information, click the **Detail** link for a product on a license server. This displays the **Fulfillment Record Details for Activatable** page, which contains the following information:
 - Product name and version
 - Suite ID, if any
 - Fulfillment record ID

- Entitlement ID
- Vendor daemon name
- License server display name
- Expiry of the license
- Number of activatable and overdraft licenses for the product in the fulfillment record
- A link to view the entire fulfillment record

The **Fulfillment Record Details for Activatable** page contains links to other parts of the FlexNet Manager for Engineering Applications interface.

- Click the vendor daemon name to open the Configure and Manage Vendor Daemon page.
- Click the fulfillment record ID to open the Fulfillment Record Details page, on which you can view all the license lines in the given fulfillment record.

Viewing Licenses in Fulfillment Records

Licenses that are represented as fulfillment records are listed by product on the **Fulfillment Records** page. Each line item on this page provides the following information:

- Product name and version for each fulfillment record
- · Vendor daemon name for each fulfillment record
- Display name of the license server where trusted storage resides
- Fulfillment record ID
- Expiration date pertaining to fulfillment record
- A link to view fulfillment record details

The list of fulfillment records can be sorted by product name and version, vendor daemon name, server name, fulfillment record ID, or expiration date.



Task To see licenses managed by FlexNet Manager for Engineering Applications that are represented as fulfillment records in trusted storage:

- 1. From the Licenses tab, under Fulfillment Records, click Fulfillment Records.
- **2.** Click the **Details** link for the fulfillment record of interest to open the **Fulfillment Record Details** page. This page displays the following information for a fulfillment record:
 - Fulfillment record ID
 - Corresponding entitlement ID
 - Product name and version

- Suite ID, if any
- Vendor daemon name
- Display name of the license server on which trusted storage resides
- Expiration date of the license
- Original expiration date (in case of a transfer, the date on the original fulfillment record)
- Number of allowed hops (number of times a fulfillment is allowed to be transferred)
- Number of allowed repairs
- The count in the fulfillment record is listed by license type—activatable, concurrent, or detachable—and any allowable overdrafts.
- License traversal—shows the transfer history of the fulfillment record, including activation server and fulfillment ID on that server.
- The complete text of the license lines contained in the fulfillment record is provided.

Viewing Licenses in License Files

The **License File Summary** page displays a list of the licenses managed by FlexNet Manager for Engineering Applications. The following information is displayed for each license file:

- Display names of the license servers on which license files reside. If the triad symbol 4 appears to the right of the license-server name, it indicates that this is a triad (three-server) configuration.
- Path of the license file location
- Number of VENDOR lines in each license file
- Number of features in each license file
- A link to view certificates in a given license file
- A link to edit the license file

You can sort the data in this page by the **License Server** column.



Note • License files are grouped together for triad license servers. If the license file names are not consistent on all three servers in a triad configuration, FlexNet Manager for Engineering Applications cannot list the license certificates and the license file is not editable. Therefore, no **Edit** link is displayed in this case.



Task To see licenses managed by FlexNet Manager for Engineering Applications that are represented in license files:

- 1. From the Licenses tab, under License Files, click License File Summary.
- 2. Click the **Certificates** link for a license file to view information about the licenses contained in the file. This displays the **Licenses for License File** page, which provides the following information:
 - Feature name in license
 - Feature version in license
 - Type of license line (for example, FEATURE, INCREMENT)
 - Status of the license (expired, superseded, or active)
 - Expiration date of the license, or permanent, if the license does not expire
 - Number of concurrent licenses for this feature
 - Number of overdraft licenses available for this feature
- **3.** After clicking the **Certificates** link, you can click the **Detail** link for the license to display the **Certificate Details** page, where you can view the text of the license line.

Click the **Edit** link to display the **Edit Licenses** page, which enables you to add, edit, import, back up, and restore license certificates.

Viewing License Certificate Details

The **Certificate Details** page presents one license certificate at a time. The information presented in this view varies depending on whether the license certificate is in a license file, or is derived from a fulfillment record in trusted storage. The following table shows these differences.

Adding and Editing License Certificates and License Files

Users assigned a role with the Manage Licenses permission can add a license certificate to an existing license file and edit existing license files.

Adding License Certificates

You can add a license certificate in FlexNet Manager for Engineering Applications using the Edit Licenses page.



Task To add a license certificate:

- 1. From the Licenses tab, under License Files, click License File Summary.
- 2. Click the **Edit** link (in the right-most column) for the license file to which you want to add a certificate.

- 3. In the **Edit Licenses** page, you can add license information either of the following ways:
 - Paste one or more license certificates into the text box.
 - Click the **Browse** button to navigate to a license file on your system, then click **Import** to import the license file. When you click **Import**, the license file contents are displayed in the text area.
- 4. Click Save. The license certificate is added to an existing license file on that license server.
- Click Save and Reread Vendor Daemon so that the license server can start serving licenses from the certificate you just added.

If you manually edit a license certificate, the changes take effect the next time the license file is reread or the license server restarted.

Adding License Files

You can add a new license file to a license server in any of the following ways:

- Placing the new file on your license server machine.
- If the license file is not copied into an already-specified license directory, using the **FlexNet Agent Configurator** to add licenses managed by the FlexNet Agent.



Note • After changes are made using the **FlexNet Agent Configurator**, the FlexNet Agent must be restarted for the changes to take effect in FlexNet Manager for Engineering Applications.

• Rereading license files or restarting the license server.

Editing License Files

You can edit a license file directly in FlexNet Manager for Engineering Applications using the **Edit Licenses** page. As you receive updated license file certificates, you can copy and paste the updated certificates into the license file.

This functionality is especially useful in environments using a triad license server configuration. This view enables you to update a license file simultaneously on all license servers, instead of having to go to each server individually. For triads, the license file of the master server is displayed in the **Edit Licenses** page.



Task To edit a license file in FlexNet Manager for Engineering Applications:

- 1. From the Licenses tab, under License Files, click License File Summary.
- 2. Click the **Edit** link (in the right-most column) for the license file you want to edit.
- 3. In the text field, make your changes, then save the changes. You can also import a license file from a software publisher by browsing to a file on your network and then clicking **Import**. You must reread the license file in order for the changes to take effect.
- **4.** Click **Save**. FlexNet Manager for Engineering Applications validates and updates the license file in the license server directory, regardless of whether the license server is running.



Note • For triads, all three license files are updated.

The related features will be updated on pages beneath the **Licenses** tab only after the license server has been reread and the update is complete. The related features will be updated on pages beneath the **Activity** tab only after the reread is done.

License File Validation

When validating the license file, FlexNet Manager for Engineering Applications checks the following:

- Confirms that the license text field is not empty
- Port number (You cannot change the port number using the Edit Licenses page.)
- Syntax checking for all invalid keywords
- Invalid date format
- Incomplete feature line

If FlexNet Manager for Engineering Applications encounters an error during validation, it displays an error message with the line number where the error was encountered, a descriptive message, and the feature line.

Backing Up the License File

The actual license file on the file system is backed up and stored internally when you click the **Back up** button, regardless of whether the license server is running. This action does not back up the updated license content in the text box.



Note • Only one backup copy is stored for each license file. (There is no multiple backup.)

Restoring the Backup License

When you click the **Restore** button, the backup copy of the license is displayed in the text box. The license file will be updated only if you click the **Save** or **Save and Reread Vendor Daemon** button. The current content in text box will be replaced with the backup copy.

Error Messages

When you save the edited license, FlexNet Manager for Engineering Applications validates the license. If the license is invalid, an error message is triggered, describing the error. For example, you cannot edit the port number on the SERVER line.

Viewing and Deleting Inactive Licenses

Pages under the **Inactive Licenses** heading of the **Licenses** navigation tab display lists of licenses that are not currently active. You can view inactive licenses by type: Concurrent, Detachable only, and Activatable.

Information displayed about inactive licenses varies by license type. The following table shows these differences.

Users assigned a role with the Manage Licenses permission can delete inactive licenses.



Task To delete inactive licenses:

- 1. From the Licenses tab, under Inactive Licenses, click Concurrent Licenses to display the Inactive Concurrent Licenses page.
- 2. Select the check box for the licenses that you want to delete, and click **Delete Selected Certificates**.

Usage Activity

Pages available from the **Activity** tab enable you to view summaries of usage primarily by license type, and to free licenses to be used by another user. You can view concurrent license activity by feature or by user; and detachable and activatable license activity by product or by host.

You can do the following, using the pages available from the **Licenses** tab:

- View a summary of concurrent license activity by feature
- View concurrent feature activity by license pool
- View concurrent activity in license pools by user
- Free licenses by feature
- View a summary of concurrent license activity by user
- Free licenses by user
- View concurrent feature activity for a single user
- View activatable license activity by product
- View activations for a product by fulfillment record
- View activation details for a fulfillment record
- View activations for a product by host
- View activatable license activity by host
- View detachable license activity by product
- View detachments for a product by fulfillment record
- View detachment details for a fulfillment record
- View detachments for a product by host
- View detachable license activity by host

Viewing Concurrent License Activity by Feature

Concurrent license activity is grouped by feature. In the **Concurrent by Feature - Summary** page, activity for each feature is listed by:

- Vendor daemon
- Feature name
- Total number of concurrent licenses available for each feature
- Number of concurrent licenses currently in use
- Percentage of the total licenses in use (Licenses in Use/Total Count)



Task To view concurrent license activity by feature:

- From the Activity tab, under Concurrent, click Concurrent by Feature to display the Concurrent by Feature -Summary page.
- 2. Click the **Pools** link for a feature to view the feature's activity by license pool.
- 3. Click the **Users** link for a feature to view the feature's activity by user.

On the **Concurrent Usage by Feature - Pools** page, the following information is displayed for each pool for the given feature:

- Feature version
- Display name of the license server on which the pool resides
- Total number of concurrent licenses for the given feature in the pool
- Number of concurrent licenses in use for that feature in the pool
- Percentage of licenses in use for that feature in the pool



Task To view concurrent license activity by license pool:

- From the Activity tab, under Concurrent, click Concurrent by Feature to display the Concurrent by Feature -Summary page.
- 2. Click the Pools link for a feature. This takes you to the Concurrent Usage by Feature Pools page.
- 3. Click the Users link for a license pool to see the users of licenses in the pool.

Viewing Concurrent Activity in a License Pool by User

The **Concurrent by Feature - Pools - Users** page provides information about the feature and a list of the users of the license pool.

The feature information includes the feature name and version, display name of the license server on which the pool resides, and the vendor daemon serving the licenses.

The following information is displayed for each license checkout:

- User—User name of the user who checked out the license.
- Host Name—Host where the license is being used—where the user is logged in.
- **Display Name**—Name of the display where the license is being used.
- Handle—License handle that uniquely identifies a checkout.
- Time of Checkout—Date and time that the license for this feature was checked out.
- Licenses in Use—Number of licenses in use for this checkout.
- Duration—Time period for which the feature has been checked out.

You can free a license using this page. If multiple licenses are checked out to the same user and host at the same time, you can use the handle value to differentiate between them when freeing a license.



Task To view users of concurrent licenses in a given license pool:

- From the Activity tab, under Concurrent, click Concurrent by Feature to display the Concurrent by Feature -Summary page.
- 2. Click the Pools link for a feature to display the Concurrent Usage by Feature Pools page.
- 3. Click the Users link for a license pool.

Viewing Concurrent Feature Usage by User

The Concurrent Usage by Feature - Users page displays the following information for each user:

- User name
- Feature name and version
- Host name and display name
- Time and duration of checkout

You can free a license using this page.



Task To view concurrent feature usage by user:

- From the Activity tab, under Concurrent, click Concurrent by Feature to display the Concurrent by Feature -Summary page.
- Click the Users link for a feature to view the feature's activity by user. This takes you to the Concurrent Usage by Feature - Users page.

Freeing Licenses by Feature

Sometimes, an application stops responding (or *hangs*) and consumes a license that you would like to free so it can be used by another user. Note that if the application is active, it re-checks out the license shortly after it is freed.

Users assigned a role with the **Manage Licenses in Use** permission can free a license, if its license server was configured to allow licenses to be freed before the license server was started.



Task To locate a license by its feature name and free the license:

- From the Activity tab, under Concurrent, click Concurrent by Feature to display the Concurrent by Feature -Summary page.
- 2. Click the Users link for the feature to display the Concurrent Usage by Feature Users page.
- 3. Select the check box next to the feature whose license you want to free.
- Click Free Selected Licenses.

If the **Free Selected Licenses** button is disabled, it means the license server has not been configured to allow licenses to be freed (that is, it has been started with the -x 1mremove option) and/or that the user is not assigned a role with the **Manage Licenses in Use** permission.



Note • Licenses that have been detached or activated cannot be freed.

Freeing Licenses by User

Sometimes, an application stops responding (or *hangs*) and consumes a license that you would like to free for use by someone else in your organization. Free a license using the **Free Selected Licenses** button. If the application is active, it re-checks out the license shortly after it is freed.

Users assigned a role with the **Manage Licenses in Use** permission can free a license, if the license server was configured to allow licenses to be freed (that is, it was started with the -x 1mremove option). The **Free Selected Licenses** button is disabled if the user does not have the correct permission or if the license server was not configured to allow licenses to be freed.



Note • Licenses that have been detached or activated cannot be freed.



Task To locate a license by user and free the license:

- From the Activity tab, under Concurrent, click Concurrent by User to display the Concurrent Usage by User
 Summary page.
- 2. For the user whose license usage you want to view, click the **Licenses** link. This displays the **Concurrent Usage for Single User** page, where you can view the feature checkouts for the user.
- 3. Select the check box next to the features whose licenses you want to free.
- 4. Click Free Selected Licenses.

If the **Free Selected Licenses** button is disabled, it means that the license server has not been configured to allow licenses to be freed (that is, it has been started with the -x 1mremove option) or that the FlexNet Manager for Engineering Applications user is not assigned a role with the **Manage Licenses in Use** permission.

Activatable license activity is displayed in units of products. In the **Activated by Product - Summary** page, activity for each product is listed by:

- Product name
- Vendor daemon
- Total number of activatable licenses for each product
- Number of licenses that have been activated (broken up by permanent and timebound activations)
- · Percentage of licenses that have been activated



Task To view activatable license activity by product:

- From the Activity tab, under Activated, click Activated by Product to display the Activated by Product -Summary page.
- 2. Click the Fulfillments link for a product to view the product's activations per fulfillment record.
- 3. Click the Hosts link for a product to view all activation records for the product sorted by host.

You can view activatable license activity for a product by fulfillment record using the **Activated by Product** - **Fulfillment Records** page. The following information is displayed for each fulfillment record for the given product:

- Number of licenses that have been activated (broken up by permanent and timebound activations)
- · Percentage of licenses that have been activated
- A link to view activation details

LUM Concurrent Usage Activity

FlexNet Manager for Engineering Applications provides support for integrating data from IBM's Licensing Use Management (LUM) tool, which is used to monitor and track license usage. This enables your enterprise to use FlexNet Manager for Engineering Applications to view LUM concurrent usage activity and to run reports based on LUM data. (Refer to the *FlexNet Manager for Engineering Applications 2018 R1 Reporting Guide* for information on configuring FlexNet Manager for Engineering Applications for use with LUM.)

To view concurrent usage activity for LUM licenses, you must add LUM license servers to FlexNet Manager for Engineering Applications using the **LUM Servers** page.

The **LUM Concurrent Usage** page enables you to see how LUM-enabled licenses are being used in your enterprise. FlexNet Manager for Engineering Applications makes an i4blt request to the LUM license servers and brings back the product license status, which includes the total count of licenses, the number of licenses that are in use, and the users who are using the licenses. The **LUM Concurrent Usage** page displays all of this data, along with the vendor, product name and version, and percentage of licenses used.

This information is refreshed according to the interval specified for the LUM Server Status Update setting.

Click the **Users** link to drill down to the **LUM Concurrent Usage - Users** page, which displays a list of the users who are using the licenses.

Reporting on License Usage

The functionality available from the **Reporting** tab enables you to understand how licensed applications are used in your enterprise. Using FlexNet Manager for Engineering Applications reporting, you can generate a variety of license usage reports, which can assist you in making decisions about your organization's software assets and licensing requirements.

Using FlexNet Manager for Engineering Applications's investment planning functionality, you can also generate reports that show usage by product, rather than only by licensed feature.



Note • The Flexera Analytics and Organizational Structures sections are available under the Reporting tab only if Flexera Analytics (Cognos) has been configured.

- Classic reports are FlexNet Manager for Engineering Applications historical reports—typically run overnight that provide aggregated historical data, based on the data collected from report logs.
- Flexera Analytics reports are generated using Flexera Analytics reporting function. These reports can provide more immediate data because the reports can be generated more quickly.
- FlexNet Manager for Engineering Applications supports usage reporting based on organizational structure. Organizational structures enable grouping and sub-grouping of users, vendors, and hosts in a hierarchical order.
- If your organization uses applications from Autodesk, which implement tier-based licensing, see the Tiers section for information about enabling this functionality in FlexNet Manager for Engineering Applications.
- Report log files contain feature usage information and are generated by vendor daemons. However, a vendor daemon does not write report logs by default; this action must be enabled. The data in report logs is compressed and authenticated, and is used only by FlexNet Manager for Engineering Applications reporting.
- FlexNet Manager for Engineering Applications provides enterprises with the ability to import and report on usage from third-party report logs. Using the Report Log Definitions page, you can create definitions for non-FlexNet report logs to facilitate import into FlexNet Manager for Engineering Applications.
- Functionality available from the Usage Data Maintenance section enables you to delete usage data that is older than the specified number of months.

Classic Reporting

Classic reports are FlexNet Manager for Engineering Applications traditional reports, which are typically run overnight to provide aggregated historical data, based on data collected from report logs. Classic reports do not display real-time data.

FlexNet Manager for Engineering Applications generates reports based on FlexNet license usage activity from usage report logs on a per–vendor daemon basis. See Report Logs for more information.

The basic steps to generate a Classic report include:

- 1. Enable FlexNet Licensing report logging. See Enabling Report Logging.
- 2. Choose the report type. See Classic Reporting.
- 3. Create a report configuration or use a previously created configuration.
- 4. Generate the report to view the results.

Classic Reporting

For all Classic reports, the only required field is a configuration name. Each report type has between two and six configuration pages that enable you to specify parameters for the report.

High Water Mark Report

A **High Water Mark** report creates a line graph that shows the maximum number of licenses used during a specific time period. This report enables you to see when the peak (*high water*) times are for license usage.

The horizontal axis of the line graph measures time, scaled to fit all of the data for one feature into one window; the vertical axis measures the number of licenses used. For each feature, two lines are plotted—one representing available licenses and one representing used licenses.

Peak Usage and Denial Report

The **Peak Usage and Denial** report creates a bar chart report that shows the following information:

- Number of peak usage licenses within the specified summary period. You can specify a summary period with a granularity of seconds, minutes, hours, days, weeks, or months.
- Number of denials within the summary period, if there were any.
- An optional availability line, which shows the number of available licenses at a particular time.
- An optional overdraft line, which shows the number of overdraft licenses at a particular time.



Note • In rare cases, the vendor daemon reports unsupported events in the report log as ultimate denials, instead of as unsupported events. These events appear in the report log as ultimate denials, but unlike standard ultimate denial events, these events do not have any license feature associated with them. Raw Report

A **Raw** report displays the raw data in text format. This enables you to use third-party tools to create a custom report for analyzing problems, such as the nature of certain denial or excessive events. This report provides information about individual usage events: It provides one line of data for every license checkout, listed in chronological order of checkin.



Note • In rare cases, the vendor daemon reports unsupported events in the report log as ultimate denials, instead of unsupported events. These events appear in the report log as ultimate denials, but unlike standard ultimate denial events, these events do not have any license feature associated with them. FlexNet Manager for Engineering Applications reports these events as unsupported events, rather than denials.

Server Coverage Report

A **Server Coverage** report shows how much time the license server has served licenses. This report enables you to see both the up time and any periods of down time (coverage gaps) for each vendor daemon. You can specify the duration of the coverage gap when you configure the report.

This report displays the time that the license server was up, as well as the following information:

- Periods of time that the license server was down
- Corrupted blocks of data in the report log
- Missing blocks of data in the report log
- Errors discovered with the report log during the report's generation

- **Do not overwrite.** —Creates subdirectories (in the report output directory) for reports based on their timestamps. The timestamp is of the format YYMMDDHHmmssSSS (where SSS represents milliseconds), for example, **C:\ManagerReports\150527213046255** for May 27, 2015, 9:30:46 p.m. Each time the report is run, a new subdirectory is created.
- **Do not overwrite.** Create subdirectories using report names and timestamps.—Creates subdirectories (in the report output directory) for reports based on their configuration name. Each subdirectory, in turn, has subdirectories based on timestamps, for example,

C:\ManagerReports\Usage_Over_Time_Sample1\070527213046255 for the configuration "Usage Over Time Sample1," run on May 27, 2007, 9:30:46 p.m.

- **c.** In the Post-Processing Command field, specify any post-processing commands that you want to invoke after the report is generated.
- **d.** In the Coverage Gap Threshold field, specify the coverage gap threshold in seconds. By default, only gaps in license service exceeding 15 minutes (900 seconds) are shown.
- 5. Click Finish or Finish & Run.

Summary Barchart Report

The **Summary Barchart** report creates a bar chart that shows usage for each feature. This report allows you to compare license usage across users and features. Based on calculations made in a Usage Summary Report, this report enables you to see the volume of usage.

By default, this report shows usage for each feature. The bars are arranged in alphabetical order. License usage is displayed as columns whose heights represent the following metrics:

- Num Used: Number of licenses checked out
- % **Used**: Percentage of available license hours used
- Hours Used: Number of available license hours used
- Max Used: Maximum number of licenses checked out at a time

A **Unique User** report shows the number of unique users for specified vendors and/or features during a given time period. This report enables you to see which features are most and least heavily used by your organization.

 - To include a list of the user names, select the "Include User Names" check box. The report will list all of the unique users at the end of the report.
 - In addition to displaying the unique user name list for all features or vendor/features at the end of the report, you can also display user names for feature or vendor/feature breakdowns (that is, show links for each feature/vendor. Click the link to view the unique user names for the feature/vendor.)

Usage Efficiency Report

A **Usage Efficiency** report creates a bar chart that shows how long each successive license for a feature was in use. This report enables you to see the efficiency of license usage and to more accurately determine how many licenses your organization needs for a particular feature.

This report shows you the maximum number of licenses checked out at one time compared to the total number of licenses available. The first bar in the graph shows how long the first license for that feature was checked out, the second bar shows how long a second license was checked out, and so on, up to the maximum number of licenses checked out at one time.

Several notations may appear on this report, representing the following types of unusual usage:

- Usage of overdraft licenses—denoted by an asterisk (*). For example, a bar marked as **4*** represents the amount an overdraft license is used.
- Usage in excess of the license limit—denoted by a question mark (?). For example, a bar marked as 5? represents the amount five licenses were used simultaneously if the license limit were less than five.

Usage Over Time Report

The horizontal axis of the line graph is time, scaled to fit all of the data for one feature into one window. The vertical axis is the number of licenses used. For each feature, two lines are plotted: one representing available licenses and one representing used licenses.

In the Output Options page, you can omit the line for available licenses by clearing the **Show Available Licenses** check box.

Usage Summary Report

A **Usage Summary** report provides textual output that summarizes the usage statistics for each feature. The top section of the report provides information about the report parameters—including when the report was run, the vendors and license server hosts included in the report—and a list of the features with and without activity.

Feature activity includes all feature events, including checkouts, denials, unsupported requests, and queued requests. If you chose to sort the report data by feature, you can click a feature name in the "Features with activity" section to view the specific activity for that feature.



Note • In rare cases, the vendor daemon reports unsupported events in the report log as ultimate denials, instead of unsupported events. These events appear in the report log as ultimate denials, but unlike standard ultimate denial events, these events do not have any license feature associated with them. FlexNet Manager for Engineering Applications reports these events as unsupported events, rather than denials.

The bottom section of the report, with default settings, contains one line per feature and multiple columns per line, depending on the breakdown categories you selected. These columns are described in the following table.

If there are denials in your reports where the maximum available number of licenses was never used, some of the possible reasons are listed below, including an example for each:

• The number of available licenses changed during the report period.

For example, you may have started your report when you had ten licenses of Feature A. A few months later, while you were writing to the same report log, you add ten more Feature A licenses. Your report would now show a maximum number of available licenses as being 20, and maximum number of used licenses as being 18, but also shows eight denials. These denials probably occurred when you only had ten available licenses.

A vendor enabled the "use all features" switch.

For example, if this switch is enabled and you try to check out a license for a feature that has multiple feature lines (some of which are already checked out), denials will be logged for each feature line that is already in use until the license server finds an available license.

Some licenses are reserved for particular users.

For example, if someone outside of the reservation group tries to check out a reserved license, the request will be denied because even though all licenses for a feature are not checked out, they are not available to all users. License reservations are set in a vendor daemon's options file.

Some users are excluded from the group of users who can check out a license.

For example, a particular user may be denied from checking out a license even though not all of the available licenses are checked out. A particular user can be excluded through a vendor daemon's options file.

The total number of licenses for a feature are divided among multiple license servers.

For example, when all licenses for a feature allocated to a particular license server are checked out, additional requests from that server will be denied even though licenses are available for the same feature from another server.



Task To create a Usage Summary report configuration:

- From the Reporting tab, under Classic Reporting, click Report Configurations.
- 2. For the Usage Summary report configuration, click Edit to launch the Create Report Configuration Wizard.
- **3.** In the Create Report Configuration: Naming page, provide a name and description for your report configuration, specify a date range, and select the vendor daemons and license server hosts from which you want report log data.
- **4.** In the Create Report Configuration: Feature Selection page, select the features whose report logs you want to use to provide data, and specify how you want the features identified in the report.
- **5.** In the Create Report Configuration: Filter Properties page, create filters to focus the data that is displayed in the report.
- **6.** In the Create Report Configuration: Summary Options page, specify breakdown categories for report data and select the time periods to include in the report.
- 7. In the Create Report Configuration: Output Options page, select the report output format, specify sort order, and provide additional output-related information.
- 8. Click Finish or Finish & Run.

Report Configurations

Before generating a report using Classic Reporting, you must create a report configuration. The report configuration defines the parameters used in creating the reports from the set of available report logs.

You create report configurations using the Report Configurations page; you can import a configuration, edit an existing configuration, or create a new one. In each case, you are presented with the Report Configuration wizard consisting of several steps. The series of steps vary depending on the type of report.



Note • To add, edit, copy, or import report configurations, the user must have a role with the View/Add/Edit/Copy/ Import Report Configurations permission.

- 1. From the **Reporting** tab, under **Classic Reporting**, click **Report Configurations**. This displays the **Report Configurations** page.
- 2. In the **Import Report Configuration** field (in the upper-right corner), enter the fully qualified path—including the file name— to the report configuration you want to import, or click the **Browse** button to navigate to the report configuration file.
- 3. Click Import.

Creating Report Configurations

You can create a new, customized report configuration based on a FlexNet Manager for Engineering Applications report type.



Task To create a new report configuration:

- 1. From the **Reporting** tab, under **Classic Reporting**, click **Report Configurations**. This displays the **Report Configurations** page.
- **2.** From the Report Types list in the upper-right corner, select the report type on which you want to base this report configuration and click **Create**.
- **3.** In the **Configuration Name** field on the **Naming** page, provide a unique name for the report configuration. Without a unique name, the report configuration cannot be saved.
- **4.** Depending on which report type you choose, between two and six definition pages guide you through the process of creating a report configuration.
- **5.** At any time during the process, you can:
 - click Finish to save your report configuration. or
 - click Finish & Run to save your report configuration and run the report.

You can later edit your report configuration or run a report based on the configuration.

In addition to creating a new report configuration, you can:

- Use a sample report configuration as it is.
- Import a previously created report configuration and use its parameters.
- Copy an existing report configuration.

You can also invoke post processing for your reports directly from FlexNet Manager for Engineering Applications.

Copying Report Configurations

FlexNet Manager for Engineering Applications provides the capability to copy an existing report configuration. This enables you to easily create a report that has the same report specifications with a few exceptions (for example, a different date range, vendor daemon, or host server).



Task To copy an existing report configuration:

- From the Reporting tab, under Classic Reporting, click Report Configurations. This displays the Report Configurations page.
- Click the Copy button next to the report whose configuration you want to copy.

When you copy a report configuration, FlexNet Manager for Engineering Applications clones the existing report configuration and displays the first page of the report wizard. As you go through the report configuration wizard, you can make changes specific to this version of the copied report configuration, creating a new report based on an existing report.

All report data are copied except for the **Configuration Name** and the report title.

- The new configuration name will be "Original Report Configuration Name Copy n," where n is the copy number. For example, if you created two copies of the High Water Mark report, the second copy would be named "High Water Mark Sample Copy 2."
- The new report title will be "main original report title + appendix for new report configuration name." For example, if the existing report title is "Sample HWM Copy" and the new report configuration name is "HWM Copy 4," the new report title is "Sample HWM Copy 4." The purpose is to use the same appendix as the report configuration.

When you copy a report configuration, FlexNet Manager for Engineering Applications copies the values in the **Report Output Directory** and **Output Directory Options** settings (available on the **Output Options** page of the report wizard). If a report output directory is specified in the original report configuration, FlexNet Manager for Engineering Applications displays a warning message on the first page of the report wizard asking you to change the report output directory or the output directory options, so your copied report does not overwrite existing report output.

You can save your copied report configuration at any time by clicking the **Finish** button, available on most of the report wizard pages.

To cancel the copied report configuration, click the **Cancel** button. FlexNet Manager for Engineering Applications exits the report wizard and returns to the **Report Configurations** page; the cloned report is not created.

- 2. Select the report configuration that you want to delete. Note that you can select multiple report configurations to delete.

Report Configuration Pages

To create a report, you select a report type and work through the report configuration pages presented for the report type. Depending on the report type you select, FlexNet Manager for Engineering Applications displays between two and six report configuration pages, which enable you to customize your report with regard to the usage information shown and how that information is displayed.

Graph Options	On this page, you can customize the look of your finished report.

Create Report Configuration: Naming

On the **Naming** page, you provide a name and description for the report configuration, select a date range, and specify which vendor daemons and license server hosts you want to use for reporting data.



Task To specify information on the Naming page:

1. Specify the settings as described in the following table.

Configuration Name	Type a unique name for this report configuration. This will be used to identify the report configuration in the Report Configurations list.
Configuration Description	Type a description that explains what data this report configuration will display.
Date/Time Range	 Specify a date range for the report data using one of the following options: Select a specific start and end date using the calendar buttons. Select a number of prior days. Select a number of prior months. Select a predefined date range from the list.
Vendor Daemons	Select the vendor daemon(s) from which you want to use report log data. If you want to use report log data from all of your vendor daemons, selectALL Tip • To select multiple vendor daemons, press the Ctrl key while selecting items in the list.
License Server Hosts	Select the license server hosts from which you want to use report log data. If you want to use report log data from all of your license server hosts, selectALL Tip • To select multiple license server hosts, press the Ctrl key while selecting items in the list.

Create Report Configuration: Feature Selection

In the **Feature Selection** page, you select report logs to be used for the report that contain the specified features and specify how features are described in the report. This step limits the amount of data that FlexNet Manager for Engineering Applications has to process to generate the report.



Task To specify feature selection options:

1. In the **Features** box, select the features whose report logs you want to use to generate this report. Only the report logs that contain the selected features are used to generate this report. If those report logs contain additional features, the additional features also appear in the report.

For example, if you want a report to show usage data only for feature f3, all report logs that do not contain data about feature f3 are will not be used to generate the report. The report logs that do contain data about feature f3 usage also contain data about features f4 and f5, so your report will show usage for features f3, f4, and f5.

Select --ALL-- to use all of the report logs (containing all of the listed features) to generate the report.



Tip • To show only data for specific features, add a filter using the Filter Properties page. Select Feature == featureName for each feature for which you want to show usage information.

2. For the **Describe Features by** option, select how you want FlexNet Manager for Engineering Applications to identify features in the report.

Option	Description
Feature Name	The report will identify features only by the feature name.
	For example, if feature f3 has version 1.0 and 2.0, the report will not distinguish between the different versions, but will display information about feature f3 version 1.0 and f3 version 2.0 as feature f3.
Feature Name and Version	The report will identify features by feature name and by version. For example, if feature f3 has version 1.0 and 2.0, the report will distinguish between the different versions, and will display separate information about feature f3 version 1.0 and f3 version 2.0.
Feature Name and Asset Info	The report will identify features by feature name and by asset information.
Feature Name and License Key	The report will identify features by feature name and by license key.

3. Click Next.

Create Report Configuration: Filter Properties

The **Filter Properties** page enables you to create filters to limit the data that is shown in a report. For example, you may want your report to show only usage information for feature f3, so you would create a filter to limit the data to only usage of that feature.

Task To specify filter properties:

- 1. Select a report filter category from the Category list.
- 2. From the **Operator** list, select an operator symbol.
- 3. In the **Event Filter** field, type the value that for which you want to filter.
- 4. To add another filter, click Add New Filter and repeat steps 1 through 3.
- **5.** For Raw and Usage Summary reports: In the **Event Types** section, specify which event types you want to appear in the report.

Event Type	Description
Used	A Used event consists of a license checkout/checkin pair. The number of Used events is summed over the time period of a report, and the duration that licenses are used is displayed in a report. License usage is calculated as the time between a checkout and its checkin.
Queued	A Queued event consists of a queue/dequeue pair. The number of Queued events is summed over the time period of a report, but the duration a license request is queued before being denied or granted is not displayed (however, queued duration can be calculated from data in a Raw report). If an application is configured for queuing and none of its licenses are available, a Denied event and a Queued event are written into the report log with the same timestamp.
	The application will continue to try to gain a license until one becomes available. Additional denials are not written for each try while queued or if a license is never granted. A queued request will remain queued until it is granted unless the vendor daemon goes down, the license server is shut down, or the request is canceled or timed out.
Denied	The number of denial events is summed over the time period of a report. A denial is instantaneous and has no duration associated with it. The why field in a Raw report gives the reason why a denial occurred.
	If filtering "false" denials is enabled, the report includes the number and percentage of "false" denials that were eliminated.

Event Type	Description
Exceptions	Exception (unsupported) events are generated when the license server receives a request for a feature it does not know about. Exceptions usually occur when the application and the license server are looking at two different license files.
	The application reads its license file and thinks it can get a license for the feature, but when it asks the license server for a license, the license server denies the request and logs it as an exception.
	The most common instances of exceptions are:
	The feature exists in the application's license file, but not in the license server's license file.
	• The version of the feature in the application's license file is later than the version(s) in the license server's license file. (The license server grants a license if the request is for an earlier version but it does not grant a license if the request is for a later version.)

- **6.** For Peak Usage and Denial, Raw, and Usage Summary reports, specify how you want to handle spurious (or "false") denials. See the topic, How Are Denials Analyzed?, for more information.
 - In the **Denial Filtering** section, select the **Eliminate spurious denials** option if you want to eliminate spurious (or "false") denials. A spurious denial can occur when an application requests a license from a license server that uses a license file containing several INCREMENT lines for the same feature. In this case, it is possible to trigger a cluster of denials reported before a successful checkout is obtained.
 - In the **Time interval** box, specify a number of seconds. During this time, denials for the same feature, user, host, process id, and report log file that occur in clusters are qualified for denial.

How Are Denials Analyzed?

FlexNet Manager for Engineering Applications analyzes the denials in each report log and eliminates spurious ("false") denials from a report. All qualified denials (both regular denials and ultimate denials) occurring with in the time specified in the **Time interval** setting of the Filter Properties page are considered together.

- If, at the end of the time interval, the license has not been granted, the last denial is reported and all previous denials are eliminated from the report.
- If a series of denials is followed by a checkout, then the checkout is reports and all denials are eliminated.

Create Report Configuration: Summary Options

Using the **Summary Options** page, you select report breakdown categories and define the time periods for which you want usage data.



Task To specify summary options:

1. In the **Breakdown Categories** section, select the categories you want to use in this report. Report breakdown categories enable you to specify categories for which you want the report to display data. You can specify multiple breakdown categories.

Breakdown Category	Description
Expiration Date	Enables you to know when a license is expiring and who is using that license so you can decide whether to renew the license depending on the level of license usage.
Hostid on Feature Line	Enables you to compare the usage among multiple report logs from multiple license servers. This helps with load balancing on the servers.
Group	Enables you to group users to represent a department or project.
	Reports can be broken down by group to provide an allocation of cost by project or department. Reserving licenses can be done by group also.
User	Enables you to see usage per user.
User Display Name	Enables you to see usage per display name.
FlexNet Licensing Version	Provides the version of FlexNet Publisher licensing being used.
User Host Name	Enables you to determine if a user is using multiple licenses on different machines.
	The host name might be a user's department or country.
User IP Address	Provides the IP address of the machine that the application is running on.
	This is usually assigned dynamically.
User Platform	Provides the type of platform the application is running on. Allows you to know if old versions are being used, or if the wrong platform is being used.
User Product Version	Shows the version of the product that is used
User Project	Provides a project's number. A project number is set in an environment variable and can be reported for several reasons, including the cost of software for a project.
Checkout Data	Value of CHECKOUT_DATA passed by the application to the license server when the license was checked out.
Vendor String	Provides the version numbers of a string of applications in the package.

Breakdown Category	Description
Version	Provides the application's version number, which enables you to identify the version that the user is using and track who is using which version of the software.

2. In the **Time Periods to Include** section, specify the days and time ranges for which you want usage data. The report will contain only the data from the selected time periods.

For example, to include only usage data for Monday through Friday, from 8:00 a.m. to 6:00 p.m., and for Saturday from 8:00 a.m. to noon, select the following:



- **3.** From the **Summary Period** list, choose the unit of time for which you want the report to calculate usage activity.
 - For High Water Mark and Usage Over Time reports, the summary period represents the granularity of the report. Longer summary periods are useful when generating Usage Over Time and High Water reports over long reporting periods to control the size of the report.
 - For Peak Usage and Denial, Summary Barchart, and Usage Summary reports, the summary period
 represents the time interval by which to subdivide the report—an individual bar or line of data is displayed
 per summary period. For example, using a summary period of Month shows usage statistics on a monthly
 basis for the entire reporting period. If the summary period is too small, the report display may be
 unreadable.

Changing the default **Summary Period** setting affects the efficiency of the FlexNet Manager for Engineering Applications report generator. Setting a summary period for a Usage Over Time or High Water Mark report reduces the amount of data and can result in less overall memory usage and faster report execution and display. Conversely, setting a summary period for a Summary Barchart or Usage Summary report—or changing the summary period for a Peak Usage and Denial report to a smaller unit—increases the amount of calculations and memory required.

Choose a summary period that is appropriate for the type of report you are generating and the duration of your report data.

4. Select the **Show Zero Usage** check box to display all features in a report, regardless of whether they have been used during the report period.



Note • This option is available for Usage Over Time, High Water Mark, Summary Barchart, and Usage Summary reports.

Create Report Configuration: Output Options (also Raw Report Output Properties)

In the **Output Options** page (also the **Raw Report Output Properties** page), you specify the report format and the order in which you want data displayed in the report. In addition, you can specify an output directory for the report and use post-processing commands on the report data.



Task To specify output options:

1. In the **Output Format** section, select the manner in which you want to view the report output. You can specify multiple output formats.

Output Format	Description
HTML	HTML report output can be viewed in an HTML browser.
XML	Report output is generated as XML. The Report Inbox provides a link to the XML output.
Image	Graphical report output is saved to files in PNG or JPEG format
RIF	Output in Report Interchange Format (RIF) is available for all reports except Summary Barchart reports. RIF is a simple, flexible, plain text format that is designed to pass tabular information between the report generator and another application, such as a spreadsheet. Specify a delimiter—choose space, tab, or specify a custom delimiter. Important • Do not use double quotes ("), single quotes ("), or a backslash (\) as the RIF delimiter.
Text	Report output is saved to a text file.

2. In the Sort Order section, specify how you want the report output ordered. Report output can be ordered by feature name and by the breakdown category value. When you select breakdown category settings, default sort order settings are automatically set. You can override these default settings by changing the sort order specifications in the list.

To change the sort order:

- **a.** Select the breakdown category value that you want to move.
- **b.** Click the arrow buttons to move the value up or down in the list.
- 3. For Summary Barchart reports: From the Summarize list, choose how you want the report to show usage for each feature that was used. License usage is displayed as bars whose heights represent one of the following metrics.
 - Number Used—Number of licenses checked out
 - Percent Used—Percentage of available license hours used
 - Hours Used—Number of available license hours used

- Max Used—Maximum number of licenses checked out at a time
- 4. Select the **Additional Options** that you want to apply.

Option	Description
Show Available Licenses	Select this option to show the number of available licenses for a particular feature.
Auto-Reduce Large Datasets	If the report dataset is particularly large, FlexNet Manager for Engineering Applications will automatically reduce the number of data points.
	Note • To avoid automatic data reduction, reduce the number of data points by choosing a different summary period or by narrowing the date range of the report.

5. In the Report Output Directory field, specify an absolute path for the output directory location—for example, C:\ManagerReports. The Report Output Directory is a folder located on the disk, where additional copies of the reports generated, will be saved. This directory is called the base directory, and the directory that you specify must already exist. The directory also needs to have write permission so the report output can be copied there.



Note • The Report Output Directory is in addition to the FlexNet Reporting's internal reports repository, which is located at \data\reports\output on the FlexNet Reporting server. When you delete a FlexNet Manager for Engineering Applications report, the report is deleted from the internal reports repository; however, reports contained in the Report Output Directory are not deleted. You must manually delete reports in the Report Output Directory.

- 6. In the Output Directory Options section, select one of the following options:
 - **Overwrite the existing contents**—When the report is run, the output is copied to the directory specified in the Report Output Directory field.



Important • If this option is selected, all existing files in the Report Output Directory will be deleted before reports output is written to this directory.

- **Do not overwrite.** Create subdirectories using timestamps.—Creates subdirectories (in the report output directory) for reports based on their timestamps. The timestamp is of the format YYMMDDHHmmssSSS (where SSS represents milliseconds), for example, **C:\ManagerReports\091027213046255** for October 27, 2009, 9:30:46 p.m. Each time the report is run, a new subdirectory is created.
- **Do not overwrite.** Create subdirectories using report names and timestamps.—Creates subdirectories (in the report output directory) for reports based on their configuration name. Each subdirectory, in turn, has subdirectories based on time stamps, for example,
 - **C:\ManagerReports\Usage_Over_Time_Sample1\091027213046** for the configuration "Usage Over Time Sample1," run on October 27, 2009, 9:30:46 p.m.
- **7.** In the **Post-Processing Command** field, specify any post-processing commands that you want to invoke after the report is generated.
- 8. Click Next.

Create Report Configuration: Graph Options

The Graph Options page enables you to customize the look of your finished report. You can use a predefined (or standard) style or you can create a custom look, in which you choose a color scheme, define text properties, and specify a line style.

Using Predefined Graph Options

FlexNet Manager for Engineering Applications provides several predefined graphic themes, which you can apply to your reports.



Task To specify predefined graph options:

- 1. In the Title box, type the title that you want displayed on the finished report.
- 2. For the Style option, select **Standard**.
- 3. In the Theme section, click a theme image to select a graphic theme for your report.
- 4. Click Finish.

Using Custom Graph Options

If you want full control over the way in which your report data is displayed, use the Custom style option to define report graph options.



Task To specify custom graph options:

- 1. In the Title box, type the title that you want displayed on the finished report.
- 2. For the Style option, select **Custom**.

- If you want to use 3D effects in your report, select the Use 3D effect check box and choose the pixel depth from the list.

Filtering Report Data

FlexNet Manager for Engineering Applications enables you to tailor reports to evaluate and show the data that you want. To limit and focus the data displayed in a report, you create filters using the Filter Properties page of the Report Configuration Wizard.

Report filter categories—when used in conjunction with filter operator symbols and event filters—enable you to narrow the focus of your reports.

All specified filters must be satisfied, except in cases where you specify multiple event filters for the same category. If multiple filters are specified for the same category, only one of the filter conditions must be satisfied.

For example, if you create the following filter conditions—

- User Host Name == abc
- User Host Name == def
- User == jsmith

Classic Reporting

—the report will included usage data collected for the user host name abc OR def AND for the user jsmith.



Task To specify a filter:

- On the Filter Properties page of the Report Configuration Wizard, select a report filter category from the Category list.
- 2. From the **Operator** list, select an operator symbol.
- 3. In the **Event Filter** field, type the value that for which you want to filter.
- **4.** To add another filter, click **Add New Filter** and repeat steps 1 through 3.

To remove a filter, click the **Remove** link to the right of the filter condition.

Note • Only a user with the <u>Super Administrator role</u> or the user who originally started running the report can cancel a report while it is in progress, whether the report is run manually or by the FlexNet Manager for Engineering Applications scheduler.



Task To run a report immediately:

- From the Reporting tab, under Classic Reporting, click Report Configurations. This displays the Report Configurations page.
- 2. Click the **Run** button to the right of the report configuration that you want to run.
- 3. A dialog appears, asking if you want to run the report. Click OK.
- 4. Go to the **Report Inbox** to view the report output.



Note • You may need to refresh the page by pressing **F5** or clicking the **Refresh** button for your web browser.

Scheduling Classic Reports

Using the **Report Scheduling** page, you can schedule a report to run at the same time on specified days. This way, you can schedule a report to run nightly, weekly, monthly, and so on.



Note • Only a user with the Super Administrator role or the user who originally started running the report can cancel a report while it is in progress, whether the report is run manually or by the FlexNet Manager for Engineering Applications scheduler.



Task To run a report at scheduled times:

- From the Reporting tab, under Classic Reporting, click Report Configurations. This displays the Report Configurations page.
- 2. Click the **Schedule** button to the right of the report configuration for which you want to schedule a run. This opens the Report Scheduling page.
- 3. In the **Run Report** section, click one of the radio buttons:
 - Not Scheduled—This report is not scheduled to run.
 - These days at (hh:mm)—Specify a time (using a 24-hour clock) and select the days of the week on which
 you want the report to run.
 - These months on day (number of day in a month) at (hh:mm)—Select the day, specify a time (using a 24-hour clock), and select the months on which you want the report to run.

4. Click Save.

After the report runs, the report output is available in the Report Inbox.

Viewing Classic Report Output in the Report Inbox

As soon as a Classic report begins to run, it is displayed in the list on the **Report Inbox** page. Reports remain listed on this page until they are deleted.



Note • Only a user with the Super Administrator role or the user who originally ran the report can delete a report from the Report Inbox, whether the report is run manually or by the FlexNet Manager for Engineering Applications scheduler.

The **Report Inbox** page provides the following information for each report:

- Status of the report run (Failed, Running, Canceled, or Complete)
- · Report configuration name and a link to the report output
- User who ran the report
- The date and time at which the report was run
- Progress of a report run (expressed as a percentage of completion)



Task To view report output:

- 1. From the Reporting tab, under Classic Reporting, click Inbox. This displays the Report Inbox page.
- 2. When the status for a report is Complete, you can view the report by:
 - Clicking the **Text** or **Image** link under the Configuration Name.

This displays the report output in a new browser window.

Clicking the **Download** button for that report.

This archives all report components into a .zip file and displays a folder of file names using a ZIP utility. From here, use the ZIP utility according to standard practice.

Checking the report output directory.

When creating a report configuration, you can specify a report output directory in the **Output Options** page.

3. Click the **View Log** button for a report to view the report's status log.



Note • The View Log button is not displayed while the report status is Running.

Click the **Delete** button for a report to remove the report output.

Specifying Post-Processing Options

FlexNet Manager for Engineering Applications provides the ability to configure a script that can be called when a report completes. The post-processing scripting (also known as command-line option) support provides a way to enter a single scripting expression in the FlexNet Manager for Engineering Applications interface. This allows typical post-generation steps (such as user ID replacement and customized formatting) to be directly invoked after the report has been produced.

Report post-processing options are available in the Raw Report Output Properties page of the Report Configuration Wizard.

The last three settings on this page (Report Output Directory, Output Directory Options, and Post-Processing Command) are relevant for post-processing functionality. The first two settings—Report Output Directory and Output Directory Options—deal with the configuration of the external copy of the generated report, and the Post-processing Command setting is where you specify post-processing command-line parameters.

The external report copy is independent of the post processing, but if in reaction to the completed and copied report, you want to execute a script or some other program, you can populate the Post-Processing Command field. In this field, you can specify the command that FlexNet Manager for Engineering Applications should execute after the report has been generated. This command typically includes the path of an executable (which can be a script processor) together with some input to properly process the report.

In many cases, the post-processing script needs additional input parameters to efficiently process the report. This input can include the location of the output directory, the list of files produced for the report, the type of report produced, and so on.

FlexNet Manager for Engineering Applications provides a number of command-line parameters that you can use for post processing. These input parameters are added to the script with a dollar sign (\$) prepended to the keyword and at run time replaced by the real values. For example, the expression—

/usr/bin/perl /opt/scripts/postproc.pl \$outputDir \$outputFiles

-will be emitted to the command line-

/usr/bin/perl /opt/scripts/postproc.pl /opt/reportOut MonthlyRaw.rif

—if the output directory is set to "/opt/reportOut" and the report is a raw report named "MonthlyRaw."

Note • You should use parameters that are applicable to the report type you are defining. Using parameters not applicable to the report type will result in indeterminate values at run time.

Parameters that can have an empty value (\$features, \$servers, \$vendorDaemons, \$filter, \$eventFilter) should be used only in cases where the corresponding report configuration values are not empty. If the report configuration setting does not contain a value for a specified parameter, no argument will be emitted, which can cause the argument interpreter in the post-processing script to confuse the next argument with the value of the current argument.

Example: The list of servers is specified (\$servers), but in the License Server Host selection on the Naming page (step 1) of the Report Configuration Wizard, none has been selected (indicating to run the report for all license server hosts). Then no argument will be emitted by the post-processing invocation. In case another parameter is specified, the argument evaluation logic can easily mistake the value for the next argument as the list of servers.

After you specify the post-processing expression, you can complete the report configuration. When you finish the report configuration, FlexNet Manager for Engineering Applications validates the external output directory and the post-processing expression.

After saving the report configuration, you can run the report. FlexNet Manager for Engineering Applications will generate the report, copy the report to the external directory, and then invoke the post-processing script.

Testing Post-Processing Scripts

It is recommended that you use a test script first to see the command-line arguments that are being passed in and to compare them to the expected values. The following code sample shows a simple perl script which will emit the argument values into the report log file, which can be retrieved from the **Report Inbox** page.

```
print "Post-processor command line arguments:\n";
foreach $arg (@ARGV) {
  print "\t$arg\n";
}
```

When you understand the command-line parameters, you can adjust your existing post-processing scripts or programs to interpret the report data.

Error Scenarios

There are two different error scenarios—report generation failure and post-processing failure.

- In the first scenario, the report generation in FlexNet Manager for Engineering Applications fails for some reason. In this case, the \$errorNum parameter contains a nonzero value and the \$errorLine parameter contains a description of the problem. In most cases, you can analyze the report generation log file (a file named *ReportConfigurationName.fns* located in the output directory) to troubleshoot the problem. The status of the report in the *Report Inbox* will show Failed.
- In the second scenario, the post processing fails and returns a non-zero exit status. (This is the return value of the process). The status of the report in the Report Inbox will also show Failed. This will not allow access to the data FlexNet Manager for Engineering Applications successfully produced.

Report Post-Processing Examples

Example 1: Monthly Extraction of Raw Data

Use Case: FlexNet Manager for Engineering Applications should provide the Raw data format for the managed licensing system on a monthly basis. A nightly raw report is run on the first day of the next month to extract the data. The post processing includes replacing of the user IDs with full User names and department information.

Report Configuration: Define a raw report configuration with the following settings.

- 1. Set the Date/Time Range to "Prior Month," scheduled at the first of each month. Because the raw report contains data for the entire system, all of the server hosts, vendor daemons and features are included.
- **2.** The Event Types (on the Filter Properties page) can be restricted to Used, Queued and Denied, because exceptions are not relevant to the further processing.
- 3. On the Raw Report Output Properties page, select the RIF format. Note that for this format, there is no parameter because the you can deduce the report output format based on the file endings of output files.
- **4.** Select "Time as Seconds" and specify the appropriate location in the Report Output Directory field. Also, select the "Overwrite the content" option (in case the output after post processing does not need to be preserved) and specify the post-processing command (in this example, Perl on Unix is used):
 - /usr/bin/perl /opt/cblecken/perl/rawProcess.pl \$outputDir \$outputFiles \$errorStatus \$errorLine \$reportType \$user \$startDate \$endDate \$eventFilter \$delimiter \$elimFalseDenials \$sortOrder \$featureUniq \$timeInSeconds
 - These are all of the parameters that apply to a Raw report. As noted previously, because none of the servers host, vendor daemons or features are selected, the associated parameters \$servers, \$vendorDaemons, and \$features are not included in the post-processing command expression. They should be included only in case a non-zero selection has been made.
- 5. Next, the Raw Report Fields page lists the fields you can select to include in the Raw report. The list of Raw report fields is not included in the list of parameters, because the Raw RIF format will describe the number of columns and the name of the columns in the report itself and it is more consistent to take the column numbers and column names from the report.

Report Generation: Given the sample perl script from the previous code sample (which writes the parameters to stdout), generating a report from this configuration leads to the following invocation on the command line as described in the following table.

Example 2: Month-to-Date High Water Mark

Use Case: Every day the aggregated High Water Mark report is calculated for the entire month up to today. This report should include only a subset of vendor daemons (for this example, the two vendor daemons "examlmd" and "exanImd"). This report is run every night.

Report Configuration: Define a High Water Mark report configuration with the following settings.

- 1. Set the Date/Time Range to "Month to Date," scheduled to run every night. Also select the vendor daemons "examImd" and "exanImd" from the Vendor Daemons selection box. Do not select anything for the license server hosts or the features (on the Feature Selection page).
- 2. On the Summary Options page, select the "Show Zero Usage" option.
- 3. On the Output Options page, select the RIF and the Image output format. In the Additional Options section, select the "Show Available Licenses" and "Auto-Reduce Large Datasets" options.
- 4. Specify the appropriate location in the Report Output Directory field. Also, select the "Overwrite the content" option (in case the output after post processing does not need to be preserved) and specify the postprocessing command (in this example, Perl on Unix is used):
 - /usr/bin/perl /opt/cblecken/perl/hwmProcess.pl \$outputDir \$outputFiles \$errorStatus \$errorLine \$reportType \$user \$vendorDaemons \$startDate \$endDate \$showZero \$showAvail \$sortOrder \$featureUniq
- 5. On the Report Scheduling page (available by clicking the **Schedule** button for the report from the Report Configurations page), schedule the report to run on the first of each month.

Report Generation: Given the sample perl script from the previous code sample (which writes the parameters to stdout), generating a report from this configuration leads to the following invocation on the command line as described in the following table.

Operational Dashboard

FlexNet Manager for Engineering Applications provides an Operational Dashboard that provides data about license usage, denials, and license server status for both FlexEnabled and LUM-enabled applications. The Operational Dashboard does not provide usage monitoring for features that have unlimited availability (are uncounted).

Accessible from within the FlexNet Manager for Engineering Applications user interface, the Operational Dashboard opens in a separate browser window. The Operational Dashboard uses the Cognos Business Insight feature, which provides a flexible and configurable framework for you to view your enterprise's usage data. (For information about working with IBM's Business Insight dashboard, click the help icon located in the toolbar at the top of the Operational Dashboard window.)

By default, the Operational Dashboard contains five mini-versions of reports (called *report widgets*). You can drag the report widgets around the dashboard page to display data where you want to see it. You can also add your own reports to the Operational Dashboard.

Server Time Zones and Accurate Display of Usage Data

Because the Operational Dashboard uses time zone information from both the reporting database server and the Flexera Analytics (Cognos) server to display usage data, it is important that both the reporting database server and the Flexera Analytics (Cognos) server are in the same time zone. It is also recommended that the FlexNet Manager for Engineering Applications servers be in the same time zone.

Operational Dashboard Report Widgets

The Operational Dashboard is composed of report widgets, which are small, self-contained reports that you can move around the dashboard space. By default, the following report widgets are displayed.

- Feature Usage—An area graph that shows feature usage for a specified time period. The red line at the top of the graph represents total availability for the feature. Use the menus in the upper-left corner of the widget to filter usage data by time period and feature name (by selecting the vendor name first, then specifying the feature name for which you want to see usage data). The time period you specify for the Feature Usage report widget is the time period that is used for the Features by Peak Usage report widget. Changing the time period for either report updates the data displayed in the other report.
- Features by Peak Usage—A table showing the 100 features with the highest peak usage for a given time period. The table provides the vendor name, feature name, type of license (whether FlexNet or LUM), the peak percentage used within the time period, and a small area graph showing usage for the time period. (The red line represents total availability for the feature during the specified time period.) Selecting All Data for the time period shows data for a rolling two-week period. The time period you specify for the Features by Peak Usage report widget is the time period that is used for the Feature Usage report widget. Changing the time period for either report updates the data displayed in the other report.
- Excessive Users (by time)—A table that shows the users who have the highest feature usage (measured by
 time of usage and the number of licenses). Use the list at the top to specify whether you want to see excessive
 usage across all features or only for a specific feature.
- Feature Denials—A bar graph that shows license denials for a rolling two-week period. Use the list at the top of
 the widget to show all denials during the time period or only capacity-based denials, where a feature is denied
 because it is being used up to its current capacity. Viewing capacity-based denials can help you determine
 whether you need to free up some licenses or perhaps purchase some additional licenses for a specific feature.
- **License Server Status**—A table showing the status of the license servers in your environment. The Type column identifies whether the server is a FlexNet license server (FLEX) or a LUM license server (LUM).

You can create your own reports and add them as report widgets to the dashboard. See Customizing the Operational Dashboard for information.

Customizing the Operational Dashboard

You can customize the Operational Dashboard by moving and adding report widgets. To move the report widgets, simply drag and drop them around the dashboard space.

You can add customized reports that you have created to the Operational Dashboard and remove existing report widgets from the Operational Dashboard.

Although you cannot overwrite the Operational Dashboard that is included in the FlexNet Manager for Engineering Applications Reports folder, you can save your own version of the Operational Dashboard by re-naming it and saving it in the appropriate folder. You can then set Cognos permissions on your customized Operational Dashboard to specify whether other Cognos users are able to view it. See Reporting on Feature Usage (Historical Feature Reports) for information. (If you save your version to your My Folders location, your customized dashboard can be viewed only by you.)

Adding Report Widgets to the Operational Dashboard



Task To add a report widget to the Operational Dashboard:

- 1. From the Insert menu, select Insert Content. This opens the Content pane on the right side of the page.
- 2. Browse to the report object that you want to add.
- 3. Right-click on the report object, then choose Insert.

Note that not all reports will work well as report widgets. If a report is very complex, the data may become difficult to read if the report is reduced to widget size.

Removing Report Widgets from the Operational Dashboard



Task To remove a report widget from the Operational Dashboard:

- 1. Select the report widget.
- 2. Click the Widget Actions icon in the upper-left corner of the report widget, then select **Remove from Dashboard**.

Before Importing a Package

To successfully import a package, you must first do the following:

- 2. Click Import Package to import the package for Flexera Analytics Reporting.

All of the packages in the **flexera\analytics\bin\deployment** directory will be imported.

Updating the Cognos Datasources

Cognos uses both FlexNet Manager for Engineering Applications Admin and Reporting databases as its datasources. If the database or database credentials have been changed, you may need to update or reset the datasources.

Before updating the datasources, ensure that:

- The Cognos server is running.
- The following settings have been specified on the System Configuration | Reporting page (available under the Admin tab): Cognos server host, Cognos server port, and web services port.



Task To update the Cognos datasources:

- 1. From the Reporting tab, under Flexera Analytics, click Cognos Administration.
- 2. If you are using Oracle, you may need to provide different database service names while updating the datasources. To do this, provide service names in the Admin Server and Reporting Server fields in the Oracle Database Service Names box. (By default, these fields contain the database service names that were provided at installation time.)

To reset the database service names to the original database service names that were provided in the Configurator at installation time, click **Reset Service Names**.

Click Update Datasources to update the datasources that Cognos uses.

The **Cognos Roles** page displays a list of the available Cognos roles, the number of users for which your enterprise is licensed for each role, the number of licenses available for each role, and a list of the FlexNet Manager for Engineering Applications users who have been assigned each role.

To see the **Cognos Roles** link in the navigation bar (which enables you to access the Cognos Roles page), you must have a FlexNet Manager for Engineering Applications role with the **Assign Cognos Roles** permission.

The Cognos roles provide access to various pieces of reporting functionality, as described in the following table. By default, each role can be assigned to a limited number of users. To see how many FlexNet Manager for Engineering Applications users are can be licensed for each Cognos role, refer to the **Cognos Roles** page.

Only users with a role that has the **Assign Cognos Roles** permission can view this page and assign Cognos roles to FlexNet Manager for Engineering Applications users.

By default, the **Super Administrator** role has the **Assign Cognos Roles** permission.

- From the Reporting tab, under Flexera Analytics, click Cognos Roles.

Report Data Aggregation

For increased reporting efficiency, Flexera Analytics (Cognos) reports are built from data contained in a set of database tables called the *data warehouse*, which stores usage data. *Aggregation* is the process that parses the report log data that has been imported to FlexNet Manager for Engineering Applications and populates the data warehouse with usage data. It is sometimes referred to as a *roll-up*.



Important • You must aggregate your usage data before you can run Flexera Analytics reports.

You can run aggregation on your enterprise's report log data in two ways:

- Incremental Aggregation—Run aggregation for specified vendor daemons and/or for a specific time period.
- Periodic Aggregation—Run aggregation on a regularly scheduled, periodic basis.

To view the status of aggregation tasks, go to the Aggregation Status page.

For a detailed description of the Flexera Analytics data model, see the Flexera Analytics Guide.

Required Permissions

To schedule, run, and cancel data aggregation, a user must have a role with the Run and Cancel Aggregation permission.



Tip • To improve aggregation performance, consider defining single-master-feature products if your enterprise uses products that can be configured in this way—products containing a single master feature, where that feature cannot be mapped to any other product. See Single-Master-Feature Product Mapping for information.

Incremental Aggregation

Using the Incremental Aggregation page, you can schedule incremental data aggregation, which enables you to control the data set used for, and the timing of data aggregation. For example, you may want to aggregate only data for a specific vendor daemon or data from before a particular date.

Incremental aggregation can be useful when you are first setting up the FlexNet Reporting data warehouse or if your enterprise has FlexNet Manager for Engineering Applications's Planner functionality and going through the software license–planning process.

You can also use the Incremental Aggregation scheduler to import organizational-structure data from an LDAP domain. (See Importing Organizational-Structure Data from LDAP for more information about this functionality.)

If you want to schedule the aggregation task to take place on a recurring, periodic basis, use the Periodic Aggregation page.



Note • To schedule, run, and cancel data aggregation, a user must have a role with the Run and Cancel Aggregation permission.



Task To define an incremental data aggregation:

- **1.** From the **Reporting** tab, under the **Usage Data Maintenance** section, click **Incremental Aggregation** to display the Incremental Aggregation page.
- 2. For the Aggregation Data Set, specify whether you want to run aggregation:
 - For all vendor daemons
 - For only selected vendor daemons. Hold down the Control key to select multiple vendor daemons.
- **3.** For the Aggregation Increment, specify which data you want to aggregate:
 - Data from all unprocessed report logs for the selected vendor daemons.
 - Data from a specified period for the selected vendor daemons. Specify the beginning and end dates for the period.
- **4.** Select the **Import Org Structure...** check box if you want to import organizational-structure data from an LDAP domain prior to aggregation. When this option is selected, FlexNet Manager for Engineering Applications will import organizational-structure data for all organizational structures that are associated with LDAP domains.

This option is displayed only if an organizational structure has been created and mapped to an associated LDAP domain.

- **5.** Run the aggregation immediately or schedule it to run at a later time.
 - Click Run Now to run this incremental aggregation immediately.
 - Specify a date and time, then click Save Schedule to run this incremental aggregation at the specified time. The time zone is that of the FlexNet Reporting server.

If you choose to schedule the incremental aggregation to run at a later time, the aggregation is displayed in the Scheduled Aggregation list at the bottom of the page. To delete a scheduled incremental aggregation, select the check box in front of the aggregation entry and click **Delete**. Incremental aggregation tasks cannot be edited.

At the top of the page, the status for the last aggregation will be displayed. If an aggregation is currently running, this will be displayed as well.

Periodic Aggregation

For ongoing reporting using FlexNet Reporting, you can set up aggregation to run on a recurring, periodic basis using the Periodic Aggregation page. Periodic aggregation processes all report log data that has been imported to FlexNet Manager for Engineering Applications since the most recent aggregation was run.

You can also use the Periodic Aggregation scheduler to import organizational-structure data from an LDAP domain. (See Importing Organizational-Structure Data from LDAP for more information about this functionality.)

Periodic aggregation does not run if it is set to "Not scheduled".



Note • To schedule, run, and cancel data aggregation, a user must have a role with the Run and Cancel Aggregation permission.



Task To define periodic aggregation:

- **1.** From the **Reporting** tab, under the **Usage Data Maintenance** section, click **Periodic Aggregation** to display the Periodic Aggregation page.
- 2. Select the **Import Org Structure...** check box if you want to import organizational-structure data from an LDAP domain prior to aggregation. When this option is selected, FlexNet Manager for Engineering Applications will import organizational-structure data for all organizational structures that are associated with LDAP domains.
- **3.** Specify how frequently you want periodic aggregation to run. When periodic aggregation is defined for specific days or months, the time zone used is that of the FlexNet Reporting server.
 - Not scheduled—Periodic aggregation does not run. Select this option to turn off the periodic aggregation task.
 - These days—Specify the days of the week and the time using the 24-hour clock.
 - These months—Specify the day of the month for the selected months, and the time using the 24-hour clock.
- 4. Click Save.




Figure 5-3: Feature Peak Usage Trend report




Figure 5-6: Organization Total Usage Chart report




Figure 5-8: Peak Usage by Server Over Time report

Reporting on Product Usage

As part of its investment planning functionality, FlexNet Manager for Engineering Applications provides product-based usage reporting. These are Cognos report definitions that provide reports and graphs based on product usage rather than on feature usage.

To facilitate product usage—based reporting, FlexNet Manager for Engineering Applications maps the usage of licensed features to the products with which the features are associated. You must provide the feature-to-product association, which you can do by adding features to products or assigning unassigned features to products. (You can also specify these associations using a product definition XML file.)

FlexNet Manager for Engineering Applications uses the product usage aggregation process to determine which features combine to create usage for which product.

Product Peak Usage Report




Figure 5-9: Portion of a Product Chargeback report.

Product Usage Aggregation

FlexNet Manager for Engineering Applications uses a data-aggregation process (also referred to as a *roll-up*) to determine which products are being used at your enterprise, based on the feature-usage data generated by report logs. During this process, FlexNet Manager for Engineering Applications analyzes feature usage events to create

FlexNet Manager for Engineering Applications makes the product determinations based on the feature-to-product associations that you provided.

Because some features can be part of multiple products, FlexNet Manager for Engineering Applications uses the *product resolution process* to determine which product in the set of possible products is correct for a particular feature. The result of this determination is provided in a product choice.

A single feature may be part of more than one product. To determine to which product a particular feature belongs, FlexNet Manager for Engineering Applications uses a process called *product resolution*.

The following factors are used to create a product choice for a feature (in the order listed):

- 2. Product with the fewest number of features defined.

3. Product with the largest number of licenses.

Tier Usage Report

The Tier Usage report displays the daily peak usage for a tier, and optionally calculates the cost of the usage (calculated using either the peak or the second-highest peak). This report can be used for billing purposes.

Data is presented in a list that shows costs, followed by a chart and list that shows peak usage for all the days in the specified time period. You can drill through to the hourly report by clicking one of the dates in the lists, which will launch the hourly report for that day, using the same options.

Options for configuring the report include:

- Calculate cost based on peak or second-highest peak, or not at all.
- Interval for the report, either the Previous Month, Previous Quarter, or a custom data range (where you specify start and end dates).
- Select the organization to report on (it is always the top level of the organization that is reported against).
- Select the tier to report on.
- Optionally include breakdown by features—there are three options: Tier data only, Feature data only, or Tier +
 Feature data.




Figure 5-10: Part of the Tier Usage report, showing Hourly Peak Usage by Feature.

Consumptive Token Reports

These reports are specific to the Autodesk consumptive-token–based licensing model. The reports enable your organization to see the total number of tokens consumed in a month, with breakdowns by day and by product family.



Important • Both of the consumptive-token reports require information—**product family** and **token cost**—that is not contained in the report logs. Before running the reports, you must supply this information using an XML file. See the section, Specifying Additional Feature Data Using an XML File, for information on how to provide the information to be used in the reports.

Consumptive Token Monthly Summary Report

The **Consumptive Token Monthly Summary** report provides a tabbed interface that shows token-consumption information for a specified month. Because tokens are granted per day, continued use of the feature during the same day will not result in additional token consumption; however, use of the feature on a different day will result in the additional token consumption.

Tokens are consumed by product family. If a user checks out one feature from a product family, the tokens that are consumed will enable the user to use any other feature in the same product family without consuming additional tokens.



Important • Consumptive-token reports rely on additional feature data (product family and token cost) that must be manually imported into FlexNet Manager for Engineering Applications using an XML file. See the section, Specifying Additional Feature Data Using an XML File, for information.

The report displays the following information for the specified month:

- Total number of tokens consumed
- Number of unique users
- Breakdown of token usage, both by days and by product families
- Out-of-scope tokens and usage hours (Out-of-scope usage refers to usage of tokens that are not part of your organization's contract with Autodesk.)

Consumptive Token Monthly Summary with Contract Report

The **Consumptive Token Monthly Summary with Contract** report provides a tabbed interface that shows token-consumption information for a specified month, along with month-to-date token consumption and the token consumption for each month in the contract year. Tokens are considered consumed when a user accesses a feature that has a token-cost associated with it. Because tokens are granted per day, continued use of the feature during the same day will not result in additional token consumption; however, use of the feature on a different day will result in the additional token consumption.

Tokens are consumed by *product family*. If a user checks out one feature from a product family, the tokens that are consumed will enable the user to use any other feature in the same product family without consuming additional tokens.



Important • Consumptive-token reports rely on additional feature data (product family and token cost) that must be manually imported into FlexNet Manager for Engineering Applications using an XML file. See the section, Operational Dashboard Report Widgets, for information.

The report displays the following information for the specified month:

- Total number of tokens consumed
- Number of unique users
- Breakdown of token usage, both by days and by product families
- Out of scope tokens and usage-hours (*Out-of-scope* usage refers to usage of tokens that are not part of the enterprise's contract with Autodesk.)
- Information about the tokens consumed to date, and the number of tokens consumed in each month during
 the contract year. This enables enterprises to compare the number of tokens consumed to the number of tokens
 to which they are entitled.




Figure 5-12: Part of a Token-Capability Peak Usage report.




Figure 5-13: Part of a Token-Capability Peak Percentage Usage report.

Usage Statistics reports provide detailed information on how products and features are being used in your enterprise. The reports provide data about peak usage, unique users, and ultimate denials for selected products or features. You can use the data in these reports to assist you in making decisions regarding renewals and contract remixes.

The Usage Statistics reports are available in the **FlexNet Manager for Engineering Applications Reports** folder, available from the **Cognos Reporting** page of the FlexNet Manager for Engineering Applications user interface.

Usage Statistics reports are available for:

- Feature Usage Statistics Reports—Peak usage, denials, and availability information for selected features.
- Product Usage Statistics Reports—Peak usage, denials and availability information for selected products.



Important • Before running Usage Statistics reports, you must complete the tasks described in the following section, Prerequisites for Running Usage Statistics Reports.



Note • These reports are not fully compatible for use with hybrid organizational structures. If you have enabled organizational structures for hybrid aggregation, these reports will run, but will show usage data by organization structure **without** breakdown by license servers.

Prerequisites for Running Usage Statistics Reports

In order to successfully run Usage Statistics reports for product— or feature-based reports, you must have organizational structures defined, and your organization's reporting data must be aggregated. For product-based reports, product-to-feature mapping must be in place.

Ensure that the following tasks are completed before running the reports. You complete these tasks using the FlexNet Manager for Engineering Applications user interface.

- For product-based reports, map features to products, using the functionality available under the Planner tab.
 (See Investment Planning for information.)
- For both product
 – and feature-based reports, define organizational structures using the pages available under
 the Reporting tab, in the Organizational Structures section.
- For both product
 – and feature-based reports, run data aggregation using the aggregation functionality
 available under the Reporting tab, in the Usage Data Maintenance section.

Feature Usage Statistics Reports

Feature Usage Statistics reports provide usage and availability information for a selected feature or group of features, for a specified group of users.



Note • Usage Statistics reports support the use of only user-based organizational structures.



Note • These reports are not fully compatible for use with hybrid organizational structures. If you have enabled organizational structures for hybrid aggregation, these reports will run, but will show usage data by organization structure **without** breakdown by license servers.

Feature Peak Usage Summary Report

The **Feature Peak Usage Summary** report is the entry point to all of the other feature usage-statistics reports. It provides a tabular overview of a group's feature-usage activity, including peak usage, denials, unique users, and overall number of usage hours.

The Feature Peak Usage Summary report serves as the gateway to the other reports, which are available as drill-through reports. To access the detailed reports, click the links within the Feature Peak Usage Summary report.

Statistics Detailed Reports

The detailed reports are available as drill-through links from the Feature Peak Usage Summary report.

- **Feature Peak Usage Details**—Column graph that shows the selected feature's daily peak usage over the reporting period, along with optional lines for maximum availability and average peak usage.
- Count of Peak Occurrences—Column graph that shows, for the selected feature, how many times (days) a
 given peak-usage number occurred during the reporting period.
- License Request Daily Denials—Column graph that shows the number of ultimate denials for the feature over the reporting period.
- Denial Details—Provides information about each denial that occurred on a given day, for the selected feature.



Feature Peak Usage Summary Report

When you run a Feature Usage Statistics report, the first view is the **Feature Peak Usage Summary** report. This report provides a view of your organization's feature usage for a given time period, and it includes the information described in the following table.

You can view data for the past 3 months, 6 months, or 12 months by clicking the corresponding tab at the top of the report. The reporting period covers n complete months of data prior to the current date. The reporting period begins on the first day of the first month and ends on the last day of the last month in the period. For example, if you run the report on 06/12/2017, the following date ranges apply:

• 3 Months: 03/01/2017–05/31/2017

6 Months: 12/01/2016–05/31/2017

• 12 Months: 06/01/2016-05/31/2017

You can view more detailed usage data by clicking a link within the report.




Figure 5-14: Feature Peak Usage Summary report

The **Feature Peak Usage Details** report presents a column graph that shows the daily peak number of licenses used for the reporting period. This enables you to see the variation in peak license usage from day to day, for the selected feature.




Figure 5-15: Feature Peak Usage Details report




Figure 5-16: Count of Peak Occurrences report for a feature




Figure 5-17: License Request Daily Denials report

Product Usage Statistics reports provide usage and availability information for a selected product or group of products, for a specified group of users.



Note • Usage Statistics reports support the use of only user-based organizational structures.

Product Peak Usage Summary Report

The **Product Peak Usage Summary** report is the entry point to all of the other product usage-statistics reports. It provides a tabular overview of a group's product-usage activity, including peak usage, denials, unique users, and overall number of usage hours.

The Product Peak Usage Summary report serves as the gateway to the other reports, which are available as drill-through reports. To access the detailed reports, click the links within the Product Peak Usage Summary report.

Statistics Detailed Reports

The detailed reports are available as drill-through links from the Product Peak Usage Summary report.

- Product Peak Usage Details—Column graph that shows the selected product's daily peak usage over the
 reporting period, along with an optional line for average peak usage.
- Count of Peak Occurrences (Product)—Column graph that shows, for the selected product, how many times (days) a given peak-usage number occurred during the reporting period.
- **License Request Daily Denials**—Column graph that shows the number of ultimate denials for the product over the reporting period.
- Denial Details—Provides information about each denial that occurred on a given day, for the selected product.

Running the Product Usage Statistics Reports

The Product Usage Statistics reports are available in the **FlexNet Manager for Engineering Applications Reports** folder, available from the **Cognos Reporting** page of the FlexNet Manager for Engineering Applications user interface.

The initial interface for the Product Usage Statistics reports is the Product Peak Usage Summary report. From this report, you can click links to the drill-through reports, which provide more granular data.

- 2. From the Reporting tab, under Flexera Analytics, click Cognos Reporting.




Figure 5-20: Product Peak Usage Details report




Figure 5-21: Count of Peak Occurrences report for a product

Specifying Additional Feature Data Using an XML File

You can use an XML file to specify additional feature data for use in Flexera Analytics reports. Using an XML file, you can specify the following feature information:

- User-friendly feature name—using the **displayName** attribute.
- Product family for use in consumptive-token-based reports—using the softwareCategory attribute.
- Token cost for use in consumptive-token-based reports or cost factor for use in chargeback reports (Feature Chargeback Report or Product Chargeback Report)—using the costFactor attribute.

You can import feature data in the XML file, in one of the following ways:

- At the command line, using the command importVendorFeatureInfo. The XML file containing the feature
 information can have any name.
- By copying an XML file named vendor_feature.xml to the directory <data_dir>\vendorFeatureInfo. The XML file must be named vendor_feature.xml.

You can specify attributes in an XML file to provide information for use in Flexera Analytics reports. You can import this XML file at the command line, or copy it to the directory <data_di r>\vendorFeatureInfo. (If you copy the file to the vendorFeatureInfo directory, the file must be named vendor_feature.xml.)

To specify information about product family and token cost for consumptive-token–based reports, and the cost factor for chargeback reports, use the attributes as described in the following table.

Importing a Feature-Information XML File at the Command Line

You can import an XML file to provide additional feature data and to update existing feature data, using the command importVendorFeatureInfo. The XML file should include a list of vendors with features. Feature information (displayName, softwareCategory, and costFactor) will be updated for the features specified in the XML file.

The properties specified in the XML file (costFactor, displayName, and/or softwareCategory) will be updated in the RPTDW tables. Properties that are not specified in the XML file will be set to NULL in the database. This way, the XML file provides the most current information about what information is in the database. For more information, see Example XML File and Impact on the Database.



Important • If the XML file lists a feature, but does not specify a value for some of the feature's properties (costFactor, displayName, and/or softwareCategory), those properties will be set to NULL in the RPTDW table in the database.

In order for all feature information to be accurately updated, it is recommended that you run the importVendorFeatureInfo command after aggregation has finished. The XML import does not insert new features into the database; it only updates features that already exist in the database. To ensure that all features exist in the database, you must run aggregation prior to importing the XML file.

Organizational Structures



Note • The **Organizational Structures** section (under the **Reporting** tab) is displayed only if Flexera Analytics Flexera Analytics (Cognos) has been installed and configured. The user must also have a role with the View Org Structures or View and Manage Org Structures permission.

FlexNet Manager for Engineering Applications supports the creation of organizational structures. Organizational structures enable grouping and sub-grouping of users, projects, and license server hosts in hierarchical order. Organizational structures act as a "rule set" for how to distribute license usage across various areas of your enterprise. You can use organizational structures in reporting, and for license distribution (if you use Investment Planning functionality). See Contract Pools for more information about license distribution.

For example, you can create organizational structures for all of the users in your organization, based on the departments to which they belong. You can create another organizational structure based on the geographical location to which users belong. Both organizational structures can exist in the FlexNet Manager for Engineering Applications system at one time and you can generate reports for either group or for subgroups of these two organizational structures.

Organization structures are made up of nodes that are arranged in a tree structure. There is a single *root node* at the top of each organizational structure. *Leaf nodes* (nodes that have no child nodes) for each organizational structure are defined by the type of the structure—for example, each leaf node of a User ID organizational structure corresponds to a user ID. The nodes between the root node and the leaf nodes are known as *intermediate nodes*. There can be an arbitrary number of intermediate levels in each organizational structure, and multiple intermediate nodes can have the same name, as long as they have different parent nodes. (For example, there could be Engineering nodes beneath each of the Japan, Australia, and Germany nodes.) A leaf-level node could have an intermediate parent node of any level. A leaf node cannot have another leaf-level node as a parent. A leaf-level node cannot have more than one parent node on the same date. Leaf nodes on the same level must be unique. (For example, there cannot be two Smith leaf nodes beneath Germany's Engineering node.)

You can define user—, project— or host-based organizational structures using the **Add Organizational Structure** page, or you can define the organizational structures in an XML file and import the file. After creating an organizational structure, you can import organizational-structure data from an LDAP domain.

To view a list of your enterprise's organizational structures, use the Organizational Structures page.

The **Organizational Structures** page (available from the **Reporting** tab) displays a list of all of the organizational structures that have been created using FlexNet Manager for Engineering Applications or imported using an XML file (or a CSV file, for virtual organizational structures). The Organizational Structures list provides the following information about your organizational structures.

The Organizational Structures list contains the All Users organizational structure, which is the default (and empty) user organizational structure provided by FlexNet Manager for Engineering Applications. When you run the aggregation for the first time, the aggregation process brings unassigned users into the FlexNet Manager for Engineering Applications system. You can assign these unassigned users to this (or to another) organizational structure.

 - Select the Enable aggregation... checkbox.
 - **b.** Using the **Vendor Daemons** options boxes, select the vendor daemons for which you want to enable hybrid aggregation.

- 3. Click **New Organization** to display the Add Organization page.

Adding Leaf Nodes (Users, License Server Hosts, and Projects)

In the hierarchy of an organizational structure, leaf nodes are the end nodes—they have no child nodes. Depending on the organizational structure type, the leaf nodes may be users, license server hosts, or projects. For example, if you create an organizational structure with the type User ID, the leaf nodes in the structure's hierarchy are users.

You can add leaf nodes manually or assign unassigned leaf nodes in FlexNet Manager for Engineering Applications.



Task To add a leaf node to an organizational structure:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. Click the name of the organizational structure to which you want to add a leaf node.
- 3. Depending on the organizational structure type, click the **New User**, **New License Server Host**, or **New Project** link (in the upper-right corner). This displays the **Add User**, **Add License Server Host**, or the **Add Project** page.
- 4. Specify the leaf node settings. Required settings are identified by a red asterisk (*).

Setting	Description
User ID License Server Host ID Project Name	Name or ID for the leaf node.
Parent Organization	Click Select to display the Select Organization dialog, where you can select the parent node for this organization node. All non-leaf nodes are displayed.

Additional optional settings may be available, depending on the type of leaf node.

In the hierarchy of an organizational structure, leaf nodes are the end nodes—they have no child nodes. Depending on the organizational structure type, the leaf nodes may be users, license server hosts, or projects. For example, if you create an organizational structure with the type User ID, the leaf nodes in the structure's hierarchy are users.

You can add leaf nodes manually or assign unassigned leaf nodes in FlexNet Manager for Engineering Applications.



Task To assign an unassigned leaf node:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. Click the name of the organizational structure to which you want to assign an unassigned leaf node.
- 3. Depending on the organizational structure type, click the Assign Unassigned Users, Assign Unassigned Hosts, or Assign Unassigned Projects link (in the upper-right corner). This displays a list of the unassigned leaf nodes, if there are any.
- 4. From the Unassigned Nodes list, select unassigned nodes to assign them to the organizational structure.
- **5.** To specify a parent node:
 - a. Click Select in the "Assign to" field.
 - b. In the Select Organization dialog that appears, expand the structure to find the parent node that you want.

Hybrid Organizational Structures

Your enterprise may need to provide usage data for an organizational structure, where the data is specific to the licenses served from an individual license server. To do this, you need usage data that is aggregated for the organizational structure and for the license server. You can use *hybrid organizational structures* to do this, for user-based organizational structures.

When you create a hybrid organizational structure (or update an existing organizational structure to be a hybrid organizational structure), you enable the organizational structure for hybrid aggregation that is based on the vendor daemons you select. FlexNet Manager for Engineering Applications aggregates the data by organizational structure and by license server.

To create a hybrid organizational structure, you enable aggregation by license server, then specify the vendor daemons for which you want FlexNet Manager for Engineering Applications to aggregate usage by license server. Usage for vendor daemons that are not identified in the hybrid-organization definition will be aggregated as usual. (That is, usage data by license server will not be available unless a vendor daemon is specified in the hybrid-organization definition.)

You can enable hybrid aggregation for both standard user-based organizational structures and for virtual organizational structures.

Use Case: Providing Multi-Dimensional Usage Data to a Vendor

For example, a vendor might want to see usage data for your Geographic organizational structure, for the AcmeCo (vendor daemon: acmeco) features served by License Server 1. To do this, you would carry out the following steps:

- 1. Create a hybrid organizational structure (or enable hybrid aggregation for an existing organizational structure).
- 2. Add vendor daemon acmeco to the Selected vendor daemons list for the organizational structure.
- Run one of the historical feature reports that is supported for use with hybrid organizational structures. See the topic, Using Hybrid Organizational Structures in Historical Feature Reports, for a list of reports.
- 4. In the License server prompt for the report, select Specified license server, then License Server 1.
- 5. Run the report.

Using Hybrid Organizational Structures in Historical Feature Reports

After you have created hybrid organizational structures, you can select the hybrid organizational structures in the historical feature reports that are available in Flexera Analytics 2018 R1 reports. This enables you to report on feature usage by both organizational structure and license server. (The report will prompt you to select a license server after you select the vendor daemon and the features on which you want to report.)



Important • You must run aggregation if you have added new vendor daemons to FlexNet Manager for Engineering Applications. Vendor daemons will not appear in the vendor daemon list until aggregation is complete. Also note that adding a large number of vendor daemons for hybrid aggregation may result in longer aggregation times.

Creating Hybrid Organizational Structures

A hybrid organizational structure is one in which selected vendor daemons are enabled for hybrid aggregation—where usage is aggregated by organizational structure and by license server. You can create a new hybrid organizational structure, or modify an existing organizational structure to enable hybrid aggregation.



Note • You can enable hybrid aggregation only for user-based organizational structures.

Creating New Hybrid Organizational Structures



Task To create a new hybrid organizational structure:

- **1.** From the **Reporting** tab, under **Organizational Structures**, click **Create Organizational Structure**. This opens the Add Organizational Structure page.
- **2.** For **Organizational Structure Type**, select **User ID**. (Hybrid organizational structures are available only for user-based organizational structures.)
- In the Organizational Structure Name box, provide a unique, descriptive name for your organizational structure.
- **4.** Define the levels for the organizational structure. For each level:
 - a. Type a descriptive level name.
 - b. Click Add Level.
- 5. Click the **Enable aggregation...** checkbox.

- **6.** In the selection box, move the vendor daemons you want to select to the **Selected vendor daemons** box. To select multiple vendor daemons at one time, hold down the **Ctrl** key while selecting items.
- 7. Click Save.

The selected vendor daemons will appear at the bottom of the **View Organizational Structure** page for the organizational structure.

Modifying Existing Organizational Structures for Hybrid Aggregation



Task To modify an existing organizational structure to make it a hybrid structure:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. In the list of organizational structures, click the name of the organizational structure for which you want to enable hybrid aggregation. This opens the **View Organizational Structure** page for that structure.

At the bottom of this page, you can see any vendor daemons that have been enabled for hybrid aggregation (in the **Vendor Daemons** list).

- 3. Click the Edit Organizational Structure link.
- 4. Click the Enable aggregation... checkbox.
- 5. In the selection box, move the vendor daemons you want to select to the **Selected vendor daemons** box. To select multiple vendor daemons at one time, hold down the **Ctrl** key while selecting items.
- 6. Click Save.

Virtual Organizational Structures

A virtual organizational structure is an ad hoc, user-based organizational structure that you can create for specific—often temporary—reporting use cases. You can use virtual organizational structures to combine usage for users that belong to multiple organizational structures—for example, users who are part of a functional department *and* a specific geographic location.

You create virtual organizational structures by importing a CSV file containing the organizational-structure definition. (See the topic, Creating Virtual Organizational Structures, for information about creating virtual organizational structures.)

To allow for easy organizational-structure definition, virtual organizational structures have only two levels when they are created: a top level (root node) and a leaf level (users). You can modify an existing virtual organizational structure via the FlexNet Manager for Engineering Applications user interface.




Figure 5-24: Diagram of a virtual organizational structure

Limitations

Virtual organizational structures have the following limitations:

- There is no LDAP integration for virtual organizational structures.
- Virtual organizations cannot be modified or updated via CSV import. If you attempt to import the same CSV file more than once, it will trigger an exception. You can modify a virtual organizational structure via the FlexNet Manager for Engineering Applications user interface.

Enabling Virtual Organizational Structures for Hybrid Aggregation

You can enable virtual organizational structures for *hybrid aggregation*—multi-dimensional aggregation where usage data is aggregated on the basis of organization *and* license server. (See Hybrid Organizational Structures for information.)

Creating Virtual Organizational Structures

To create a virtual organizational structure, do the following:

- 1. Create a CSV (comma-separated values) file that defines the virtual organization structure.
- 2. Import the CSV file using the organizational-structure–import functionality available in FlexNet Manager for Engineering Applications.

CSV File Structure for Defining Virtual Organizational Structures

The file must contain a unique organization name and a comma-separated list of user IDs. You can have any number of user IDs on a single line. There is a single, unique parent or root (specified using the keyword **Organization name**) for all of the leaf nodes (user IDs).



Important • The keyword **Organization name** must be spelled exactly as shown. The string that follows the keyword **Organization name** represents the name of the root node.

The following shows the format for a virtual organization structure named *Engineering Germany*, that contains several users.

```
Organization name: Engineering Germany userID1, userID2, userID3, userID4, userID5, userID6
```

Importing this CSV file into FlexNet Manager for Engineering Applications will create a virtual organizational structure with a root node of Engineering Germany. The second level of this virtual organizational structure will contain six users: userId1, userId2, userId3, userId4, userId5 and userId6.

Importing the CSV File to Create a Virtual Organizational Structure

You import a CSV file to create a virtual organizational structure. Importing a virtual organizational structure is the same as importing an organizational structure using an XML file. The file extension (.csv) tells FlexNet Manager for Engineering Applications that this is a virtual organizational structure.



Task To import a virtual organizational structure, using a CSV file:

- 1. From the Reporting tab, under the Organizational Structures section, click Organizational Structures.
- Click the Browse button in the upper-right part of the page and browse to the CSV file that contains your definition for the virtual organizational structure.
- 3. Click Import.



Note • Virtual organizations cannot be modified via CSV-file import. If you attempt to import the a CSV file containing the same organization name as a previously imported file, it will trigger an exception. You can modify a virtual organization via the FlexNet Manager for Engineering Applications user interface.

Custom User Attributes

You can use custom user attributes in your user-based organizational structures. These custom attributes enable you to provide additional information for users that you add to your <u>organizational structures</u>—whether you add the users manually or via LDAP import. These custom user attributes can be used, for example, to identify contract employees working within your organization.

These custom user attributes can be used in reporting. You can also use the custom attributes when adding user-based organizational structures using XML. See Sample XML: User Organizational Structure for the syntax.

Providing User-Friendly Custom User-Attribute Names

You can provide user-friendly names for the custom user attributes using the **Custom User-Attribute Names** page. After you update the user-attribute names, the names that you provide are used on the **Add User** and **LDAP Domain Association and Mapping** pages.



Note • If you use XML to add or update a user-based organizational structure, you must use the syntax provided in the example, Sample XML: User Organizational Structure, to specify custom user attributes: custom1, custom2, and so on. The user-friendly names you provide using the **Custom User-Attribute Names** page are used in the FlexNet Manager for Engineering Applications user interface, and are not for use in XML.



Task To define custom user attributes:

- 1. From the **Reporting** tab, under the **Organizational Structures** section, click **Custom User-Attribute Names**. This opens the **Custom User-Attribute Names** page.
- 2. In the text boxes, type or edit the names you want to use for the custom user attributes. (You can provide up to 13 custom user-attribute names.)
- 3. Click Save.

Editing Leaf Nodes

Using the Edit User/Edit License Server Host/Edit Project page, you can change the parent node for the leaf node and provide a new start date for the parent-leaf node relationship.

Task To edit a leaf node:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. Click the name of the organizational structure for which you want to edit a leaf node. This displays the View Organizational Structure page.
- 3. Click the leaf node name to display the Edit page for the leaf node.
- **4.** Edit the settings as necessary. Click **Select** in the Parent Organization field to select a new parent organization for this leaf node.

Viewing and Deleting Parent Node Relationships

You can view the history of the relationships between the parent node and intermediate or leaf nodes. For a particular node, the History dialog shows the displays all of the parent relationships for the node, along with the start and end dates for each relationship. This provides a history of transitions for a particular node and can be useful if you need to correct a mistake that was made moving a node between parents. You can delete a relationship using the History dialog and re-add the node as necessary.



Note • To add and work with organizational structures, the user must also have a role with the View and Manage Org Structures permission.

Example

Suppose that node **n1** was a child of parent **p1** from January 1, 2010, through February 1, 2010. Then the node **n1** was moved to parent **p2** on February 1, 2010. In this example, the relationship history would be displayed as follows.

Table 5-17 •

Name	Parent	Start Date	End Date	
n1	p1	Jan 1, 2010	Feb 1, 2010	Delete
n1	p2	Feb 1, 2010		Delete

When deleting relationships, note the following:

- For intermediate nodes, if there is more than one row (showing more than one relationship), no Delete link is displayed. History cannot be deleted for the past for intermediate nodes; only for relationships scheduled to commence in the future.
- When you delete the last row in history, the node moves back to the parent in the row immediately preceding the deleted row. and the end date for that row no longer contains a date.
- If you delete the first row in history, all other rows are deleted and the node is moved to the unassigned pool.



Task To view and delete parent node-leaf node relations:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. Click the name of the organizational structure to display the View Organizational Structure page.
- For the node whose relation with the parent you want to view, click History.

Importing Organizational Structure XML Files

You can define organizational structures using an XML file, then import the XML file into FlexNet Manager for Engineering Applications. The organizational structure can then be viewed and edited using the FlexNet Manager for Engineering Applications interface.

You can import organizational structure XML files in two ways—using the **Import** button on the Organizational Structures page in the FlexNet Manager for Engineering Applications interface and using the command-line utility flexnet importorgstructure.

To import organizational structure XML files, a user must have a role with the Import Org Structures from Command Line permission.



Note • Because importing large files from the Organizational Structures page may take a significant amount of time, it is recommended that you use command-line import if the organizational structure XML file is larger than 150 MB.

Importing from the Organizational Structures Page



Task To import an organizational structure XML file from the Organizational Structures page:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. In the **Location** field, type the path or click **Browse** to navigate to your XML file.
- Click Import.

Importing from the Command Line Using flexnet importorgstructure



Task To import an organizational structure XML file at the command line:

- Ensure that FlexNet Manager for Engineering Applications Admin and FlexNet Manager for Engineering Applications Reporting are running.

Defining Organizational Structures Using an XML File

FlexNet Manager for Engineering Applications provides the XML schema for the organizational structure orgStructure.xsd and sample XML files in the FlexNet Reporting installation directory at \site\samples. The schema ensures that an organizational structure contains only one type of entities (leaf-nodes)—that is, a host organizational structure can never contain users or projects.

The organizational structure schema enables you to contain one or more structures in a single XML file at the time of import. The organizational structures can be one of three types—userOrgStructure, hostOrgStructure, or projectOrgStructure. The userOrgStructure can contain at least one or more userOrgNodes or one or more users. The userOrgNode should contain at least one more user or one or more userOrgNode as its child. The hostOrgStructure and projectOrgStructure have a similar hierarchy.

In an organizational structure, the leaf nodes (users, hosts, or projects) can be grouped into organization nodes (for example, userOrgNode), which could be grouped under other OrgNodes or the OrgStructure. The organizational structure is associated with a start date (startDate). Reports could be run for leaf nodes, organization unit nodes or structures. The organizational structure is validated to ensure that a child node would never have more than one parent at a time.

You can include up to 13 custom user attributes in the XML for a user-based organizational structure. To include a custom user attribute, use the following format—

```
customn="value"
```

—where *n* is the custom attribute number. For example, you might use a custom attribute (*custom1*) to identify a contractor's company affiliation and another custom attribute (*custom2*) to indicate whether an employee is working remotely or in-house:

```
custom1="ContractCo"
custom2="remote"
```

In the FlexNet Manager for Engineering Applications user interface, you can provide user-friendly names for the custom user attributes using the **Custom User-Attributes Names** page. Note that you must use the format custom*n* to specify custom user attributes in the XML file, even if you have provided user-friendly names for the attributes.

Updating Organizational Structures Using XML

An organizational structure can be updated to have additional nodes, delete nodes and move nodes from one parent to another by modifying and re-importing the organizational structure. The update is always done incrementally and cannot retroactively change an organizational structure. In the cases where the organizational structure is modified and needs to be taken back to a previous state at the previous time, it is recommended to delete a structure and re-import.

You can re-use a previously imported XML file to create an updated organizational structure. (Note that the isnew flag has been deprecated. The flag must be present in the XML file, but the value is not processed.)

Organizational structures can be updated to add a node that was previously deleted, as long as the start date for the node being re-added is not prior to the end-date for the same node. While updating the organizational structure, it is validated to ensure that no child node exists prior to its parent node. The best way to ensure the changes made to the structure are valid is to provide an appropriate start-date for a structure. The start-date for a structure can never be in the past.

Another key consideration with regard to updating an existing organizational structure is that the names of the existing nodes must remain the same. If a node is renamed, FlexNet Manager for Engineering Applications treats the two nodes as two different nodes belonging to different time periods.

Running Report Data Aggregation After XML Import

When updating an organizational structure using XML, you can delete any leaf node. However, the deleted nodes are not moved to the unassigned pool immediately after the update. After updating an organizational structure using XML, you must run the report data aggregation process. The aggregation process moves deleted leaf nodes that had usage data, to the unassigned pool.

Importing Organizational-Structure Data from LDAP

FlexNet Manager for Engineering Applications enables you to import the organizational and user data for an organizational structure from a defined LDAP domain. Prior to importing the LDAP data, you must associate the organizational structure with an LDAP domain, and map the domain attributes to specific levels in the organizational structure. You must import report logs before importing data from LDAP.

LDAP Data Import Process

The process for importing organizational-structure data from LDAP is as follows:

- 1. Create an organizational structure. Only one mapping can be defined per organizational structure.
- **2.** Define any custom user attributes that you require. Custom user attributes enable you to provide user information that is specific to your enterprise.
- **3.** Add an LDAP domain association and map domain attributes to levels in the organizational structure, then test the mapping for a specified user.
- 4. Import report logs. The LDAP import will import only the users found in previously imported report logs.

5. Import LDAP organizational-structure data on demand or set up a schedule for LDAP data import using the Periodic Aggregation scheduler.

After LDAP data is imported, the attribute–organizational structure mapping cannot be changed. You can, however, change the user attribute mappings.

You can associate organizational structures with LDAP domains and define attribute mappings using the **LDAP Association and Mapping** page.



Note • Use the **Custom User-Attribute Names** page to define any custom attributes that you require. These custom user attributes enable you to provide and map to user information that is specific to your enterprise.



Task To map LDAP attributes to organizational structure levels:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. If necessary, add an organizational structure. (Only one mapping can be defined per organizational structure.)
- Select the checkbox to the left of the organizational structure to which you want to add the LDAP association, and click the Add LDAP association button (at the top of the page). The LDAP Domain Association and Mapping page is displayed.
- 4. From the **Domain** list, select the domain from which you want to import organizational-structure data.
 - If you select a new domain from the list after completing some of the mapping, the attribute mappings will be reset
- 5. In the **Attribute Retrieval User ID** field, specify the LDAP user ID that you want FlexNet Manager for Engineering Applications to use to retrieve the attribute list, then click **Retrieve Attribute List for User**.
 - This populates the mapping sections of the page using the specified user's LDAP attributes.
- 6. In the Attribute-Organizational Structure Mapping section, map the LDAP attributes to the organizational structure levels. The first level (Level 1) will be the name of the organizational structure with which you are associating the LDAP domain. The last level should be user names (leaf nodes of the organizational structure).
 - After LDAP data is imported, this attribute-organizational structure mapping cannot be changed. (This section will be displayed as view only.)
- 7. In the **User Attribute Mapping** section, map the user attributes.
- 8. To test the mapping, specify a user ID in the User ID field, then click Test mapping for selected user.

The mapping test shows the attribute data for the specified user to the right of the Level mapping menus (in the **Attribute - Organizational Structure Mapping** section).

9. Click Save mapping.

You can import LDAP data on demand by clicking the **Import LDAP Data** button from the **Organizational Structures** page.

To import LDAP data on a schedule, you can use the Periodic Aggregation scheduler to import organizational-structure data from LDAP prior to aggregating report log data.



Task To import LDAP organizational-structure data:

- 1. From the Reporting tab, under Organizational Structures, click Organizational Structures.
- 2. Click the checkbox in to the left of the organizational structure for which you want to import LDAP data, then click **Import LDAP data** (at the top of the page).



Note • If the organization has no domain association, you will need to add an LDAP association.

3. In the **Import Data from LDAP Domain** dialog box, specify a start date for the organizational structure, then click **Import now**.

Reporting on Usage By Project

Using organizational structures, you can enable reporting by project. This way, you can see the usage of software products by various project teams in your enterprise.

Setting the LM_PROJECT Environment Variable

In order to enable reporting by project, all users working on the same project must set the environment variable *LM_PROJECT* to a string that describes the project. FlexNet Manager for Engineering Applications groups usage by project, as defined by what *LM_PROJECT* was set to when the application was run.

Tiers

Autodesk licenses its applications as individual features, and groups those applications into tiers. Each application tier has a set price that can differ from other tiers.

To provide reporting based on tiers rather than features, FlexNet Manager for Engineering Applications provides functionality that enable you to group features (Autodesk applications) into tiers for aggregation purposes, and to run reports on those tiers.

This functionality is available from the **Tiers** section, which is under the **Reporting** tab in the user interface.



Task The basic process for reporting on tier-based usage is as follows:

- **1.** Turn on Tiers functionality to display the **Tiers** tab in the FlexNet Manager for Engineering Applications user interface. The **Tiers** tab is displayed when both of the following conditions are true:
 - The Tier-Based Reporting System Configuration option must be selected. (This option is available from the Admin tab, under System Configuration, then Reporting.)
 - If the Tier-Based Reporting option was not selected, you must log out and log back in to FlexNet Manager for Engineering Applications after selecting the option, to be able to see the Tiers tab.
 - To work with tier functionality, a user must have a role with the appropriate permission level.
 - To manage tiers from the FlexNet Manager for Engineering Applications user interface, a user must have a role that has the View and Manage Investment Planner permission.
 - To import tiers from the command line, a user must have a role that has the Import Products and Contracts from Command Line permission.
- 2. If the usage data is not already in FlexNet Manager for Engineering Applications, bulk-import the report log data that contains information about tier-based usage.
- **3.** Create tiers—in one of the following ways:
 - Importing Tier Definitions Using XML—This is the recommended way to add tier definitions. You can import tier definitions from the command line or from the **Tiers** page in the user interface.
 - Adding Tiers Using the Add Tier page—You can define tiers using the Add Tier page in the FlexNet
 Manager for Engineering Applications user interface.
- 4. Run (or re-run) aggregation. You need to re-run aggregation in the following cases:
 - · One or more tiers has been deleted.
 - You have imported tier definitions, either using the **Import Tiers** button on the **Tiers** page or by importing the definition file at the command line.
- **5.** Run usage reports. See Reporting on Tier-Based Usage for descriptions of the predefined reports that are specific to tier-based usage.

A feature can be part of only one tier.

Importing Tier Definitions Using XML

You can use define tiers in FlexNet Manager for Engineering Applications by importing an XML file containing the tier definitions. The import can be initiated in two ways:

- From the command line
- Using the Add Tiers page

Importing tier definitions is the recommended way to create tiers. Your vendor typically will provide you with a predefined XML file that you can import. After importing the XML file, you can use the Edit Tier page in the FlexNet Manager for Engineering Applications user interface to make incremental changes to your tier definitions.



Important • The XML file must contain a complete list of tier-feature definitions. The import will delete all previously created tier definitions from FlexNet Manager for Engineering Applications. You will need to run aggregation after importing the definitions.

To view help for this utility, run the command:

flexnet importtiers help

You can manually create tiers using the Add Tier page in the FlexNet Manager for Engineering Applications user interface.

The lists of vendors and features displayed in the Add Tier page are populated after aggregation has been run.



Task To add a tier using the Add Tier page:

- 1. From the Reporting tab, under Tiers, click Create Tier to display the Add Tier page.
- 2. In the **Tier Name** field, type a unique name for this tier.
- 3. In the **Cost** field, type an optional cost. This must be an integer.
- **4.** In the **Step 1** box, select one or more vendor daemons to display their features in the Step 2 box on the right. To select multiple vendor daemons, hold down the **Ctrl** key while selecting vendor daemon names.
 - After you have selected the vendor daemons, click the arrow key to display the vendor daemons' features. You can add features from different vendor daemons to the same tier.
- 5. In the **Step 2** box, select the features that you want to add to the tier. Features that appear in gray text belong to another tier and cannot be selected. (A feature can belong to only one tier.) To select multiple features, hold down the **Ctrl** key while selecting feature names.
- After you have selected the features that you want to add to the tier, click Add to Tier.
- 7. Click Save. The tier now appears in the Tiers list.

Select the check box in front of the tier you want to delete and click **Delete**. To delete all tiers, select the check box in the top row, to the left of the Tier Name column label, then click **Delete**.

Report Logs

Report log files contain feature usage information and are generated by vendor daemons. However, a vendor daemon does not write report logs by default; this action must be enabled. The data in report logs is compressed and authenticated and is used only by FlexNet Manager for Engineering Applications Reporting.

In the Report Logs page, you can view information for report logs that have been imported into FlexNet Manager for Engineering Applications; the following information is displayed.

- Status—Aggregating, Importing, Failed, or Complete—The value in the Status column indicates whether the
 report log is in the process of being aggregated, is in the process of being imported, the import has failed, or
 the import process is complete.
- Vendor daemon name
- · License server host name
- Start and end date of the log
- Original file name
- File size



Task To view report logs that have been imported into FlexNet Manager for Engineering Applications:

- 1. From the Reporting tab, under Report Logs, click Report Log Summary.
- 2. Select the report log and click the **Download** button. FlexNet Manager for Engineering Applications provides the report log in a .zip file and asks whether you want to open the .zip file or save it.

Report Logs

Click the **Delete** button for a report log to remove it.

Select multiple report logs for delete or download by selecting the check box to the left of the Status heading.



Note • A status of **Aggregating** indicates that data aggregation is in progress. Report logs cannot be deleted until the status is **Complete**.

You can import a report log using this page.

To rotate report logs, FlexNet Manager for Engineering Applications must know the location of the report log by reading the report log name configured in the options file. If you change this location, you must update the options file with an absolute path to the report log. For example, if the report log resides at **c:\vendors\report.rl**, then you must specify **c:\vendors\report.rl** and not **report.rl**.

Importing Report Logs

You can import an existing report log file to FlexNet Manager for Engineering Applications, so FlexNet Manager for Engineering Applications can ingest the report log data into the reporting database and use the data to create a report.



Task To import a report log:

- 1. From the Reporting tab, under Report Logs, click Report Log Summary.
- 2. In the Import Report Log field, enter the name of the report log you want to import, or click the **Browse** button to navigate to the report log.
- 3. Click Import.

The report log is immediately displayed in the Report Logs list. While FlexNet Manager for Engineering Applications is importing the log file, the Status column will display Importing. When the status changes to Complete, the import process is finished and you can use the report log data to run reports.

You may need to refresh the view (by clicking the Refresh toolbar button or pressing **F5**) to update the report log status.



Important • The maximum file size for import is 250 MB; however, importing large files may take a significant amount of time. Flexera recommends that you use the bulkimport command-line functionality to import report logs that are larger than 150 MB.

Managing (Rotating) Report Logs

As a vendor daemon runs for a period of time, the size of the report log increases. If your enterprise has a lot of license usage activity, the report log can become very large in a short period of time.

FlexNet Manager for Engineering Applications provides the ability to automatically archive the usage data from the active report log to a new archive report log file, thus flushing out the active report log file to zero bytes. This process is known as *rotating* the report log. See Report Log Administration for details about archived report logs.

You can configure a rotation schedule based on the rate at which usage data is generated. Each time the active report log is rotated, the resulting new archive file is cataloged, the usage data is loaded into the FlexNet Reporting database, and the data becomes available to report configurations.

When you schedule the report log rotation time, the time you need to specify is based on the FlexNet Manager for Engineering Applications server time, and not your local time if that is different.



Task To set up an automatic report log rotation schedule:

- 1. From the Servers tab, under Vendor Daemons, click Vendor Daemon Summary.
- 2. Click the name for the vendor daemon of interest.
- 3. Modify parameters in the Report Log section of the Configure and Manage Vendor Daemon page.
- 4. Click Save.



Note • The only usage data available to report configurations is that which has been rotated. To ensure the newest data is available for configurations, rotate the report log manually by clicking the **Rotate Report Log Now** button on the **Configure and Manage Vendor Daemon** page. Depending on your license usage, you should wait a few hours or a few days after enabling report logging before rotating the report log to allow a significant amount of usage data to accumulate.

Report Log Administration

Each time a report log is rotated, an archive report log file is copied to the machine on which FlexNet Manager for Engineering Applications resides.

 Rotated report logs are stored with unique file names on the machine on which FlexNet Manager for Engineering Applications resides. Each time the active report log is rotated, a new archive file is created. • Report log archives accumulate to a sizable quantity over time on the license server machine. Consider deleting older archive files that are no longer needed.

On the FlexNet Manager for Engineering Applications Admin machine:

- 1. The report log is copied in preparation for loading to the FlexNet Manager for Engineering Applications Reporting database.
- 2. FlexNet Manager for Engineering Applications validates the report log file to verify that the:
 - File can be read.
 - Log header exists.
 - Header has a hostname.
- **3.** A catalog entry is made in the FlexNet Manager for Engineering Applications Reporting database. The entry includes the following information:
 - File name
 - Host name
 - File size
- **4.** Usage data contained in the report log is parsed and loaded to the FlexNet Manager for Engineering Applications Reporting database.
- **5.** Report log metadata—containing, for example, feature names which are used to populate menus in the Report Configuration pages—is loaded to the FlexNet Manager for Engineering Applications Reporting database.
- **6.** The usage data contained in the FlexNet Manager for Engineering Applications Reporting database is available to report configurations.



Note • A copy of the report log is also retained on the FlexNet Agent machine in the data directory for the FlexNet Agent installation.

FlexNet Manager for Engineering Applications archive logs are stored on the license server machine with file names of the format:

<server_name>-<vendor_name>-yyMMddhhmmss-<sequence_number>.rl

Table 5-19 • Report Log Name Components

Component	Description
<server_name></server_name>	Name of the license server host.
<pre><vendor_name></vendor_name></pre>	Name of the vendor daemon.
yyMMddhhmmss	Timestamp (in 24-hour format) corresponding to the time at which the report log is rotated by the vendor daemon, local to the system that originally created the report log.
<sequence_number></sequence_number>	A running sequence number that the FlexNet Agent appends to the file name to ensure uniqueness if the report log is rotated twice within the same second.

For example, consider the archive report log with the name:

TestLicenseServer1-avend10-150910104137-401.rl

This file was written on September 10, 2015 at 10:41:37 by the vendor daemon avend 10 on the license server TestLicense Server 1.

Enabling Report Logging

Each report log that FlexNet Manager for Engineering Applications processes must contain usage data written by a single vendor daemon running on a single machine. Therefore, to enable report logs whose data can be loaded into the FlexNet Reporting database for report processing, you must enable report logging for each instance of a vendor daemon.

To enable reporting for a vendor daemon, you must include the keyword REPORTLOG in the vendor daemon's options file, and specify the path to the report log file. You can edit a vendor daemon's options file from the FlexNet Manager for Engineering Applications user interface. See Options Files: Passing Instructions to Vendor Daemons for more information.



Task To enable report logging:

- 1. From the Servers tab, under Vendor Daemons, click Vendor Daemon Summary.
- 2. Click the name link of the vendor daemon for which you want to enable logging. This displays the Configure and Manage Vendor Daemon page.
- 3. Click **Edit Options File** to display the Edit Options File screen. Here you can modify directly the content of the vendor daemon's options file.
- **4.** In the options file text box, type the following:

REPORTLOG +<path_to_report_log_file_name.rl>

Specify the full path to where you want FlexNet Manager for Engineering Applications to write the report log, including the file name. The report log file must have the file extension .rl. FlexNet Manager for Engineering Applications adds the line to the vendor daemon's options file.

The leading "+" character tells the vendor daemon to append to the specified file each time it starts, rather than clearing and overwriting the file. There is no space after the "+" character. If you do not include the "+" character, a new report log will overwrite the existing report log file.

- 5. Click Save, then click Reread License Files.
- 6. In the Log Rotation Scheduling section, indicate whether you want to rotate the report log on a scheduled basis.
 You can rotate the report log manually by clicking the Rotate Report Log Now button.

7. Stop and restart the vendor daemon for the changes to take effect, by clicking the **Stop Daemon** and then the **Start Daemon** buttons.

FlexNet Manager for Engineering Applications adds the options file path to the VENDOR line in the license file. For example:

VENDOR vendor options=options_file_path

Redundant License Server Configurations

The options file and license files for each license server in a redundant license server configuration must be set up in order for report logging to continue when the master changes. If a master license server goes down, the new master reads its license and options files and writes to its own report log. Additionally, each vendor daemon in the configuration must write to a separate report log.

Bulk Importing Existing Usage Data

To import existing usage data, use the bulkimport command of the <code>flexnet_man_dir/flexnet</code> utility. This command imports report logs that you may have accumulated prior to installing FlexNet Manager for Engineering Applications.

In FlexNet Manager for Engineering Applications, the bulkimport command does the following:

- Writes a catalog entry (for each report log) to the FlexNet Manager for Engineering Applications database.
- Parses the report logs and puts the data into the FlexNet Reporting database, where FlexNet Manager for Engineering Applications can access it.

Syntax

flexnet bulkimport -uusername -ppassword -ffolder [-ccustomerid] [-sserver] [-r]
The parameters in [brackets] are optional.



Note • If the value for the -uusername, -ppassword, or -ffolder parameter contains a comma, semicolon, or ampersand (&), enclose the value in double quotes ("").

Table 5-20 • bulkimport Parameters

Parameter	Description
-uuser	Specifies the FlexNet Manager for Engineering Applications user to run this command. The user must be assigned a role with the Bulk Import Report Logs permission.

-ppassword	Specifies the password for user. For the user admin, the password is admin.

Common Report Log Definitions

FlexNet Manager for Engineering Applications provides common report log importing—available with a separate license from Flexera—which enables enterprises to define a report log format, then import those report logs into FlexNet Manager for Engineering Applications using the user interface or at the command line.

This functionality enables enterprises to import non-FlexNet (and non-LUM) report logs for usage reporting and tracking purposes. In this way, FlexNet Manager for Engineering Applications provides for comprehensive reporting across your engineering and technical application usage and enables you to do consolidated planning for your enterprise-wide software licensing needs.

Creating a common report log definition is also the first step in the process of managing a third-party license server using FlexNet Manager for Engineering Applications.

The process for working with non-FlexNet report log data is:

- 1. Create a report definition in FlexNet Manager for Engineering Applications, using functionality available from the Report Log Definitions tab.
- 2. Format your report log files properly, generate or convert them to match the formats that you have defined.
- 3. Import the properly formatted report logs using the command-line bulkimport utility or using the Import button on the Report Logs page.
- 4. Create and generate reports based on your usage data.

Report Log Definitions page

The Report Log Definitions page displays a list of all of the custom report log definitions that you have created. This page displays the following information:

- Name of the report log definition.
- · License system for which this report log definition was created.
- File extension of the report log to be imported.

From this page, you can delete existing report log definitions and move to the Add Report Log Definition or the Edit Report Log Definition pages.

Creating Report Log Definitions

To enable FlexNet Manager for Engineering Applications to report on non-FlexNet license usage, you create report log definitions that describe the structure of the usage events. FlexNet Manager for Engineering Applications uses this definition to parse usage event data contained in report logs when they are imported.



Task To add a report log definition:

- **1.** From the **Reporting** tab, under **Report Log Definitions**, click **Create Report Log Definition** to display the Add Report Log Definition page.
- 2. In the top section, provide the following information. Required settings are identified by a red asterisk (*).

Setting	Description
Name	Unique name for the report log definition.
License System	The license system for which you are creating this report log definition. Choose one of the predefined options or choose a Custom option if the license system is not listed.
	After you choose a license system for a report log definition, the license system option is removed from this list and cannot be used for future report log definitions.
File Extension	The file extension that is used for the report logs.
	FlexNet Manager for Engineering Applications uses the file extension to determine which report log definition it must use to parse the report log file when it is imported.
Delimiter	Specifies what is used to delimit data contained in the report log file.
	The maximum delimiter size is five.
Each Item Value Double Quoted	Select this check box if all of the item values in the report log are in double quotes. Values must be in double quotes if any of the values in the report log contain delimiters. This includes values in the header, feature list, usage events section, and footer.
	For example, if your report logs use commas as delimiters and one of the values contains a comma, then all values in the report log must be enclosed in double quotes.
	If a value contains double quotes, it must be escaped with a backslash (\).
	 For optional items, if the values do not exist, double quotes with empty values are required.
	See Formatting Common Report Log Files for information on how the report log file must be formatted. See Common Report Log Examples for an example.

Setting	Description
Event Matching Rule	Specifies how FlexNet Manager for Engineering Applications should match license-grant and license-release events in the report log.
	• Duration —Matches the value (license-grant timestamp minus duration) to the license-release timestamp of events that have the same feature name, feature version, user name, and user host, to determine whether the events match. If you choose Duration, you must specify a column number for the Duration property (in the Properties section).
	• Transaction ID —Matches license-grant and license-release events where the transaction ID is the same. If you choose Transaction ID, you must specify a column number for the Transaction ID property (in the Properties section).

3. In the Usage Event Data section (bottom of the page), specify where usage event data is located in the report log file. To do this, specify the Column Number in the report log in which the usage-event property's value is contained. The listed properties will be imported to FlexNet Manager for Engineering Applications (if they exist in the report log file); all other properties contained in the report log file are ignored.

For some properties, additional information about how the value is formatted in the report log file is required. Provide this information in the "Format of Data in Report Log" field. Required settings are identified by a red asterisk (*). Click the sample links at the top of the section to view examples.

Most properties are self explanatory; however, some require you to identify how the information is formatted or identified in the report log:

• Date/Time n—In the report log file, the date/time must be expressed in GMT. In the "Format of Data in Report Log" field, specify the format of the date and time using Java patterns. At minimum, Date/Time 1 is required, but if the license event's date/time information spans multiple columns, you can specify which columns contain which date/time information by using multiple Date/Time fields.

• Event Type—Specify the value used to indicate whether a license event is a license grant (or check-out), a license release (or check-in), or a denial. If you have multiple event types that indicate license grant or license release (for example, if one event type indicates a borrowed license), you would convert all license grant and release events to be simple license grant and release events, then use the Reason ID field to indicate the nature of the event.

For example, you might have event type 1 as a license grant and event type 5 as a borrowed license grant. When you generate your report logs, you would map event type 5 to event type 1, but specify a reason ID for borrowed license grants in the license event (and specify the Reason ID column when creating your report log definition). When FlexNet Manager for Engineering Applications parses the data for that license event, it looks at the Reason ID column to determine whether the license grant is a simple license grant or a borrowed license grant.

 Number of Licenses—The number of licenses involved in the usage event—checked out, checked in, or denied.

In the report log file, this value must be a positive integer.

• **Duration**—If you chose "by Duration" for the Event Matching Rule setting, you must specify the column number of the Duration property.

In the report log file, this value must be a positive integer that specifies the duration in seconds.

- Transaction ID—If you chose "by Transaction ID" for the Event Matching Rule setting, you must specify the column number of the Transaction ID property. In the report log file, this value must be a positive integer.
- Reason ID—This property is used in conjunction with license grant (checkout) or license denial events. In the report log file, this value must be one of the Reason ID numbers provided in the following table.

Reason ID	Description
3	Normal.
13	Borrowed.
55	No such feature exists.
60	Feature has expired.
76	Request for more licenses than this feature supports.
88	Not authorized to use this product.

- Process ID—In the report log file, this value must be a positive integer.
- 4. Click Save.

Before FlexNet Manager for Engineering Applications can process data contained in non-FlexNet report logs, you must ensure that the report logs are formatted in a way that enables FlexNet Manager for Engineering Applications to read them. Each report log must contain license event data only for a single license server and vendor daemon.

Each report log contains the following information:

- Common Report Log Header Section—Required
- Feature List with Tokens Owned (Available Count) Section—Optional
- License Events—All license event data
- Common Report Log Footer Section—Required

Common Report Log Header

The report log header is required and must be at the beginning of the report log. The first line of the header must be -Report Log Header Begin- and the last line must be -Report Log Header End-. The header defines the following items:

- Server—Name of the license server.
- Vendor—Name of the vendor daemon.
- Start Date—The start date of the report log, which can be the same as or prior to the first license event time. The format should follow the Date/Time format used in defining the report log.



Note • The End Date value of a report log file from the same license server/vendor daemon should be the same as the Start Date value of the subsequent report log file. This enables you to detect if there is any missing usage data.

Feature List with Tokens Owned (Available Count)

The feature list with tokens owned is optional and must be after the report log header. In this section, you can define the number of tokens owned (the available count) for the features in the Feature List section. The first line of the header must be -Feature List Begin- and the last line must be -Feature List End-.

In the Feature List section, each feature must be formatted as follows:

[feature name][delimiter][feature version][delimiter][tokens owned]

The delimiter is defined in the report log definition.



Note • If the report log does not contain a Feature List section or if a feature is not listed in the section, FlexNet Manager for Engineering Applications uses a token count (available count) of unlimited.

Common Report Log Footer

The report log footer is required and must be at the end of the report log. The first line of the footer must be - Report Log Footer Begin- and the last line must be -Report Log Footer End-. The footer defines the following:

• End Date—The end date of report log. It can be the same as or later than the last license event time. The format should follow the Date/Time format used in defining the report log.



Note • The End Date value of a report log file from the same license server/vendor daemon should be the same as the Start Date value of the subsequent report log file. This enables you to detect if there is any missing usage data.

Importing Common Report Logs

After you have created a common report log definition and generated or converted your report log files to align with the format you defined, you can import the report logs in one of two ways:

- From the FlexNet Manager for Engineering Applications interface, using the Import button on the Report Logs page.
- At the command line, using the bulkimport command.

At import time, FlexNet Manager for Engineering Applications uses the report log file's file extension to determine which common report log definition it must use to parse the report log file.

FlexNet Manager for Engineering Applications uses the event matching rule to determine which license events should be matched together. For the license-grant events or license-release events that do not have matching license events, FlexNet Manager for Engineering Applications uses the report log starting time (contained in the report log header) or ending time (contained in the report log footer) to complete the events.

Usage Data Maintenance

If your enterprise has used FlexNet Manager for Engineering Applications for a long period of time and/or has a high volume of usage data, you may accumulate a large amount of usage (both report log and aggregation) data. To help you manage the volume of usage data, you can delete database data that you no longer need to keep.

All usage aggregation data is stored separately in the database. Hourly usage data consumes more space than daily usage data (24 hours in one day), and daily usage data consumes more space than monthly usage data (~30 days in one month). If you delete hourly usage aggregation data, but retain daily usage aggregation data, it can free a

substantial amount of database space. However, you would still be able to run reports based on the daily usage aggregation data. This enables you to generate reports to see the usage breakdown by day, but the reports will not provide the ability to drill down to hourly usage.

Required Permissions

To view the Usage Data Maintenance tab and access the functionality available from this tab, a user must have a role with the Manage Usage Data Maintenance permission.



Task To enable usage data maintenance:

- 1. Click the **Reporting** tab, then click the **Usage Data Maintenance** tab.
- Select one of the cleanup service options and specify the number of months that you want to keep the data.Data will be removed from the database after the number of months specified.
- Click Save.

Best Practices for Usage Data Maintenance

By default, usage data maintenance is not enabled. If your reporting system has newly imported files that were never aggregated and you are unsure how many months of data you may need for reporting, it is recommended that you leave the Usage Data Maintenance settings disabled at first.

After aggregation is finished and you have analyzed your Flexera Analytics (Cognos) reports, you can specify the appropriate hourly, daily, and monthly Usage Data Maintenance settings. These three settings can have different values based on business needs—for example, your enterprise may need to retain 12 months of monthly usage data, six months of daily usage data, and three months of hourly usage data in the system.

While enabling Usage Data Maintenance, be sure to consider aggregation scheduling. When you save the Usage Data Maintenance settings, the data cleanup service will be invoked immediately. While the usage data cleanup service is running, if a scheduled or manually triggered aggregation starts, the aggregation may try to save the usage data and the data cleanup service may try to delete the usage data for the same timeframe. This could result in undesired behavior. Before running aggregation, check the reporting flexnet.log to determine whether the data cleanup service is in process.

The following example demonstrates how the aggregation process works:

- 1. FlexNet Manager for Engineering Applications builds hourly aggregation for seven days (default configuration). The input is transactional data.
- 2. FlexNet Manager for Engineering Applications build daily aggregation for the same seven days. The input is hourly aggregation.
- **3.** FlexNet Manager for Engineering Applications build monthly aggregation in a similar way, taking input from daily aggregation.

In this scenario, if you re-run aggregation for a past period of time—for example, six months from now—and you have a three-month retention policy for hourly aggregation, it may result in creating hourly aggregation for the time beyond the retention date just to support the re-aggregation for daily and/or monthly aggregation. Normally the "extra" data will be deleted later, but the best practice is to disable the usage data maintenance settings *prior* to aggregation that may overlap in time with the retention intervals.

It is recommended you define your data-retention time intervals such a way that there is a "buffer time interval" that ensures that the usage data for cleanup would not overlap with any possible usage data for reports or aggregations.

Usage Data Cleanup Service Log Messages

When running each type of data cleanup service (hourly, daily, or monthly), the following line appears in the log to indicate that the data cleanup service is running:

Starting Hourly Cleaning activity for <from-date> to <to-date>

When the data cleanup service is finished, it will log the following:

Stopping Usage Data Cleanup Service.

If the data cleanup service found no usage data, it logs the following:

Hourly cleanup activity found no data to clean up.

Mapping Generated User Names and Filtering by Application-Server Host

Usage events for some vendors result in a large number of randomly generated user names, where the user names contain appended characters and/or numbers. For example, if users access applications using a browser, the usage events are assigned randomly generated user names (user473796471_137, user1946733051_472, and so on). This causes issues because the generated user names do not appear in organizational structures, and the volume of the data impacts the organizational structure—import process.

To resolve this issue and prevent future report log–import issues, you must create an XML mapping file (vendorFeatureForRandomUser.xml) to map the randomly generated user names to fixed user names. In the XML file, you specify which vendor and feature-name combinations should map to a given user name. As a result of the mapping, you can report on consolidated usage.

In addition, you can filter which generated user names are consolidated, by the application-server host (the user host name in the usage event). That is, you can specify in another XML file, **vendorHostForRandomUser.xml**, which application-server–host names are relevant when mapping generated user names to a fixed user name.

The two XML files enable you to consolidate randomly generated user names on the basis of the following:

vendor + feature + application-server host

Mapping Generated User Names to Fixed User Names

Map randomly generated user names to fixed names to allow for consolidated reporting.



Task: To map generated user names to fixed user names:

- 1. Create an XML file with the name **vendorFeatureForRandomUser.xml**. The XML file should have the same format as the following Example XML File: Mapping Generated User Names.
- **2.** Copy the file to the user data directory. By default, this directory is located at <fnmea_install_directory>\data

At the time of report-log import, FlexNet Manager for Engineering Applications checks the XML file for any changes. If there are changes to the file (if the file has been updated), FlexNet Manager for Engineering Applications will read the file for new mappings.

Example XML File: Mapping Generated User Names

This file must be named vendorFeatureForRandomUser.xml.

Filtering the Mapping by Application-Server Host

You can refine the user-name mapping by filtering the mapping by application-server host.



Task: To filter mapping by application-server host:

- 1. Create an XML file with the name **vendorHostForRandomUser.xml**. The XML file should have the same format as the following Example XML File: Filtering by Application-Server Host.
- **2.** Copy the file to the user data directory. By default, this directory is located at <fnmea_install_directory>\data

Example XML File: Filtering by Application-Server Host

This file must be named vendorHostForRandomUser.xml.

In this case, the random user names generated by feature usage (as specified in the file **vendorFeatureForRandomUser.xml**) will be consolidated and mapped to a fixed user name *only* if the application-server host for the vendor daemon is specified in the file **vendorHostForRandomUser.xml**.

Reporting on IBM Rational Products: Mapping Features to Products

During product aggregation, FlexNet Manager for Engineering Applications automatically maps IBM token-based feature usage to product usage. (You do not need to import or create the product definitions manually.) This mapping is done using the product information provided in either the feature lines (using the VENDOR_STRING keyword), or—for JazzToken-related usage events, using information provided by a vendor-defined string (which is included in the checkout event).

IBM Rational Products (All Except JazzToken)

For all IBM Rational products (that are not JazzToken), the product name is provided in the vendor-defined string, using the keyword VENDOR STRING in the feature line.

One feature can be mapped to only one product.

Example Feature Line

- ibmrft is the capability name.
- **TLSTOK** is the feature.
- FUNCTIONAL_TESTER is the product name.
- **10** is the token cost for the feature, TLSTOK. That is, a count of 10 TLSTOK checkouts corresponds to 1 count of product usage for the product FUNCTIONAL_TESTER.

For Jazz-based products, the product name is not defined in the feature line. Instead, the product name is found only in the checkout, via a vendor-defined string in the checkout data. In the checkout data, the product-name string is surrounded by the characters #p#.

In this example:

- TLSTOK is the feature.
- Change and Configuration Management is the product name.
- JazzToken is the capability name.

Authoring and Modifying Reports to Use Hybrid Organizational Structures

You may want to create new feature-based reports—or modify existing feature-based reports—to use hybrid organizational structures. When an organizational structure is enabled for hybrid aggregation, the usage data are aggregated by multiple dimensions: by organizational structure (for example, geographic location) *and* by license server.

When you use hybrid organizational structures, you can develop Flexera Analytics reports to show usage data that is aggregated on these two dimensions. To do this, you need to author your reports (or make modifications to existing reports) to identify whether the organizational structure is a hybrid organizational structure, and, if so, to enable the report user to select a license server, in addition to an organizational structure.

When you run aggregation for a hybrid organizational structure, the aggregation process creates additional records in the database.***

If an organizational structure is enabled for hybrid aggregation, the report user can select a license server—in addition to selecting an organizational structure—during the report-configuration process. These selections (organizational structure and license server) can be used to filter the information that is shown in the report. (By default the historical-usage reports show data from *all* license servers.)***

Prompts for Hybrid Organizational Structure Reports

Typically, you author a feature-based usage report to filter the results by organizational structure. If you want the report user to select the organizational structure, you would include a value prompt to let them make the selection.

A value prompt to get the parameter to filter by organizational structure might be similar to the following:



Figure 5-25: Typical prompt for organizational structure

For this prompt, the query would use the query subject **Org Type Name** as the data item used to populate the prompt menu. The user's selection in this prompt can be used to create a parameterized filter—in this example, the organization selected will be used for the parameter **ParameterOrgStructure**. You can use this parameter to filter the data shown in the report by applying the following detail filter: [Org Type Name] = ?ParameterOrgStructure?



Figure 5-26: Data item for a typical organizational-structure prompt query

***When you use hybrid organizational structures and want report users to be able to select a license server for which they want to view data, your prompt for the organizational structure needs to collect two pieces of information about the organizational structure—the name of the organizational structure (**Org Type Name**) and the value of the **Is Hybrid** flag for the organizational structure, which indicates whether the organizational structure is hybrid or not (1 for hybrid, 0 for non-hybrid). These query subjects are part of the **Org-Feature-Product Details** namespace.




Figure 5-27: Query subjects for use with hybrid organizational structures

If you are creating a report (or modifying an existing) report to use hybrid organizations, you may want to let the user select a license server to configure and filter the report by multiple dimensions—by organizational structure (for example, by geographic organization) and by license server.

Because the data model now has two data items that must be used to identify the organizational structure - to determine whether the organizational structure is hybrid. ***

In order to get the necessary information, you need to structure your query to get three data items—**Org Type**Name, Is Hybrid, and a combined data item that concantenates the two values (here, called

OrgData_concantenate).




Figure 5-28: Organizational structure query data items

The **Org Type Name** and **Is Hybrid** query subjects are from the *** namespace. The expression for the concantenated data item is:

[Org Type Name] + cast([Is Hybrid], char(1))

This gives us the organizational-structure name with the Is Hybrid flag value appended to the end of the name string. We can parse that string later to separate the organization name from the concantenated string.

The value of this parameter can be parsed, then used to filter your report results.




Figure 5-29: Hybrid Org Filter query subjects in Feature-Org OLAP

***To display usage for all license servers, the detail filter for your query must set the License Server DB Key (Hybrid Org Filter) data item to null.

[Org Type Name] = ?ParameterOrgStructure? *** this is the report filter***

License server selection***

When you enable an organizational structure for hybrid aggregation, you select the vendor daemons for which you want to run hybrid aggregation. In your reports, you use query subjects in the Hybrid Org Details folder of the Org-Feature-Product Details namespace.

To display a list of license servers for the selected hybrid organizational structure, you can add a value prompt that cascades from the vendor-selection prompt. (Hybrid aggregation is based upon vendor selection.***) The query for this prompt uses two query subjects as data items: License Server Host Name and Vendor Name. These query subjects are located in the Hybrid Org Details folder in the Org-Feature-Product Details namespace.




Figure 5-30: Query subjects for mapping vendor daemon to license server

Within the report, you will need to parse the concantenated organizational-structure string to be able to use the name of the organizational structure to filter report data.***

To parse the Org Type Name string to get the organization name without the Is Hybrid flag appended, you can use the following expression:

substring (?ParameterOrgStructure?, 1, character_length (?ParameterOrgStructure?) - 1)

Filter Expression***

In your report query, you need to create a detail filter to filter the usage data by the license server if the user selected a license server for a hybrid organizational structure.

To do this, you will first find out whether a license-server selection was made. If the parameter for the license server value is not empty, your filter will be by the specified license server. If the parameter is empty, you need to set the License Server DB Key to NULL.***

Access Rights

Access rights determine which FlexNet Manager for Engineering Applications users are able to view and manage information pertaining to specified entities—license servers and FlexNet Agents—within the license management domain. Using functionality available under the **Access** tab, you can specify the license server sets and FlexNet Agents that a FlexNet Manager for Engineering Applications user can view and manage.

License Server Access

FlexNet Manager for Engineering Applications enables you to specify access to license servers based on the administrative needs of various users. You can group license servers into license server administrative sets, and then associate those license-server sets with specific FlexNet Manager for Engineering Applications users.

Users have access only to the information that pertains to the license servers in the License Server Administrative Set with which they are associated. For example:

- The information displayed in pages beneath the Summary, Servers, Licenses, and Activity tabs will pertain only to the license servers for which the user has access.
- License server access rights work in conjunction with alert subscription to determine which alerts are displayed when a particular FlexNet Manager for Engineering Applications user is signed in.

You can group one or more license servers in a license server administrative set. There is no limit to the number of license servers in a set.

Universal License Server Admin Set

By default, FlexNet Manager for Engineering Applications creates the **Universal License Server Admin Set**. Users with the **Super Administrator** role are able to view and manage license servers in the Universal License Server Admin Set. When a license server is registered with FlexNet Manager for Engineering Applications, it is automatically added to the Universal License Server Admin Set.

Agent Access Rights

Agent access rights provide individual FlexNet Manager for Engineering Applications users with rights to view information and manage specified FlexNet Agents. The **Agent Access Rights Management** page displays a list of the FlexNet Agents that are registered with FlexNet Manager for Engineering Applications and the users who have access rights for each agent.

When a FlexNet Agent starts up and is registered with FlexNet Manager for Engineering Applications, the FlexNet Agent is automatically associated with all FlexNet Manager for Engineering Applications users who have been assigned the Super Administrator role. This means that every user who has the Super Administrator role at the time the FlexNet Agent is registered will have access rights to information about that FlexNet Agent.

Agent access rights work in conjunction with alert subscription to determine which alerts are displayed when a particular FlexNet Manager for Engineering Applications user is signed in.

Agent Access Rights

Investment Planning

FlexNet Manager for Engineering Applications provides investment-planning functionality that enables your enterprise to analyze product-usage trends in order to forecast future product-licensing needs and license distribution for your entire organization.

Using the investment-planning functionality available from the **Planner** tab, you can map licensed features to the software products that are used in your organization. This feature-to-product mapping enables FlexNet Manager for Engineering Applications to report on product usage, in addition to feature usage. Using the product-usage reports, you can discover usage trends and use this information to optimize your product license purchases by remixing your contract pools according to the terms specified in your license contract.

Key Investment Planner Features

Key investment-planning features include:

- The ability to input and manage contractual data.
- Feature-to-product mapping to facilitate product-based usage reporting.
- Remix calculations and renewal-planning analysis to show where license re-allocation may benefit your enterprise.
- Combined with organizational structure functionality, functionality that enables you to accurately calculate chargebacks for different departments and project groups within your enterprise.

Basic Investment Planning Steps

The following basic steps are necessary to compare your enterprise's contract (licensing) data to actual product usage.

1. Add information about software producers (companies that create software products) and software vendors (companies that sell software products).



Note • The software producer and the software vendor may be the same company, if you purchased the product directly from the software producer.

- Add products to FlexNet Manager for Engineering Applications, then associate licensed features with the products.
- 3. Input contract data.
- **4.** Select the **Product Aggregation** setting in Admin | System Configuration | Reporting. This enables reporting on the products that you have defined.
- 5. Run reports to view product-based usage trends.
- **6.** Compare the usage trends shown in the reports to the entitlements specified in your contracts to determine whether you are under- or over-licensing specific software products in your enterprise.
- **7.** Run remixes to determine where your enterprise may be able to optimize licensing costs by purchasing licenses for a different mix of products.

Products

The **Products** page, available from the **Planner** tab, displays a list of the products that have been added to and/or imported into FlexNet Manager for Engineering Applications.

A software product is composed of one or more licensed features. A software producer creates a product by grouping together separately licensed features and distributing the products to its enterprise customers, along with the feature licenses.

The same feature can be used in multiple products. This practice enables a software producer to create different product tiers, where each tier contains progressively more (and/or more advanced) features. For example, a software producer may have a professional and an express version of a product, where both products include the same core features, but the professional version includes additional advanced features that are not included with the express version.

Enabling Product-Based Reporting

To enable product-based reporting in FlexNet Manager for Engineering Applications, you must do the following:

- 1. Add products.
- 2. Map those products to licensed features.
- 3. Select the **Product Aggregation** check box (available on the Admin | System Configuration | Reporting page).

Adding Products

Before you can map licensed features to a product (to provide for product-based reporting), you create a product definition in FlexNet Manager for Engineering Applications. After you add a product, you assign features to the product to provide the basis for product-level usage reporting.



Task To add a product:

- 2. Click the Add Product button.
- 3. In the Add Product page, provide the product settings. Required settings are identified by a red asterisk (*).

Setting	Description
Software Producer	Specify the software producer that makes this product or, if you have already added software producers, select one from the list.
	If the software producer does not appear in the list, type the name of the software producer in the text box. This adds the software producer to the FlexNet Manager for Engineering Applications system. The software producer will appear in both the Software Producer list (under the Products tab) and on the Software Producers page.
Product Name	Name of the software product whose usage you want to track. You will later associate licensed features with the product.
Part Number	The product's part number or SKU (shop-keeping unit).
Version	The product version.
Family	Specify a product family or choose one from the list. When you type a family name, the name is added to the Existing Families drop-down menu.
Category	Specify a product category or choose one from the list. The category typically identifies the type of product. For example, the product might belong to the EDA (electronic design automation) category. When you type a category name, the name is added to the Existing Categories drop-down menu.
Notes	Notes about the product. These are for reference only.

Importing Product Definitions

You can import product definitions contained in an XML file to populate the FlexNet Manager for Engineering Applications database. The imported products will be displayed on the **Products** page.

Product import can be done in two ways:

- Using the Products page in the FlexNet Manager for Engineering Applications interface.
- From the command line, using the importproducts command.

The XML file must contain product definitions from a single software producer. If the XML file contains a reference to a software producer that does not already exist in the FlexNet Manager for Engineering Applications system, FlexNet Manager for Engineering Applications creates the software producer.

The following XML example is from the sample file provided. The product and feature settings are the same as the settings presented in the FlexNet Manager for Engineering Applications user interface for the Add Product and Add Product Feature pages.

All settings that are required in the user interface are also required in the XML file, except for the following feature settings:

- The licenseSystem attribute is optional. Valid values are "flex" or "lum"; the default value is "flex".
- The licensesPerProduct attribute is optional. The default value is "1".

Exporting Product Definitions

From the **Products** page, you can export all product definitions to a .csv (comma-separated values) file. Adding Features to Products

A feature is a discrete, separately licensed unit of functionality. A single feature can be a part of multiple products. FlexNet Manager for Engineering Applications tracks usage by feature. To enable usage reporting by product (which are composed of one or more features), you must associate licensed features with products.

You can also use the Assign Features page to assign unassigned features to products.



Task To associate features with products:

- 1. From the Planner tab, under Products, click Products.
- 2. On the **Products** page, click the name of the product to which you want to add features.
- 3. On the bottom half of the View Product page, click the Features tab, then click Add Product Feature.

4. On the Add Product Feature page, specify the feature settings. Required settings are identified by a red asterisk (*)

Setting	Description
Vendor Daemon	Select the vendor daemon that serves the feature. The list contains all vendor daemons that are assigned to the software producer that makes this product. When you select a vendor daemon, the Feature Name list is populated with all of the features that are associated with the selected vendor daemon. If the list is empty, type the name of the vendor daemon name in the text field. Also, specify whether the vendor daemon serves features that use FlexNet or IBM LUM licensing.
Feature Name	Select the feature that you want to assign or map to this product.
	If the list is empty, you can specify a feature name in the text field. If you manually enter a feature name, the feature will be associated with the vendor daemon that is selected in the Vendor Daemon list.
Minimum Feature Version	Minimum feature version that is required for the product. This field accepts a string.
	This value can be used by the product usage aggregation process to fine-tune the association of feature usage to product usage. Some FlexEnabled (FlexNet-licensed) products specify a minimum version for the feature that is required to satisfy a checkout request.
	For example, the aggregation process may need to determine whether a checkout of version 1.0 should be included for a particular product. If the product definition requires that the minimum feature version is 2.0, then the version 1.0 checkout will not be grouped as usage for the product.
Feature Licenses Per Product License	Number of feature licenses, expressed as an integer, that are included in a single product license for the product.

Assigning Unassigned Features to Products

A feature that is not associated with a product is an unassigned feature. The **Assign Features** page displays a list of unassigned features and enables you to select features for assignment to a particular product.

The list of unassigned features is populated after you import report logs and aggregate the report log data.

Minimum Feature Version	Minimum feature version that is required for the product. This field accepts a string.
	This value can be used by the product usage aggregation process to fine-tune the association of feature usage to product usage. Some FlexEnabled (FlexNet-licensed) products specify a minimum version for the feature that is required to satisfy a checkout request.
	For example, the aggregation process may need to determine whether a checkout of version 1.0 should be included for a particular product. If the product definition requires that the minimum feature version is 2.0, then the version 1.0 checkout will not be grouped as usage for the product.

3. From the list of unassigned features, select the check boxes in front of the names of the features that you want to map to the specified product. Selected features must be from a vendor daemon associated with the software producer specified or from a vendor daemon that is not associated with a software producer.

An error message is displayed if you select a feature from a vendor daemon that is associated with a software producer different from the one specified in the top section of the page.

4. Click **Assign Selected Features**. The selected features are mapped to the product and removed from the unassigned features list.

Software Producers

In FlexNet Manager for Engineering Applications, a *software producer* is a company that makes software products that use a licensing system to control access to product functionality. The product functionality is defined in the product's features, which are licensed to your enterprise by the *software vendor*—the company that sells software. The licensing terms are defined in a contract.

The software producer may also be the software vendor—that is, the same company may both produce *and* sell its software products to customers.

Each product that you define in FlexNet Manager for Engineering Applications must be associated with an existing software producer.

Associating Vendor Daemons with Software Producers

The vendor daemon is the process that serves licenses for a particular product's features. A single software producer may have multiple vendor daemons associated with it.

Vendor daemons are automatically added to the FlexNet Manager for Engineering Applications database as needed, when report logs are imported. You associate vendor daemons with software producers to tie the usage of features—served by vendor daemons—to the usage of products, which are created by software producers.

Depending on whether the vendor daemon already exists in the FlexNet Manager for Engineering Applications database, you can:

• Assign an unassigned vendor daemon to a software producer.

Vendor daemons in the FlexNet Manager for Engineering Applications database that are not associated with a software producer appear in the unassigned vendor daemons list. If the vendor daemon that you want to associate with the software producer does not appear in the unassigned vendor daemons list, it means that the vendor daemon is not in the FlexNet Manager for Engineering Applications database.

 then deleting the vendor daemon puts it into the unassigned vendor daemon pool.

Contracts

A contract defines the terms under which you (the enterprise) purchase product licenses from a software vendor (which may be the same company as the software producer). The contract terms include the start and end dates, the fixed and variable costs of the contract, any license restrictions (for example, geographic license restrictions), and the remix rules for the contract, which define the percentage of the contract for which you can reallocate licenses.

The product licenses purchased under a contract are typically grouped together into one or more contract pools.

The **Contract Summary** page, available under the **Planner** tab, shows a list of the contracts that have been input to or imported into the FlexNet Manager for Engineering Applications system. From the **Contract Summary** page, you can delete contracts and sort the contracts by column headings.

Contract Value	The dollar value of the contract over the life of the contract. For example, you may have a contract with a value of \$24 million over three years. In this case, the contract value is \$24 million.
Fixed Cost	The cost of the fixed portion of your contract, if it is divided into fixed and variable portions.
Variable Cost	The cost of the variable portion of your contract, if it is divided into fixed and variable portions. For example, after a specified number of licenses, your contract may specify a variable cost for additional licenses.
Annual Maintenance Fee Date	Specified as mm/dd/yyyy, the date on which the annual maintenance fee associated with this contract is due to the software vendor.
Payment Amount	Dollar amount of the periodic payment due to the software vendor.

Setting	Description
Payment Start Date	Specified as mm/dd/yyyy, the date on which the first payment is due to the software vendor.
Payment End Date	Specified as mm/dd/yyyy, the date on which the last payment is due to the software vendor.
Payment Interval	Specify how often payment is due to the software vendor. For example, payment may be due quarterly.

Contract Pools

Contract pools are used to define common license terms for a group of product licenses purchased under a contract. These terms can include geographic and other license usage restrictions, and the remix rules. Contract pools have the same license type and the same remix type. A typical contract will have a remixable contract pool of time-based licenses and a contract pool of non-remixable licenses.

Annual Maintenance or Access Fee Percent	Percentage of list price paid to the software vendor each year for each product license in the contract pool.
	This is known as <i>annual maintenance</i> for perpetual license models and as an <i>annual access fee</i> for time-based license models.
Currency	USD. Contract pool currency is specified in US dollars.
Initial Value	The remix ceiling amount for this contract pool.
Remixable Percent	Percentage of the contract pool's initial value that can be changed during a remix. A value of 0 indicates that this contract pool is not remixable.
	Important • This value is not applicable for renewals.
Revisions Per Year	Number of times the contract pool can be remixed each year, expressed as an integer.
Next Plan Date	The date, specified as mm/dd/yyyy, on which the contract pool can next be remixed.
Organization	All product licenses in the contract pool will be distributed to the selected organizational unit. This distribution specification can be used for peak usage and chargeback reporting.
	See Product Usage Reports for more information about reports that provide investment planning information.
Geography	Geographic area for this contract pool; for example, Midwest.
Site	Site for this contract pool; for example, Chicago or Milwaukee.
Notes	Notes about the contract pool.

Product Licenses

To use licensed software, you purchase product licenses from a software vendor. The contract specifies the terms of the license and indicates how many copies of the product you own. At a particular point in time, the total number of copies is the sum of the quantities of all product licenses that have an effective date on or before the point in time and an expiration date that is either blank—which indicates that the product license is perpetual—or after the point in time.

For reporting and chargeback purposes, a product license can be distributed to different organizational units within your enterprise. For example, if you have a license for 10 copies of Product A, you could distribute six copies to the Broadband division and four copies to the Memory Products division.

In FlexNet Manager for Engineering Applications, you add product licenses to contract pools. After adding the product licenses, you can add license distributions.

List Price	The software vendor's list price to purchase a single copy of the product.
Calculated Net Price	The net price for this product license, calculated using the following formula: List Price * (1 - Discount Percent) * (1 + Uplift Percent)

Override Net Price	To override the calculated net price, provide an override price.

Adding License Distributions

You can add a license distribution for a product license, which enables you to capture the number of product licenses that are allocated to your enterprise's various organizational units. For example, if you have a total of 100 licenses for a product, you may want to allocate 30 of them to the Memory Products division and 70 to the Communications division.

License distributions are used primarily for reporting and chargeback purposes; there is no way to restrict product usage.

You can distribute product licenses automatically or manually. Automatic distribution is based on each organizational unit's percentage usage of the product. Using the previous example, if the Communications division is using the product three times as much as the Memory Products division, they would receive 75 product licenses and Memory Products would receive 25 product licenses.

You can use manual distribution if you know the quantities used by your organizational units—if the quantities are known or fixed (and not based on relative usage).

Remixing Contract Pools and Planning for Renewals

Remixing is the process of optimizing the money spent on software by adjusting the quantities of product licenses within a set of rules defined by the contract and contract pools. Customers are typically limited to a fixed number of remixes per year over the life of the contract.

Planning takes into account both remixes and renewals. The remix and the renewal-planning process use historical product usage patterns and the limits defined in the contract and pools to forecast the number of licenses your enterprise will require for each of the products purchased under the contract.

A remix or renewal analysis is performed on the product licenses within the same contract pool; any manipulation for a remix between the product licenses that belong to different contract pools of a contract are not permitted.

Plan Information

The bottom of the page contains the following information:

- **Product**—The product for which this plan information applies.

- Time at Peak—The total amount of time spent at the peak value during the specified time period.
- Denials—The number of denials that occurred during the specified time period while at peak usage.
- **Denial** %—Editable field that enables you to specify the percentage of hours during a specified time period, during which a denial would be acceptable.
- **Effective**—The new peak usage quantity after applying the value specified in the Denial % field (if any). This is used to calculate the Forecast quantity.
- Current—The quantity of product licenses in the contract pool, owned as of the Trend Data Start Date.
- Forecast—Total quantity of product licenses that are needed as of the Forecast Date. This value is determined
 by extending the usage trend line from the effective peak usage as of the Trend Data End Date until the
 Forecast Date.
- **External**—The number of product licenses that are not part of the current contract pool. This will be 0 if the current contract pool is associated with an organizational unit.
- Additional Qty—Number of additional product licenses to add to the forecast quantity.
- Buffer %—Enables you to specify an additional percentage of product licenses to add to the forecast quantity.
- Suggested—The suggested total quantity of the product.
- Override—Enables you to override the quantity suggested by trend analysis for this remix.
- Final—The number of product licenses required for this remix. If the Override field contains a value, the Final quantity will be the same as the Override quantity. If the Override field is empty, the Final quantity will be the same as the Suggested quantity.

Single-Master-Feature Product Mapping

To improve aggregation performance, you can define single-master-feature products, in cases where the product and feature meet specific criteria. You define the product-to-feature mapping—identifying the product's single master feature—using the functionality available beneath the **Planner** tab.

Single-Master-Feature Product Criteria

In order to define single-master-feature products, the product and master feature must meet the following criteria:

- Only one feature (which serves as the "master" feature) can be assigned (mapped) to the product.
- The single, master feature cannot be assigned to more than one product. The product to which it is mapped is the only product to which it can be mapped. (The feature cannot be shared among multiple products.)
- The number of features (parallel running instances) per product license is 1:
 - 1 product license = 1 running feature instance

As a result of defining single-master-feature products, you can significantly improve the aggregation performance of FlexNet Manager for Engineering Applications. The performance gain is dependent upon the number of single-master-feature products in your environment, but can be up to 50–70 percent for environments with a high percentage of single-master-feature products.



Important • This functionality does not apply to any features served by the vendor daemon ibmratl.

Defining a Single-Master-Feature Product

To define a single-master-feature product, map the master feature to the product.



Task To define a single-master-feature product:

- Create a product (if it does not already exist in FlexNet Manager for Engineering Applications). See Adding Products for information.
- 2. Add the master feature to the product. See Adding Features to Products for information.



Important • As noted in the Single-Master-Feature Product Criteria, this product cannot have any other assigned features, and the master feature cannot be assigned to any other products. In addition, one product license = one running feature instance.

Single-Master-Feature Product Mapping

FlexNet Manager for Engineering Applications provides different alert types that can be used to notify users about different events or conditions. For example, you can configure an alert to notify you when a FlexNet Agent or license server is down or not responding.

Pages under the Alerts tab enable you to view a summary of alerts, subscribe to alerts, and configure alerts. Depending on the permissions you have been granted through roles, you see the Alerts tab with the following links:

- Inbox—List of alert messages that have been triggered and not dismissed.
- Subscription—Subscribe and unsubscribe to FlexNet Manager for Engineering Applications alerts.
- Configure Alerts—Enables you to specify an email template, and to configure the detection and notification interval for an alert.
- Cleanup Service—Activate the alert cleanup service and specify the interval at which it will run.

Alerts Inbox

You can view your existing alerts on the Alerts Inbox page and in the Alerts table on the Dashboard page.

The Alerts Inbox page—available from the Alerts tab—displays the alerts for the user who is currently signed in to FlexNet Manager for Engineering Applications. The alerts that appear in this list are dependent upon the signed-in user's alert subscriptions.

The Alerts Inbox page provides the following information about each alert:

- Category—Relative seriousness of the alert, as set by FlexNet Manager for Engineering Applications (displayed in the column beneath the alert bell icon); whether the alert provides information, a warning, or an error message.
- **Date**—Date and time that the alert message was sent.
- **Message**—Text of the alert message.

Action—Possible actions to perform on the alert message; for example, dismiss.

Some alerts are dismissed automatically when the alert condition is resolved. To manually remove an alert message from the Alerts Inbox page, click its **Dismiss** button.

Users assigned roles with the **View and Subscribe Alerts** permission—and who are subscribed to alerts—are able to view them in their **Alerts Inbox**.

Dismissing Alerts

When an alert message is dismissed, its message is removed from the **Alerts Inbox** page and from the Alerts table on the Dashboard page. Some alerts are dismissed automatically when the alert condition is resolved; others must be dismissed manually.

Alerts on events are triggered only one time at the time the event is detected. Therefore, if an alert on an event is dismissed manually, it is not redisplayed. However, if an alert on a condition is dismissed manually, it is displayed again if the alert condition is not corrected before the next time the alert condition is evaluated (based on the **Detection and Notification Interval**).

Dismissed alert items remain in the FlexNet Manager for Engineering Applications database until the alert cleanup service job runs.



Note • Alerts are not automatically dismissed if a user's access rights and/or alert subscriptions change. Users are notified based on their access rights and alert subscriptions at the time that the alert was issued.



Task To dismiss an alert manually:

- From the Alerts tab, under Alerts, click Inbox.
- On the Alerts Inbox page, click the check boxes in front of the alerts you want to dismiss, then click the Dismiss button.

Click **Dismiss All Alerts** if you want to dismiss every alert in the list.

Users assigned a role with the View and Manage Alert Configurations permission can dismiss an alert.

Configuring Alerts

You can configure alerts that can be used to notify specified users about different types of events or conditions. Alerts are not sent to users, however, unless a user subscribes to the alert. (See Creating or Editing Alert Subscriptions.)

Users assigned a role with the View and Manage Alert Configurations permission can configure the alert definition.

Task To configure an alert definition:

- 1. From the Alerts tab, under Alerts, click Configure Alerts to display the Configure Alerts page.
- 2. For the alert that you want to configure, click Configure. This displays the Configure Alert Definition page.
- **3.** Specify the **Detection and Notification Interval** for FlexNet Manager for Engineering Applications to check for the specific alert event or condition. You can specify a number of seconds, minutes, hours, or days.
- 4. Set the Status to Active.
- 5. Provide a **From Address**. This is used when an email is sent as the result of an alert being triggered.
- **6.** Provide a path to a customized email template, if any, for this alert. For more information, see Customizing an Alert Email Template.
- 7. Click Save.

Customizing an Alert Email Template

You can configure an alert handler to send email to a specified email address when an alert is triggered. Each alert type, or alert type family, has a default email template—an XSL file that is used to create email messages. Each alert type uses a single email template path. For example the **Agent Down** alert uses the template **manager.agentDownTemplate.xsl**.

The name of a default email template is usually composed of the:

- · Module in which the alert is defined.
- Name or family name of the alert type.

For example, one of the templates is named **manager.licenseExpiringTemplate.xsl**. It is defined in the manager module for the family of License Expiring alerts. If there is no email template that matches the alert type or alert type family, the **genericAlert.xsl** template is used.

Default email templates are located in the *admin_install_directory*/site/webapps/flexnet/templates directory. These email templates can be customized. Before renaming a customized email template, decide whether the customizations will apply to all alert emails that use this template.



Important • You should be familiar with XSLT before attempting to edit email templates.

Task To customize an alert email and specify the customized email template for an alert:

- **1.** Open a Command Prompt window and change to the FlexNet Manager for Engineering Applications installation directory (*admin_install_directory*).
- 2. Create a directory named custom in the admin_install_directory using the command mkdir, creating the following directory structure in the custom directory to mimic the path to the default email templates: custom/webapps/flexnet/templates
- 3. Locate the default email template and copy it to the custom templates directory that you just created.
- **4.** Edit the copy of the email template and save the file.
- **5.** Rename the customized file if necessary.
 - If the changes to the email template apply to all email messages that are generated using this template, do
 not rename the template file. If it is not renamed, it will replace the default template in the **site** directory,
 but the original will remain intact in the **releases** directory in case it has to be recovered.
 - If you want to target your edits to the email template used for only one of a family of alerts, rename the email template.
- **6.** Stop FlexNet Manager for Engineering Applications Admin.
 - To stop Admin from the command line, navigate to the Admin installation location, then type the command: flexnet_stop
 - If you configured Admin to run as a Windows service, you can stop the service from the Windows Services pane.
- 7. To load files from the custom directory into the site directory, in the admin_install_directory, type the command: flexnet site make
- **8.** Restart FlexNet Manager for Engineering Applications Admin.
 - To start Admin from the command line, navigate to the Admin installation location, then type the command: flexnet start
 - If you configured Admin to run as a Windows service, you can start the service from the Windows Services pane.
- 9. From a supported web browser, log in to FlexNet Manager for Engineering Applications Admin.
- 10. To configure an alert definition to use the customized email template:
 - a. From the Alerts tab, under Alerts, click Configure Alerts.
 - b. Click Configure to display an alert's Configure Alert Definition page.
 - c. To change the email template, specify the template name in the Email Template field.
 - d. Click Save.



Note • You must subscribe to an alert in order to see alerts as they are triggered (as configured). See Alert Subscriptions for more information.

Alert Subscriptions

To ensure that you receive only the alerts that are useful to you, you subscribe to individual FlexNet Manager for Engineering Applications alerts. In order to receive an alert, you must subscribe to the alert. When an alert to which you are subscribed is triggered, that alert appears in your Alerts Inbox. You will not see alerts to which you are not subscribed.

Alert subscription works in conjunction with access rights to determine which alerts a FlexNet Manager for Engineering Applications user sees. For example, a user will see alerts only for the FlexNet Agents and license servers for which the user has defined access rights. Access rights override alert subscription rights.

For example, the Concurrent Threshold Alert could be calculated based on the subscriber's access rights:

One company has two sites—Europe and USA.

- In Europe, there are 500 licenses available and 450 were used.
- In USA, there are 1000 licenses available and 400 were used.

If a user has access rights for the license servers in Europe only and he subscribes to the alert (80%), he would receive the alert because the usage is 90% and it exceeds the threshold.

If a user has access rights for the license servers in USA only and he subscribes to the alert (80%), he would not receive the alert because the usage is 40% and it does not exceed the threshold.

If a user has access rights for all license servers in USA and Europe and subscribes to the alert (60%), he would receive the alert because the usage is 63% and it exceeds the threshold.

To see an alert triggered by a specific event, the FlexNet Manager for Engineering Applications user must:

- Subscribe to the alert (for example, Agent Down).
- Have access rights for the object of interest for the event, where this is pertinent. For example, the user must have access rights to a particular FlexNet Agent in order to see the Agent Down alert for that agent.

For example, to see an alert when the FlexNet Agent AcmeCo is down, the FlexNet Manager for Engineering Applications user must be subscribed to the Agent Down alert and must have agent access rights to the AcmeCo agent.

When you unsubscribe to an alert type, the existing Inbox Notification alerts message is not dismissed automatically—the existing alerts (shown in the Alerts Inbox) will remain and the status of alert condition will be not updated.

Creating or Editing Alert Subscriptions

The following instructions describe how to subscribe to most FlexNet Manager for Engineering Applications alerts. Product-based alerts or Feature-based alerts—which enable you to select specific products or features—require additional configuration.



Task To subscribe to an alert:

- 1. From the Alerts tab, under Alerts, click Subscription to display the Alert Subscription page.
- Click Subscribe/Edit for the alert to which you want to subscribe. This displays the Create/Edit Alert Subscription page.
- **3.** Select the **Inbox Notification** check box to display alerts in your Alerts Inbox. Inbox Notification is required if Email Notification or Script Execution is enabled.
- 4. In the **Email Notification** section, set up one or more email notifications for the alert.

You may want to set up multiple email notifications with different trigger times to escalate alerts to different email recipients if an alert condition is not corrected within a particular amount of time.

State	Select the check box to enable email notification for the alert.
Trigger time	Specify a positive integer or zero in the first field and select an interval from the list. Specifying zero in the field causes the alert to be triggered immediately after the alert trigger occurs.
	The alert date is the time the alert condition began, and the trigger time is the time offset from the alert date when the alert email is triggered, but not necessarily sent. Email with a trigger delay is sent when the alert condition is next checked after the trigger time has passed, if the triggering alert has not been dismissed.
	If an email notification is set with a trigger time delay (for example, 1 hour) less than the detection interval (for example, 1 day), an email could be triggered by an alert condition on Monday, but not be sent until the alert is checked again on Tuesday (if the alert was not dismissed). Therefore, for clarity, set the trigger time delay to be a multiple of the Detection and Notification Interval .
	Tip • Set one alert handler/notification to trigger immediately upon detection of the event and set trigger-time delays only on additional email notifications.
Send email to	Email address to which you want to send this alert notification. Specify multiple email addresses in a comma-delimited list.

- **5.** To set up additional email notifications, select the **Show additional email notifications** check box and complete the email notification settings described in the previous table.
- **6.** In the Script Execution section—displayed for License Server Down, Vendor Daemon Down, Concurrent License Expiring, and Concurrent Threshold alerts—specify whether you want to execute a script when this alert is triggered.
- 7. Click Save.

- **9.** From the list on the left, select the vendor daemon for which you want to select products/features. Press the **Ctrl** key to select multiple vendor daemons.
- 10. Click the arrow button to display the vendor daemon's products/features in the box on the right.
- 11. From the list of products, select the products for which you want to set the alert, and click Add.
- 12. Repeat steps 8 through 11 to add more products or features with different expiration days.
- 13. Click Finish.

- **6.** In the Script Execution section—displayed for the **Concurrent Usage Threshold** alert—specify whether you want to execute a script when this alert is triggered.
- 7. Click **Next** to move to the next page of the subscription process.
- **8.** For the **Activatable Usage Threshold** alert, specify whether you want to include overdraft licenses in the license counts to determine where you are with respect to the threshold.
- **9.** Indicate whether you want FlexNet Manager for Engineering Applications to calculate the usage separately by product versions or take all versions into account when calculating the usage.

For example, MyProduct has 2 versions: 1.0 and 2.0.

- MyProduct 1.0 has 500 licenses, with 300 in use—60% of licenses in use
- MyProduct 2.0 has 500 licenses, with 400 in use—80% of licenses in use

A FlexNet Manager for Engineering Applications user subscribes to a usage threshold alert for MyProduct and specifies a usage threshold of 75%.

- If the Threshold Calculation (Separately by product versions) check box is selected, the threshold will be calculated by product versions separately. The user will receive an alert regarding MyProduct 2.0 has exceeded 75% usage.
- If the Threshold Calculation (Separately by product versions) check box is not selected, the user will
 not receive the alert, because the threshold for MyProduct (all versions) is 70% (700 in use / 1000
 total licenses).
- **10.** Type the threshold percentage. For example, type **50** if you want to receive an alert when 50% of a particular product's licenses are in use. This number will be used for all products/features that you specify in the following fields. You can modify the expiration days for individual products/features after they are added.
- **11.** From the list on the left, select the vendor daemon for which you want to select products. Hold down the **Ctrl** key to select multiple vendor daemons.
- 12. Click the arrow button to display the vendor daemon's products/features in the box on the right.
- **13.** From the list of products/features, select the products/features for which you want to set the alert, and click **Add**.
- **14.** Repeat steps 11 through 13 to add more products or features.
- 15. Click Finish.

Alert Scripting

FlexNet Manager for Engineering Applications provides script execution functionality as part of the alert subscription process. You can define a script—using, for example, Perl or Java—that FlexNet Manager for Engineering Applications will call when one of the following events occurs:

- License Server Down
- Vendor Daemon Down

- Concurrent License Expiring
- · Concurrent Usage Threshold Reached

The script is launched under the security credentials of the FlexNet Manager for Engineering Applications process (typically root of the machine). It is recommended that you test the command to ensure that the script will run when it is invoked.

The script is executed only if the FlexNet Manager for Engineering Applications user has the Execute Scripts for Alerts permission.

Table 8-3 • Alert Script Execution Settings

Script Execution Setting	Description
State	Select the check box to enable script execution for this alert. This specifies whether the script (whose path is provided in the next field) is invoked.
Execute Command	Specify the path to the script. This path must be accessible to FlexNet Manager for Engineering Applications. There is no validation for the path.
User-Defined Message	This text is appended to the LMADMINAINFO environment variable: message=user-defined_message&

LMADMINAINFO Environment Variable

LMADMINAINFO is an environment variable set when an alert triggers. You can use it in the program that is run when the alert triggers. It is defined in accordance with the Common Gateway Interface (CGI) format. It is the same format as the query_string environment variable defined by an HTTP server.

LMADMINAINFO is set to a character string consisting of a series of name=value pairs with no spaces or line breaks. All blanks in the string are encoded using the "+" character. All "+" characters are encoded using the "%2B" string.

The following example is formatted with line breaks to make reading easier, but remember not to use any spaces or line breaks in your LMADMINAINFO.

The alert cleanup service enables you to periodically clean up the FlexNet Manager for Engineering Applications database by deleting dismissed alerts from the database.

- 2. For the **Job Execution Interval** setting, specify how often you want the alert cleanup operation to run. Type a positive integer in the first text box and select an interval from the list.

Administration

Functionality available from the **Admin** tab enables you to manage users and roles, view currently logged-in users, see information about the FlexNet Manager for Engineering Applications application, and configure settings for FlexNet Manager for Engineering Applications components.

Some of the pages under the **Admin** tab enable you to view system information and the database connection, and to configure the behavior of FlexNet Manager for Engineering Applications. Depending on the permissions that have been granted through roles, a user may see the **System Configuration** and **System Information** sections under the **Admin** tab.

Table 9-1 • Functionality available from the Admin tab

Section	Description
Users	Enables you to view, add, and manage users; and to view, add, and manage domains.
Roles	Lists the default (system) roles that are provided; enables you to add, modify, and manage non-system roles.
Access Rights	Access rights determine which FlexNet Manager for Engineering Applications users are able to view and manage information pertaining to specific license servers and FlexNet Agents.
System Information	Provides information about the FlexNet Manager for Engineering Applications system, including versions and build numbers, location of the license file, environment and database information, and information about Java VM memory.
	From this tab, you can also view logs for FlexNet Manager for Engineering Applications and the Reporting module.
System Configuration	Enables you to configure the FlexNet Manager for Engineering Applications application and user interface for your enterprise.

User Management

Some of the pages under the **Admin** tab enable you to view and manage users, roles, and domains of users. If domains in addition to the FlexNet domain are configured, groups can also be viewed and managed.

Depending on the permissions you have been granted through roles, you see the **Admin** tab with the following user management sections:

- **Users**: Manage users, groups, and domains for FlexNet Manager for Engineering Applications, and see users who are currently logged in to the application.
- Roles: Manage roles (sets of permissions) for FlexNet Manager for Engineering Applications.

Default System Administrator User: admin

By default, there is an admin user (System Administrator) that is assigned the **Super Administrator** role. You cannot deactivate the admin user or modify the role assignment.

Administering Users

To log in to FlexNet Manager for Engineering Applications, a user must provide a user name and password. Users can gain access to FlexNet Manager for Engineering Applications by being either:

- A FlexNet Manager for Engineering Applications user, meaning that all or some information for that user, whatever its source, is stored in the FlexNet Manager for Engineering Applications database. User of this type are listed on the **Users** page.
- A user in a configured directory service who is not a FlexNet Manager for Engineering Applications user. Any
 user in a configured directory service domain can log in to FlexNet Manager for Engineering Applications.
 However, to perform a task in FlexNet Manager for Engineering Applications, a non–FlexNet Manager for
 Engineering Applications user must belong to a group that has been granted a role that can perform the task.
 These users do not appear in the Users page.

LDAP

Information for a FlexNet Manager for Engineering Applications user can be imported from an LDAP directory service, if the application has been configured to access a directory service, or the information is manually input into FlexNet Manager for Engineering Applications. Users input manually into the application are users in the FlexNet Manager for Engineering Applications domain. Authentication information for a user in the FlexNet Manager for Engineering Applications domain is stored in the FlexNet Manager for Engineering Applications database. FlexNet Manager for Engineering Applications users imported from a directory service are users in that directory service domain. Authentication information for a user in a directory service domain is maintained in the directory service.

Users can be members of FlexNet Manager for Engineering Applications groups. Groups cannot be input manually through FlexNet Manager for Engineering Applications, but only can be imported from a directory service. Group membership is managed entirely in the directory service.

After logging in, to perform tasks using FlexNet Manager for Engineering Applications, a user must be granted one or more permissions that are defined by the application. Permissions are not assigned to users directly—permissions are grouped into roles and FlexNet Manager for Engineering Applications users or groups are assigned one or more roles.

Some user names are intended to be logins to be shared among multiple users, for example, the admin user. Shared logins do not appear in the Logged-In Users page.

Browsing Users

Users (users who have all or some of their user information stored in the FlexNet Manager for Engineering Applications database) are displayed in the **Users** page. A non–FlexNet Manager for Engineering Applications user who can log in to the application only because the user is in a directory service domain does not appear on the Users page.

The **Users** page provides the following information:

- Whether a user is a shared user (shared users are marked with an icon showing several people)
- User Name—Login name of the user.
- Display Name—Full name of the user.
- Date Created—Date the user was created.
- Date of Last Login—Date of last login by the user; this date is not recorded for shared users
- Status—Whether the user is active or inactive.



Task To browse users:

From the Admin tab, under Users, click Show Users to display the Users page.

Users assigned roles with the View Users or View and Manage Users permission can browse users.

Adding Users

A user who has all or some user information, whatever its source, stored in the FlexNet Manager for Engineering Applications database is a FlexNet Manager for Engineering Applications user. FlexNet Manager for Engineering Applications users appear in the Users page.

Information for a FlexNet Manager for Engineering Applications user can be typed manually into FlexNet Manager for Engineering Applications or imported from an LDAP directory service, if access to a directory service is configured. Users entered manually into FlexNet Manager for Engineering Applications are users in the FlexNet Manager for Engineering Applications domain. If no domain is shown, the user is in the FlexNet Manager for Engineering Applications domain. Authentication information for a user in the FlexNet Manager for Engineering Applications domain is stored in the FlexNet Manager for Engineering Applications database. FlexNet Manager for Engineering Applications users imported from a directory service are users in that directory service domain. Authentication information for a user in a directory service domain is stored in the directory service.

To perform tasks using FlexNet Manager for Engineering Applications, a user needs one or more permissions that are defined by FlexNet Manager for Engineering Applications. Permissions are not assigned to users directly; permissions are grouped into roles and FlexNet Manager for Engineering Applications users are assigned one or more roles.

Users assigned a role with the View and Manage Users permission can view, add, and edit users.



Task To add a user to the FlexNet Manager for Engineering Applications domain:

- 1. From the Admin tab, under Users, click Create User.
- 2. If domains other than the FlexNet Manager for Engineering Applications domain are configured, select the FlexNet domain. If no domain is shown, the user is in the FlexNet Manager for Engineering Applications domain. Click **Next**.
- **3.** In the User Details page, provide (at minimum) the required information.
 - Enter the User Name (required). This becomes the user's name for signing in to FlexNet Manager for Engineering Applications.
 - Enter the First Name and Last Name of the user (required).
 - Enter the Email Address of the user (required). If this is a shared user, specify the email address of a FlexNet application administrator in this field.
 - Enter the user's Phone Number and Fax Number (optional).
 - Enter the user's address information.
 - Select the user's preferred Time Zone. This time zone setting is used when displaying a date or time to the
 user.
 - Leave the Status of the new user Active.
 - If this user name is intended to be shared among multiple users, select the Shared Login check box.
 - Assign at least one role to the user.
- **4.** Click **Finish**. When the new non-shared user in the FlexNet Manager for Engineering Applications domain is saved, an email containing a system-generated password and login instructions is sent to the user's email address. The first time the user logs in, he logs in with the system-generated password, then is immediately prompted to change his password. After his password is successfully changed, the user is logged in.

When a new shared user in the FlexNet Manager for Engineering Applications domain is saved, the email containing a system-generated password is sent to a FlexNet Manager for Engineering Applications administrator (if you specified the administrator's email address). The administrator should log in to FlexNet Manager for Engineering Applications with the system-generated password, then change the password and keep a record of it. The administrator must send this new password to all users of the shared login.



Task To add a user from a directory service domain:

- From the Admin tab, under Users, click Create User to display the Add User page.
- 2. Select one of the directory service domains that contains the information to authenticate this user. Click Next.
- 3. Search for and select one or more users to import from the directory service. Select multiple users only if you plan to assign them all the same roles. Only a small amount of user information will be imported from the directory service to the FlexNet Manager for Engineering Applications database; user authentication is done by contacting the directory service. Click Next.
- The user to be imported is displayed. Leave the Status of the new user Active. Assign at least one role to the user.
- 5. Click Finish.

When the new user is saved, they can log in to FlexNet Manager for Engineering Applications using the user name and password stored in the directory service.

6. Verify in the Users page that the user was added.

Users assigned a role with the View and Manage Users permission can view, add, and edit users. The **Edit User** page displays the date the user was created and the date on which the user last logged in (if a non-shared user) and is also used to reset the user's password.

You can delete a user using the Edit User page. You cannot delete the default admin user (System Administrator).

Resetting User Passwords

Using the Edit User page, you can reset a user's password.



Task To reset a user's password:

Open the user's record in the Edit User page and click the **Reset Password** button (located at the bottom of the view).

- If the user is not shared, an email is sent to the user with a new system-generated password. The user logs in with the new password and is immediately prompted to change his password.
- If the user is shared, the email containing a system-generated password is sent to a FlexNet Manager for
 Engineering Applications administrator (if you specified the administrator's email address when the user was
 created). The administrator should log in to FlexNet Manager for Engineering Applications with the systemgenerated password, then change the password and keep a record of it. The administrator must send this new
 password to all users of the shared login.

Deactivating and Reactivating Users

User status is displayed in the Users page. Any FlexNet Manager for Engineering Applications user can be deactivated manually and a user in the FlexNet Manager for Engineering Applications domain can be deactivated automatically; a FlexNet Manager for Engineering Applications user can be reactivated only manually.

Users assigned a role with the View and Manage Users permission can deactivate and reactivate users manually.



Task To deactivate a user manually:

- 1. From the **Admin** tab, under **Users**, click **Show Users** to display the **Users** page.
- 2. In the Users table, click a user name to access the Edit User page.
- 3. From the Status list, select Inactive.
- 4. Click Save.

A non-shared user in the FlexNet Manager for Engineering Applications domain is deactivated automatically if the user tries to log in incorrectly more consecutive times than allowed. The default number of consecutive failed authentications is three; this number can be configured in the FlexNet Platform Server configuration. When a user is deactivated in this manner, the User Deactivated alert is triggered (if it is configured by FlexNet Manager for Engineering Applications).

If a FlexNet Manager for Engineering Applications user has been deactivated, the user must be reactivated manually.



Task To reactivate a user:

- 1. From the **Admin** tab, under **Users**, click **Show Users** to display the **Users** page.
- 2. In the **Users** table, click a user name to view the Edit User page.
- 3. From the Status list, select Active.
- 4. Click Save.

A reactivated user receives an email stating that they have been reactivated. Reactivation does not affect a user's password. If the reactivated user is shared, an administrator will receive the email stating that the user has been reactivated.

Membership in a group is managed entirely through a directory service; therefore, a user added manually using FlexNet Manager for Engineering Applications cannot be made a member of a group. Groups cannot be added manually using the FlexNet Manager for Engineering Applications interface.

Administering Domains

User information is obtained from one or more domains in which it is stored. FlexNet Manager for Engineering Applications users entered manually into the application are users in the FlexNet Manager for Engineering Applications domain. Authentication information for a user in the FlexNet Manager for Engineering Applications domain is stored in the FlexNet Manager for Engineering Applications database.

Because FlexNet Manager for Engineering Applications is configured to support LDAP, information for a FlexNet Manager for Engineering Applications user or group of users can be imported from the directory service. Only enough information from the directory service is imported to enable FlexNet Manager for Engineering Applications to contact the service; authentication information for individual users in a directory service domain is maintained in the directory service.

Any user in a configured directory service domain can log in to FlexNet Manager for Engineering Applications. However, to perform any tasks in FlexNet Manager for Engineering Applications, a directory service user must be imported as a FlexNet Manager for Engineering Applications user or be a member of an imported group and be assigned at least one role.

The value of this property is displayed in the Add Group page when you create a group from a directory service. If not defined, the default value is the Group Distinguished Name in the directory service.
Returned Page Size	If a positive number is specified, FlexNet Manager for Engineering Applications tries to use paging when searching for directory service entries. Paging means that the directory service returns no more than the specified number of entries at a time instead of all entries in one batch.

License Server Access

FlexNet Manager for Engineering Applications enables you to specify access to license servers based on the administrative needs of various users. 

Exporting Configurations

The configuration-export utility exports all of the FlexNet Manager for Engineering Applications configuration settings at one time.

Configurations are exported to a **.zip** file that contains database, FlexNet Platform Server, user interface, and FlexNet Manager for Engineering Applications settings in separate XML files. The configuration-import utility uses this **.zip** file to restore all configuration settings when you import a configuration.

A user must be assigned a role with the View and Manage Configurations permission to export configuration settings to a file.



Task To export configuration settings:

- 1. From the Admin tab, under System Configuration, click Export to open the Export Configuration page.
- 2. Click Export.
- 3. Select to save the file to disk and click **OK** or **Save**.
- **4.** Specify the location and file name for the **.zip** file. By default, the configuration settings are saved to a file called **flexnet_configurations.zip**.

Importing Configurations

The configuration-import utility uses the **.zip** file created by the configuration-export utility to restore all FlexNet Manager for Engineering Applications configuration settings. (See Exporting Configurations for information.)

A user must be assigned a role with the View and Manage Configurations permission to import configuration settings.



Important • Before importing configuration settings into FlexNet Manager for Engineering Applications, export the working configuration settings (without writing over the .zip file you plan to import). If there is a problem with the imported settings, you have a backup of working settings to restore.



Task To import configuration settings:

- 1. From the Admin tab, under System Configuration, click Import to open the Import Configuration page.
- 2. Specify the .zip file that contains the configuration settings to import.
- 3. Click Import.

FlexNet Manager for Engineering Applications provides search functionality on a number of pages, which enables you to quickly locate a particular piece of information using criteria that you specify. All pages provide a basic search capability; the pages under the **Reporting** tab also include an advanced search capability.

The search scope options—available in the "Search in" list—vary depending on the page.



Task To search for information in FlexNet Manager for Engineering Applications pages:

1. In the **Search for** field, specify the string for which you want to search.



Note • The search mechanism supports partial matching. For example, if you specify **abc** for a license server, the search will return a list of license servers beginning with the string "abc": abc, abcd, abcde, and so on.

2. From the **Search in** list, select a scope for your search.



Note • If you select a Status as your search scope—for example, **Status (down)**—you do not need to specify a string in the **Search for** field. The search will return a list of all items with the specified status.

Searching for Report Information

Glossary

The following table defines many of the terms that are used throughout the FlexNet Manager for Engineering Applications documentation.

Term	Definition
aggregation	The process by which FlexNet Manager for Engineering Applications takes imported report log data and uses it to populate the data warehouse, so the data can be used to generate Flexera Analytics (Cognos) reports.
concurrent license	Entitlement defined as a fixed number of licenses available to be shared among a group of users. Also referred to as network or floating licenses.
contract	A document that defines the terms under which an enterprise purchases product licenses from a software vendor. These terms typically include the contract's start and end dates, the fixed and variable costs, remix rules for the contract, and any license usage restrictions (for example, geographic restrictions).
	Product licenses purchased under a contract are grouped into one or more license pools.
counted license	A license with a non-zero license count. A license server is required to manage a counted license. Counted licenses can either float on a network or be node-locked.
daemon	A process that "serves" clients. Sometimes referred to as a server or service process.
data warehouse	The set of database tables from which FlexNet Reporting (Cognos) reports are built. The data warehouse is populated with report log data through the aggregation process.
debug log file	One or more ASCII text files written by the license server. A debug log file contains status and error messages useful for debugging the license server.

Term	Definition	
duplicate grouping	Duplicate license requests from the same user, vendor, host or display share one license.	
end user	Your customer to whom the FlexEnabled product is supplied.	
end-user license administrator	The staff member or members at the end-user site chartered with installing the FlexEnabled product and administering the license file and server as appropriate. This could be the same person as the actual user of the product.	
entitlement	The characteristics that define the legal right to use the feature or product.	
feature	A separately licensed unit of functionality in a product. The meaning of a feature depends entirely on how it is used by a product developer. For example, a feature could represent any of the following:	
	A product consisting of one or more components	
	A specific version of a product	
	A part of a product	
	A piece of data (restricted via the access routines)	
	One feature can be included as a part of many different products.	
feature license	A license to use a discrete unit of functionality in a software product. A software vendor delivers feature licenses to the enterprise in one or more license files.	
	Feature licenses are distributed over a network by a vendor daemon running on a license server. Feature licenses are used when an end user accesses licensed parts of a software product.	
feature license event	A feature license event records the usage of a feature license by an end user. The license server creates feature license events each time a feature license is used.	
feature line	A line in a license file that licenses a particular feature. A feature line begins with one of the keywords FEATURE, INCREMENT, or UPGRADE.	
FlexNet Publisher components	The individual parts the vendor delivers to the enterprise that compose the FlexNet Publisher solution.	
FlexNet Publisher toolkit	Contains all the necessary components and libraries used by the software publisher to create a FlexEnabled product.	
FlexEnabled product	A product, instrumented with calls to the FlexNet Publisher client library, that requests a license.	
floating license	A license that can authorize usage of a product by one of a group of users on a network.	
	A license server is required to manage a floating license. Floating licenses can either be counted or uncounted. An uncounted floating license is effectively a site license.	

Term	Definition	
heartbeats	Periodic messages sent from a FlexEnabled product to a license server to solicit replies that ensure that the license server is still running. Heartbeats can be implemented automatically or called explicitly from a FlexEnabled product. If called explicitly, they are referred to as manual heartbeats.	
hostid	A means used to uniquely identify a specific system.	
hostid type	The scheme in which the hostid is determined for a particular system architecture.	
hybrid organizational structure	A user-based organizational structure that is enabled for hybrid (or multidimensional) aggregation—aggregation on both the organization level (for example, geographic) and the license-server level.	
leaf node	The end node in an organizational (or other data) structure. A leaf node does not have any child nodes.	
license	The legal right to use a feature. FlexNet Publisher can restrict licenses for features by counting the number of licenses already in use for a feature when new requests are made by the FlexNet Publisher product. FlexNet Publisher can also restrict product usage to particular node or user name.	
license certificate	One or more feature lines specific to a vendor's FlexEnabled product. This certificate is provided to the end user who incorporates it into a license file.	
license file	A license file is a collection of feature licenses. It is a text file specific to an enterprise site containing the license certificates from one or more software publishers and/or vendors. The enterprise installs the license file on a license server.	
	This file can contain descriptions of the following, for one or more FlexEnabled products:	
	License server node or nodes	
	Vendor daemon or daemons	
	• Licenses	
license-file list	A list of license files separated with a colon ":" on UNIX and a semi-colon ";" on Windows. A license-file list can be accepted in most places where a license file is appropriate. When a directory is specified, all files matching *.lic in that directory are automatically used, as if specified as a list.	
license key	A 12- to 20-character hexadecimal license signature used to authenticate a license. See also signature.	
license model	The set of defining characteristics for product entitlement. The fundamental layer of a licensing policy.	

Term	Definition
license pool	License pools are used to define common license terms for a group of product licenses purchased under a contract. These terms include remix rules and license usage restrictions.
license server	A license manager daemon (lmadmin or lmgrd) and one or more vendor daemon processes. License server refers to the processes, not the computer on which they run.
license server machine	A computer system that runs the license server processes. The license server machine hosts all site-specific information regarding licensed feature usage. Multiple license server machines used for three-server redundancy can logically be considered the license server machine. Also known as license server node.
license sharing	Duplicate license requests from the same user, host, or display share one license. See duplicate grouping.
licensing policy	The constraints applied to the legal right to use a feature.
lmadmin	Serves the same function as <code>lmgrd</code> , but provides a graphical user interface for managing license servers, viewing license rights status, and viewing enterprise-defined alerts.
Imgrd	The daemon that sends client processes to the correct vendor daemon on the correct machine. The same license manager daemon process can be used by any application from any vendor because this daemon neither authenticates nor dispenses licenses. lmgrd processes no user requests on its own, but forwards these requests to a vendor daemon.
network license	Entitlement defined as a fixed number of licenses available to be shared among a group of users across a network. Also referred to as concurrent or floating licenses.
node-locked license	A license that can authorize use of a product to be run on a specific machine based on a unique identifier known as a hostid. Node-locked licenses can be counted or uncounted. Node-locked, uncounted licenses do not require a license server.
options file	A text file implemented for a particular vendor's product by a FlexNet license administrator at an end-user site to customize the behavior of the vendor daemon or to enable or restrict the use of the licenses managed by the vendor daemon at that site.
organizational structure	Hierarchical structures that help you report on how software is being used by user ID, host, or project. Organizational structures provide a set of rules for how to distribute software usage across nodes in your enterprise.
package	A set of independent components to be licensed as a single product. Packages are defined in the license certificate, not in the product; this allows a vendor to change the components of a package until just prior to shipping the license.

Term	Definition	
package suite	A set of products combined into a package with the restriction that the package components of a single license may not be simultaneously shared.	
product	Software that comprises one or more licensed features.	
product choice	A product choice captures the results of the product resolution process for each unique set of possible products to choose from.	
product license	Defined in a contract, the product license specifies the quantity purchased, pricing information, and the license start and expiration dates.	
product license event	A product license event records the usage of a product license by a user. Product license events are not created directly by the license server; they are created by the product usage aggregation process by combining feature license events.	
product resolution	The process of determining which product was used when the feature license events could have come from more that one product.	
product usage aggregation	The process of creating product license events by analyzing feature license events. This is how FlexNet Manager for Engineering Applications identifies which products were used.	
remix	Remixing is the process of optimizing the money spent on software by adjusting the quantities of Product Licenses within a set of rules defined by the Contract and Pools. Customers are usually limited to a fixed number of remixes per year over the life of the contract. The remix process uses product usage patterns and the limits defined in the contract and pools to forecast the number of licenses required for each of the products purchased under the contract.	
report log file	The feature usage data written by a single vendor daemon. Report logs are not human readable; the data is compressed and authenticated for use with FlexNet Manager for Engineering Applications.	
	FlexNet Manager for Engineering Applications uses the data contained in the report log files to produce various usage reports.	
roll-up	See aggregation.	
served license	A license that requires the management of a license server.	
signature	A secure, 12- to 120-character hexadecimal number that authenticates the readable feature line in the license file, ensuring that the license text has not been modified. See also license key.	
software producer	A company that makes software products that use a licensing system to control access to various functions (features) of the product. The software producer may also be the software vendor.	

Term	Definition
software vendor	A company that sells licensed software products. The software vendor may also be the software producer.
suite	See package suite.
supersede	A way of changing characteristics of a license with new ones, thereby making obsolete the earlier ones. For example, a supersede license can be issued to both change the name of a feature and obsolete the older name at the same time. This is more powerful than upgrading.
tamper resistant licenses	An encryption method employing an industry-recognized asymmetric, public/private key digital signature.
unassigned feature	A feature that is not associated with any products.
uncounted license	A license that does not restrict the number of uses of a feature. Usually node-locked to a machine hostid.
unserved license	A license that does not require the management of a license server.
upgrade	The concept of upgrading the version entitlement for a given license certificate.
vendor	See software vendor.
vendor alias	The alias given to one or more vendor daemon names that symbolically represents the vendor's name from whom the daemons are deployed.
vendor daemon	The server process that dispenses licenses for a particular software publisher's features. The software publisher builds this binary using libraries supplied by Flexera Software.
vendor name	A unique vendor name that is supplied to the software publisher by Flexera Software. This is used as the name of the vendor daemon.
virtual organizational structure	An <i>ad hoc</i> user-based organizational structure. You can use virtual organizational structures to combine usage for users that belong to multiple organizational structures—for example, users who are part of a specific department and a specific geographic location.
