New Software Suggestion API

A new Software Suggestion API has been introduced, allowing you to request software coverage either single or in bulk without using the UI. This REST API supports JSON and file upload formats, requests to the authenticated user, and creates corresponding records. It includes error handling, authentication, rate limiting, and request visibility in the UI. This enhancement allows seamless integration into internal automation workflows, significantly improving efficiency.
